(57) **CLAIM**

The ornamental design for a uniform scrapbook, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our ornamental design for a uniform scrapbook.

FIG. 2 is a top plan view of the uniform scrapbook of FIG. 1. FIG. 3 is a bottom plan view of the uniform scrapbook of FIG. 1.

FIG. 4 is a left side elevation view of the uniform scrapbook of FIG. 1.

FIG. 5 is a right side elevation view of the uniform scrapbook of FIG. 1.


FIG. 6 is a rear elevation view of the uniform scrapbook of FIG. 1.

FIG. 7 is a front elevation view of the uniform scrapbook of FIG. 1; and,

FIG. 8 shows a perspective view of the uniform scrapbook of FIG. 1 in an open condition.
















