(57) **CLAIM**

The ornamental design for a tag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tag showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevational view thereof; the right side elevational view being a mirror image thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is an enlarged fragmentary view of a head portion of FIG. 2;

FIG. 6 is an enlarged fragmentary view of a head portion of FIG. 6;

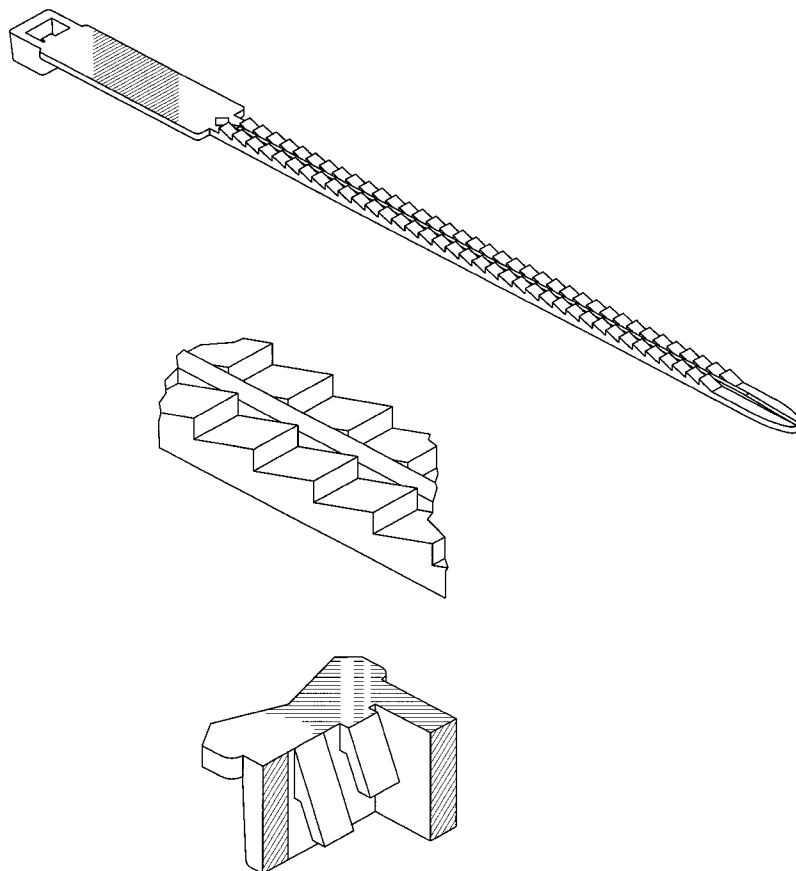
FIG. 7 is a cross-sectional view of the tag taken along line 7—7 of FIG. 5;

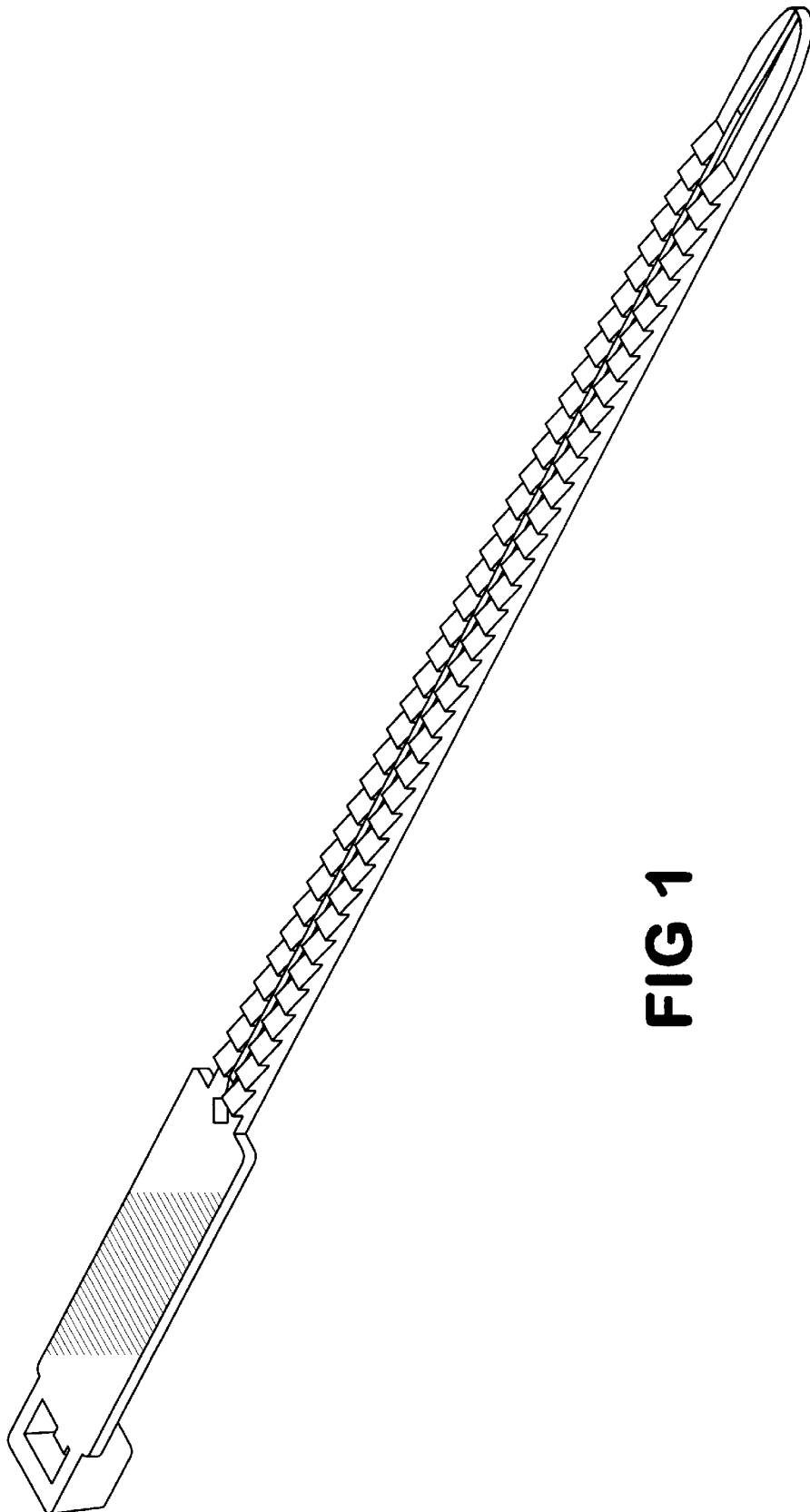
FIG. 8 is a cross-sectional view of the tag taken along line 8—8 of FIG. 5;

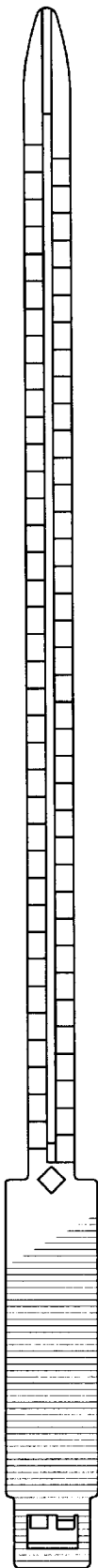


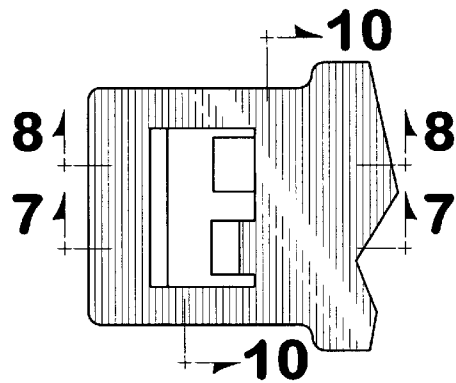

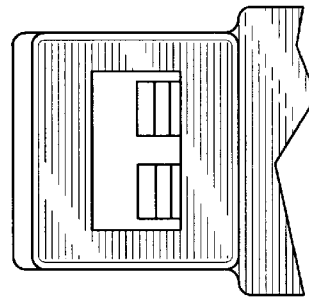

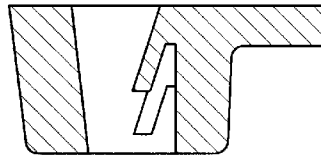

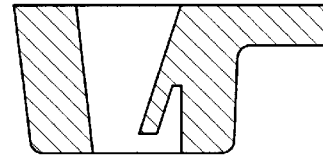

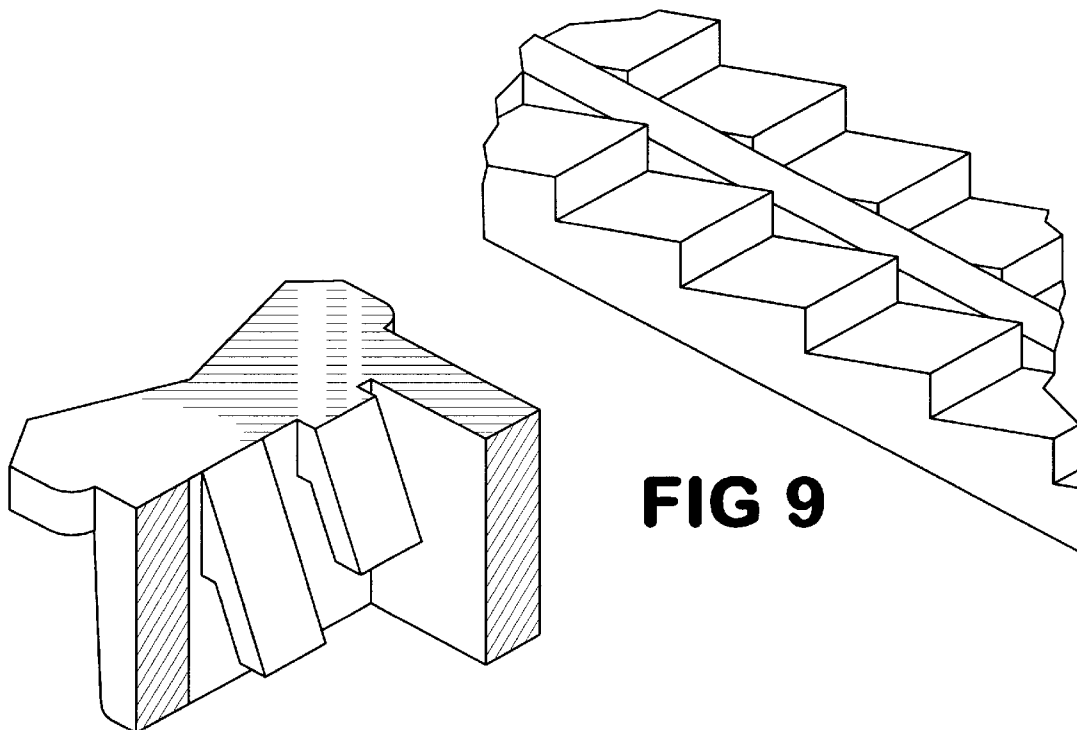

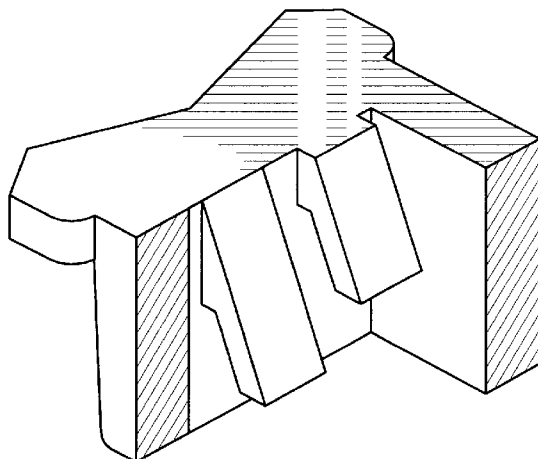
