FIG. 6 is a top elevation view thereof;

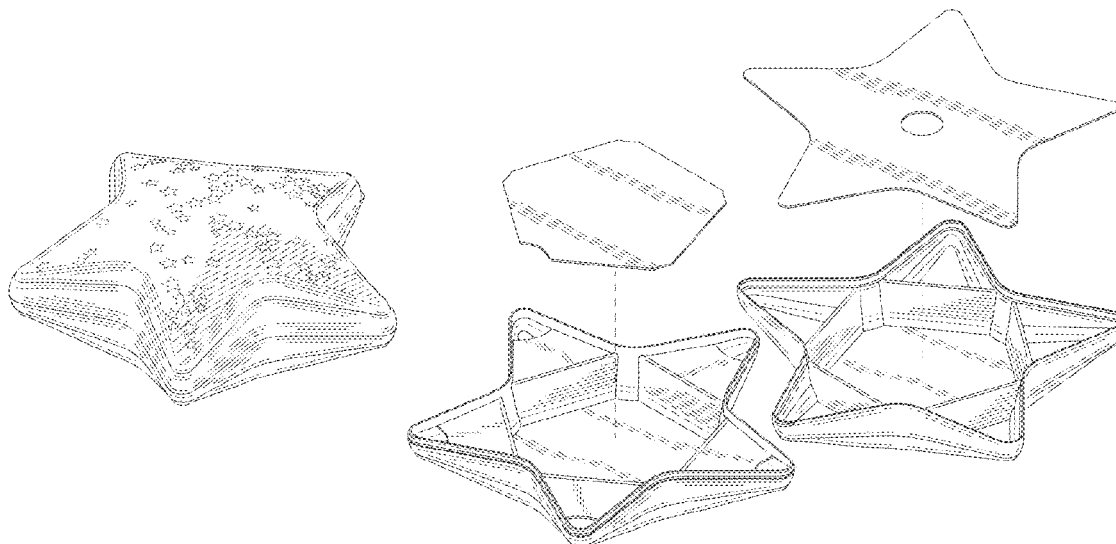
FIG. 7 is a bottom elevation view thereof;

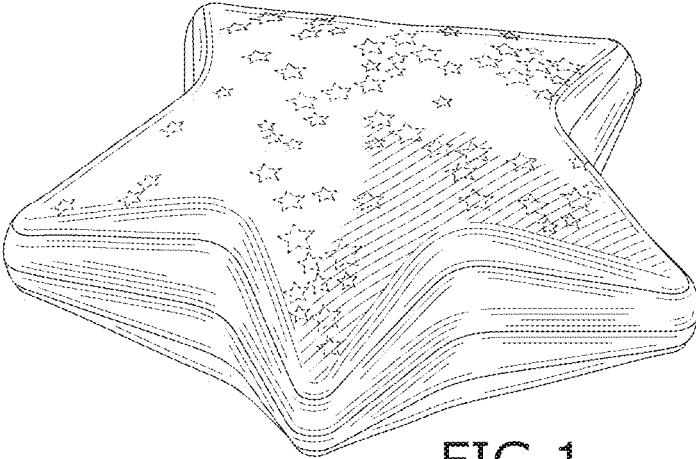

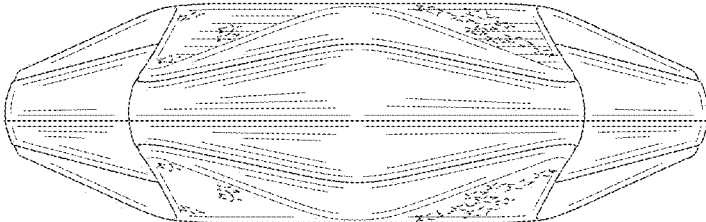

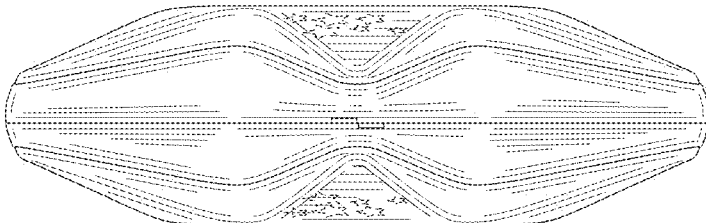

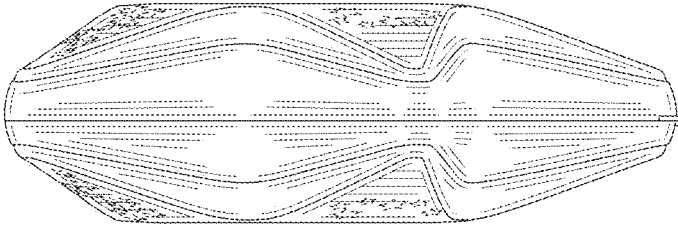

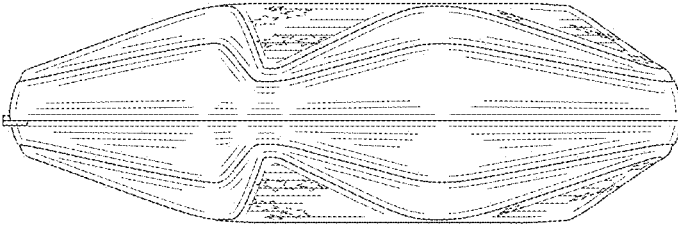

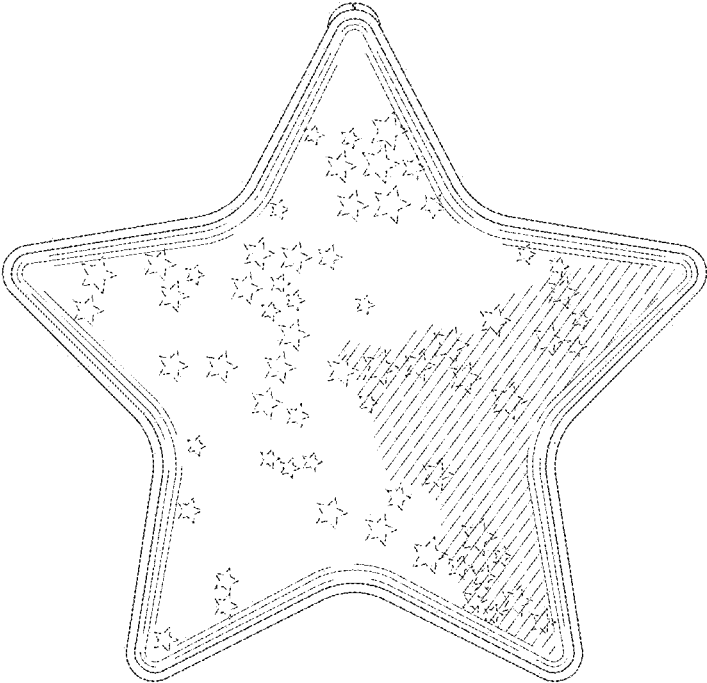

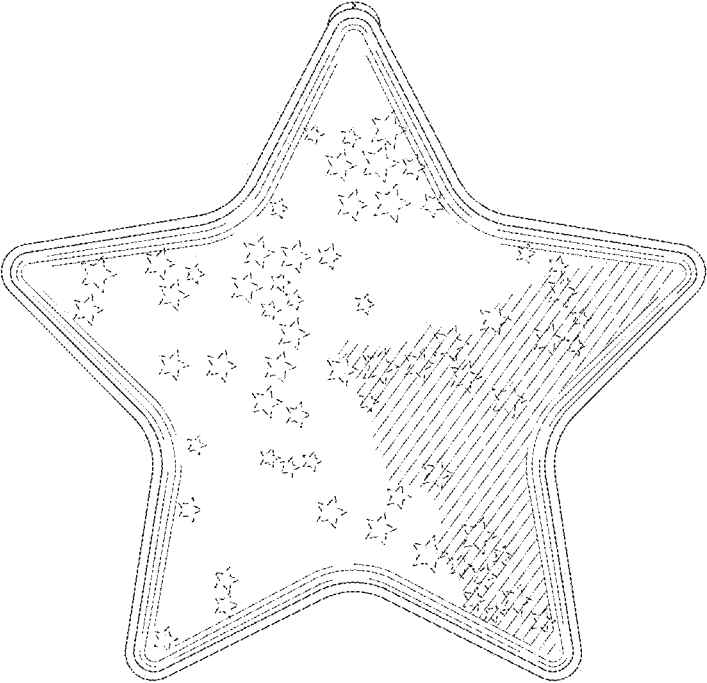

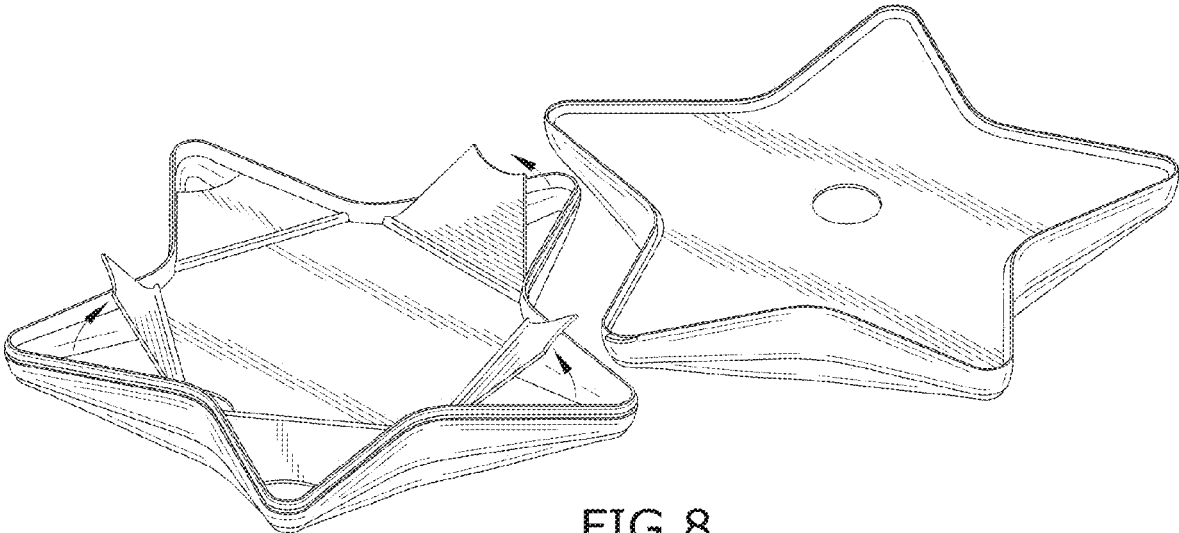

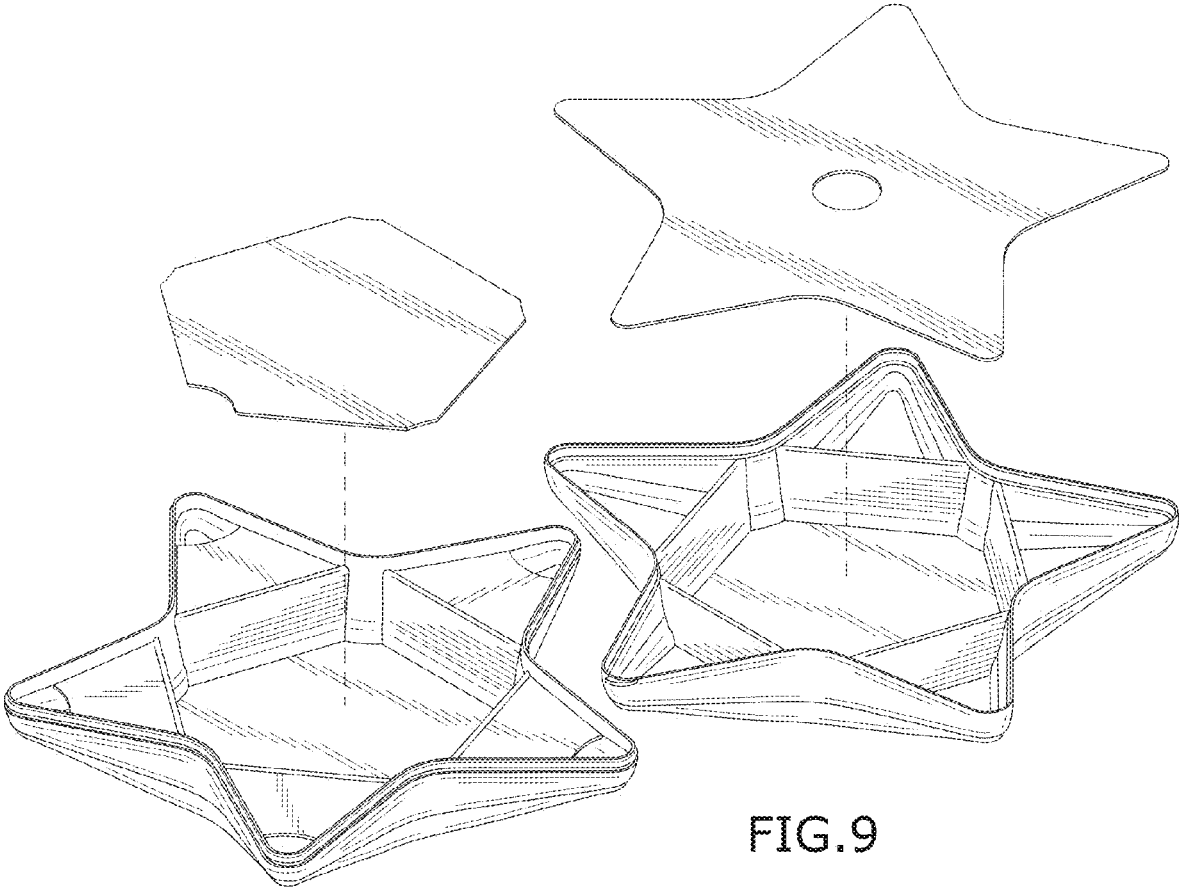
