(57) **CLAIM**

The ornamental design for a night light, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a new ornamental design for a night light;

FIG. 2 is a front elevation view of the night light of FIG. 1;

FIG. 3 is a rear elevation view of the night light of FIG. 1;

FIG. 4 is a left-side elevation view of the night light of FIG. 1;

FIG. 5 is a right-side elevation view of the night light of FIG. 1;

FIG. 6 is a top plan view of the night light of FIG. 1;

FIG. 7 is a bottom plan view of the night light of FIG. 1;


FIG. 8 is a perspective view of a night light according to a second embodiment; and,

FIG. 9 is a front elevation view of the night light of FIG. 8














