(57) **CLAIM**

I claim, the ornamental design for an antenna, as shown and described.

DESCRIPTION

The antenna is used in the state in which the antenna is affixed to a semiconductor device such as an IC chip.

FIG. 1 is a top plan view;

FIG. 2 is a bottom plan view;

FIG. 3 is the front elevational view;

FIG. 4 is the right side elevational view;

FIG. 5 is a perspective view showing a top side, a front side, and a right side thereof; and,

FIG. 6 is a perspective view showing a bottom side, a rear side, and a left side thereof.

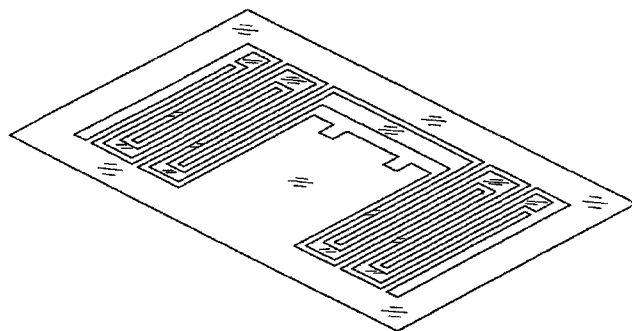
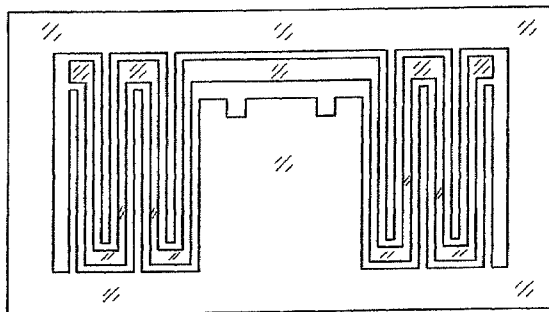

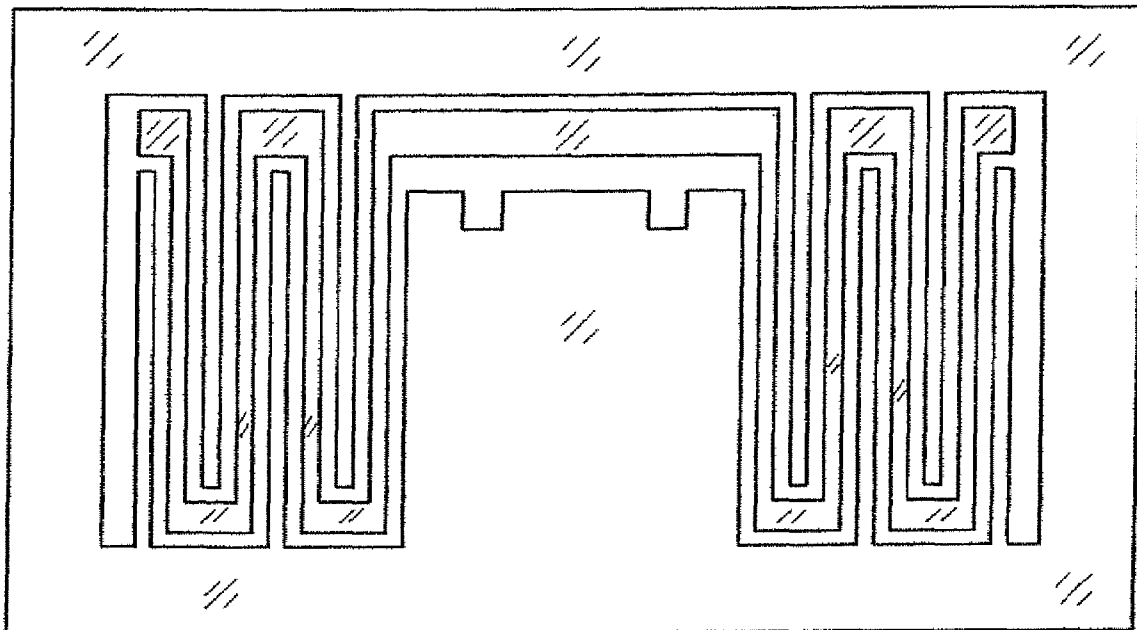

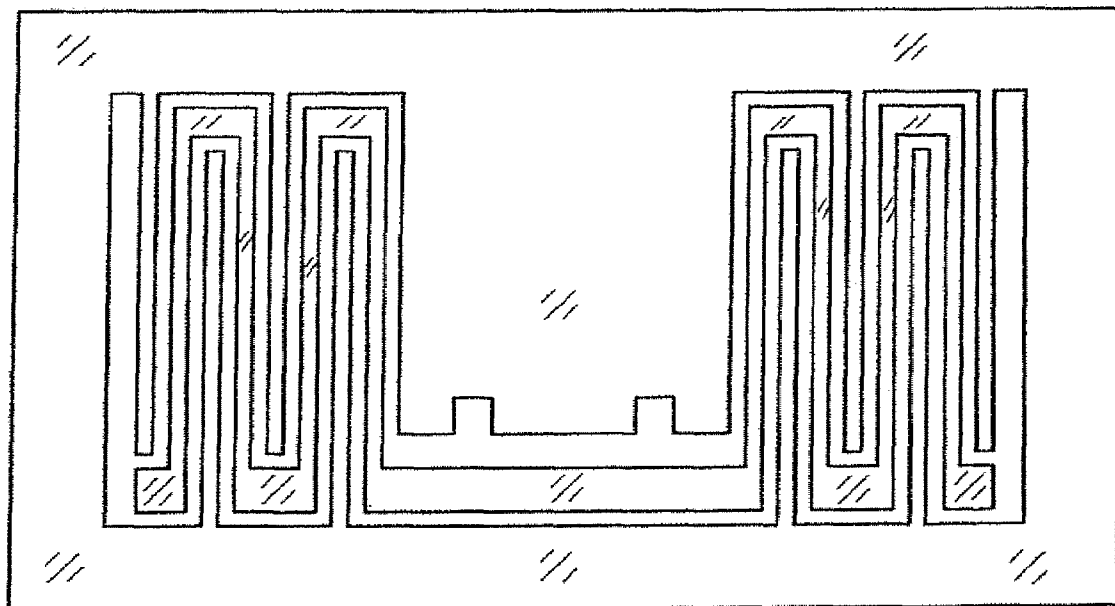

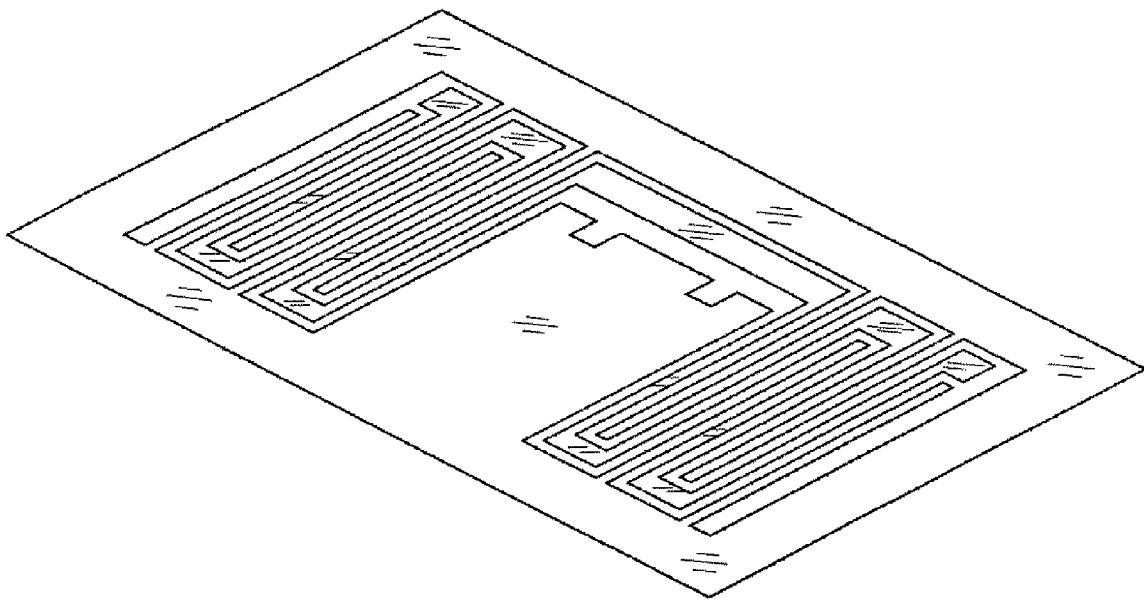
