(57) **CLAIM**

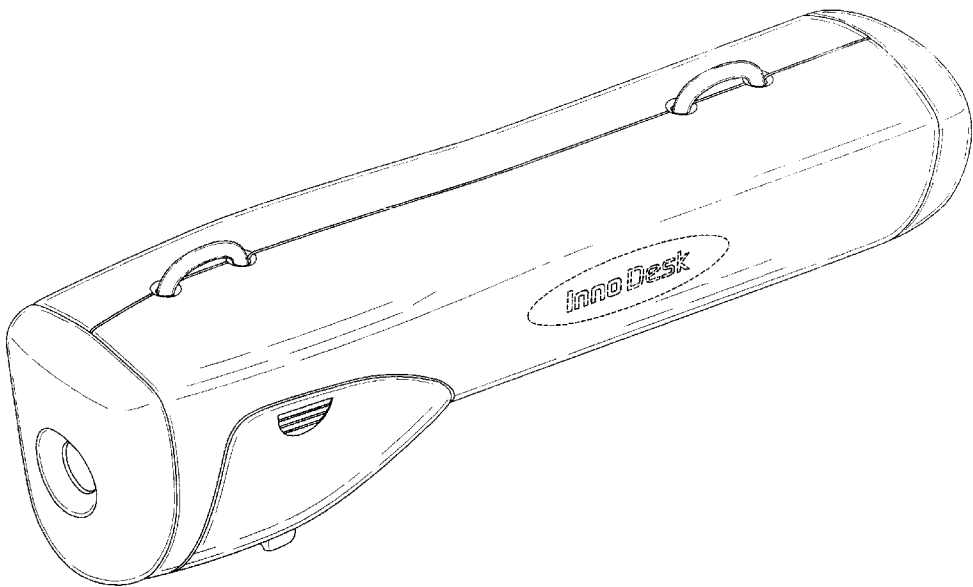
The ornamental design for a portable hand-held pencil sharpener with loop attachments, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the portable hand-held pencil sharpener with loop attachment; FIG. 2 is a left side view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a rear elevational view thereof.

The indicia depicted by means of broken lines in FIGS. 1, 3, and 5 has been shown for illustrative purposes only and forms no part of the claimed design.

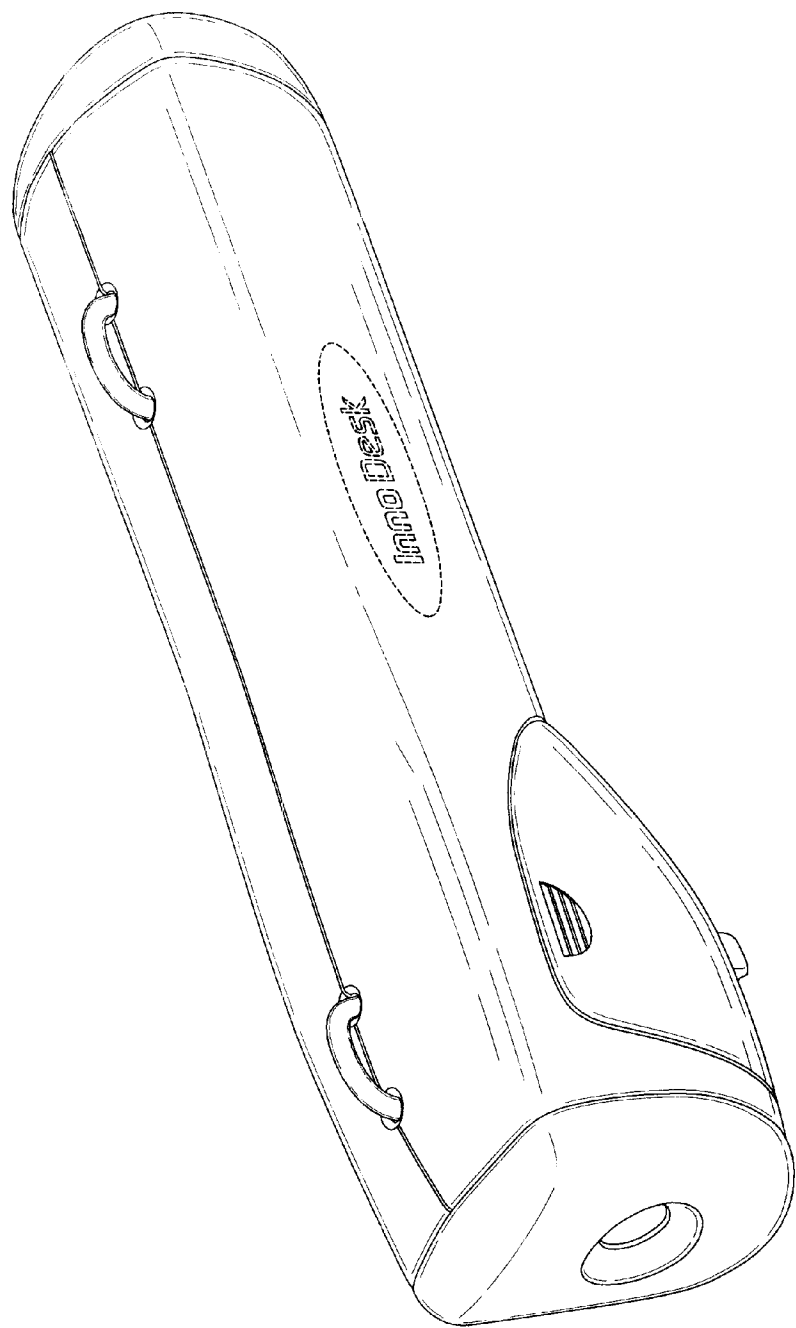

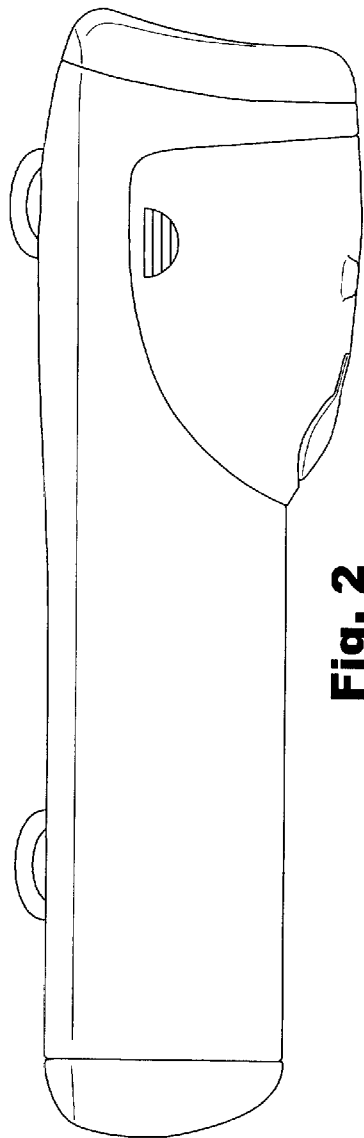

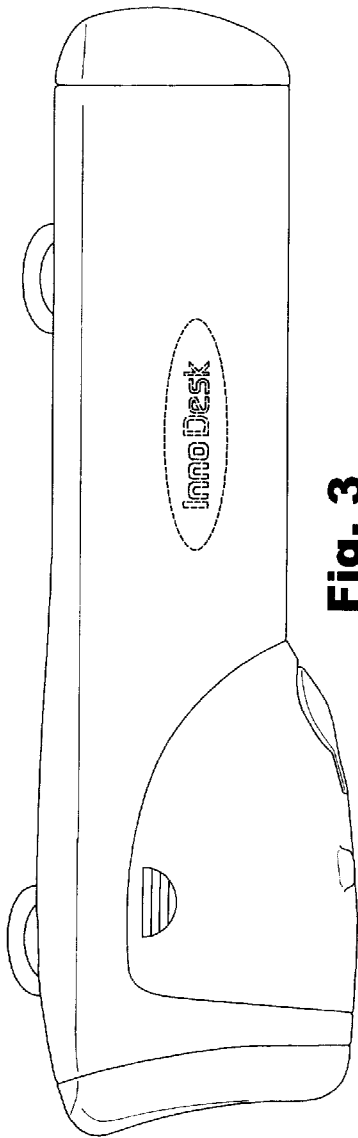

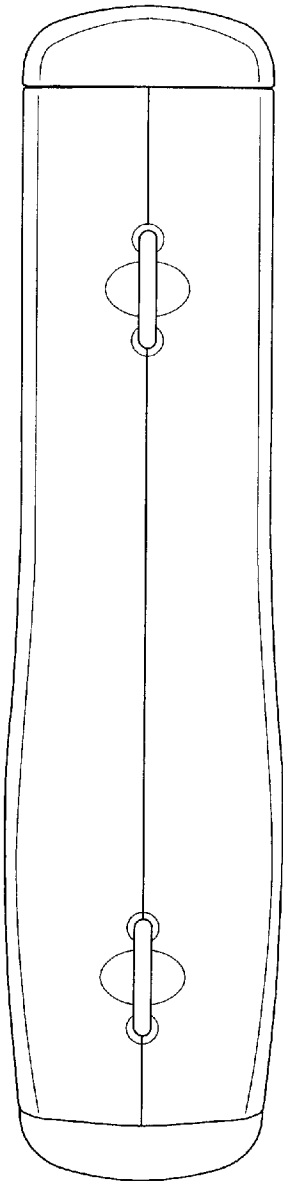

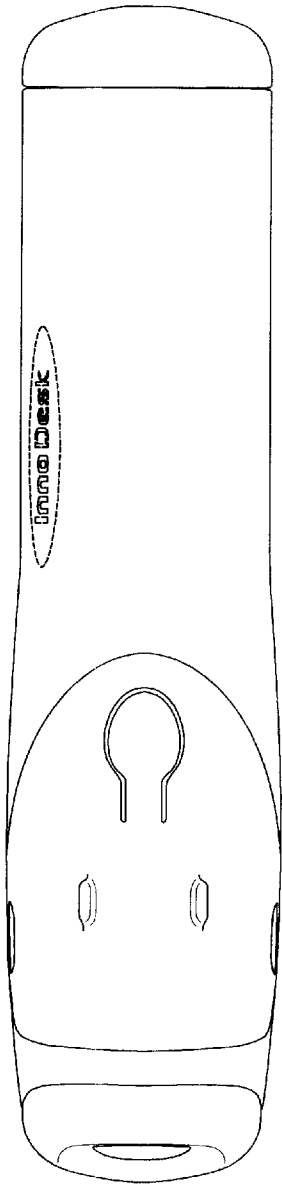

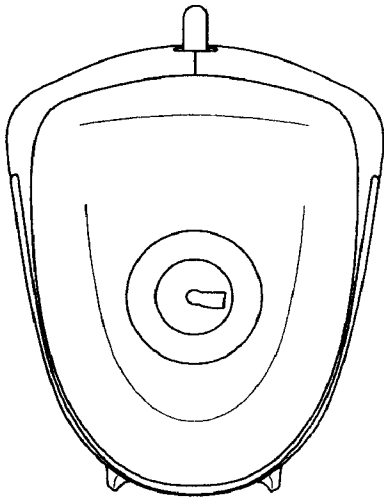

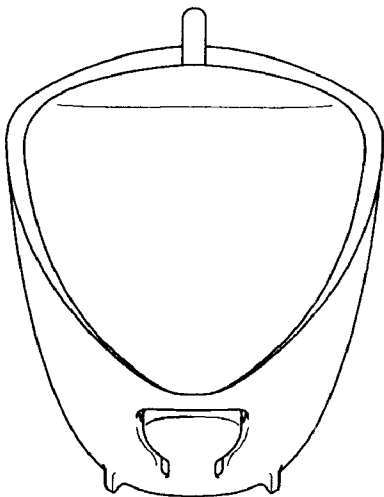
