The ornamental design for a bottle or similar article, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the bottle showing our new design;  
 FIG. 2 is a bottom view of the bottle of FIG. 1 on a reduced scale;  
 FIG. 3 is a side view of the bottle of FIG. 1 on a reduced scale;  
 FIG. 4 is a rear view showing the bottle of FIG. 1 on a reduced scale;  
 FIG. 5 is a top view of the bottle of FIG. 1 on a reduced scale.

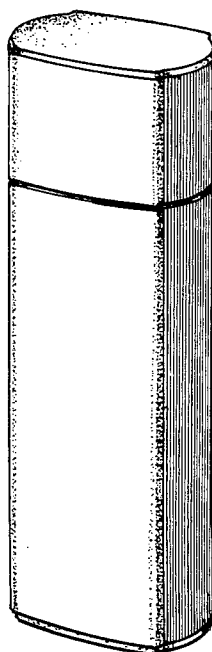

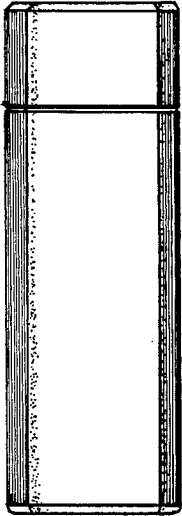

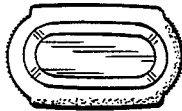

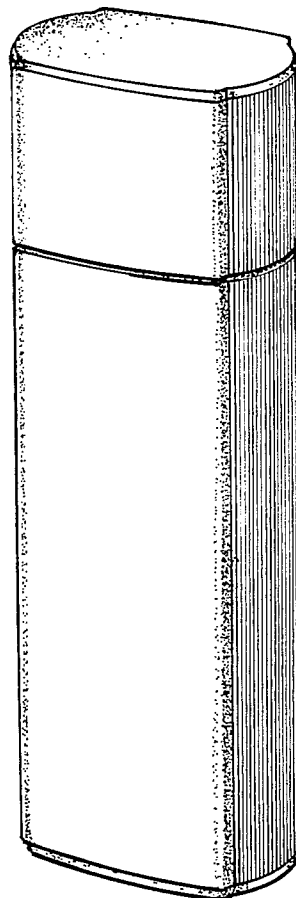
