The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a bottle showing my new design;

FIG. 7 is a cross-section taken along line 7-7 of FIG. 1;


FIG. 8 is a cross-section taken along line 8-8 of FIG. 1;




















