The ornamental design for a manipulator for robot, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the front, right, and top sides of a manipulator for robot showing our new design; FIG. 2 is a rear perspective view of the rear, right, and bottom sides thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

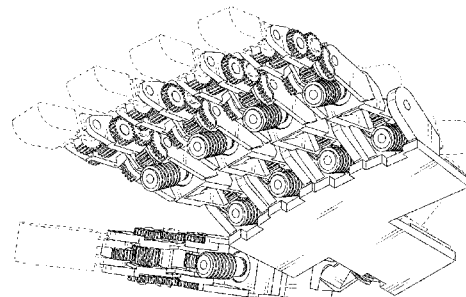
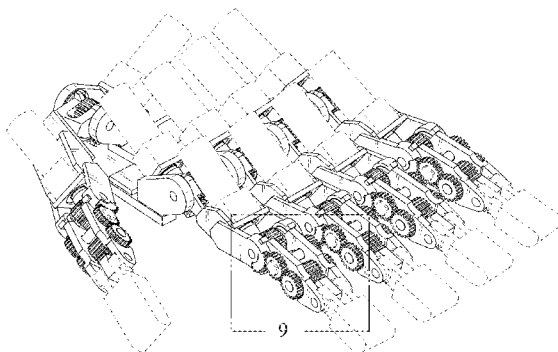
FIG. 9 is an enlarged view of FIG. 1; and,

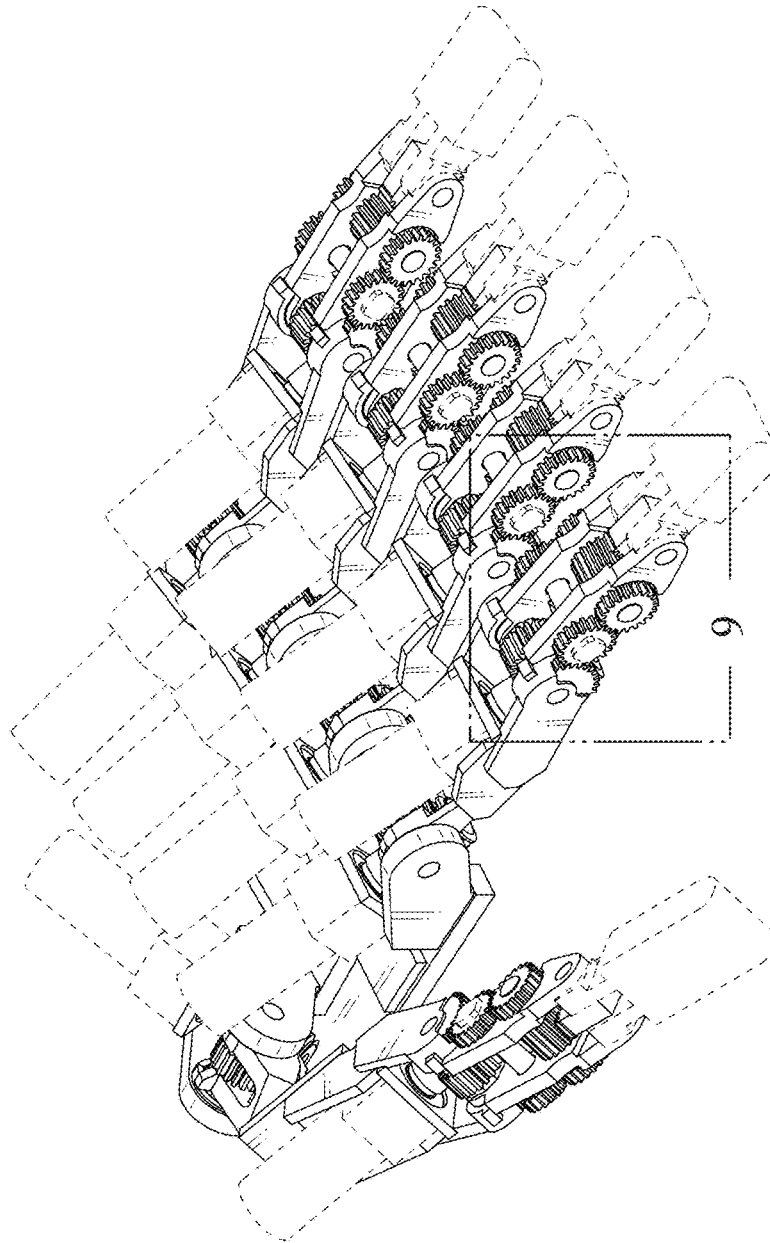

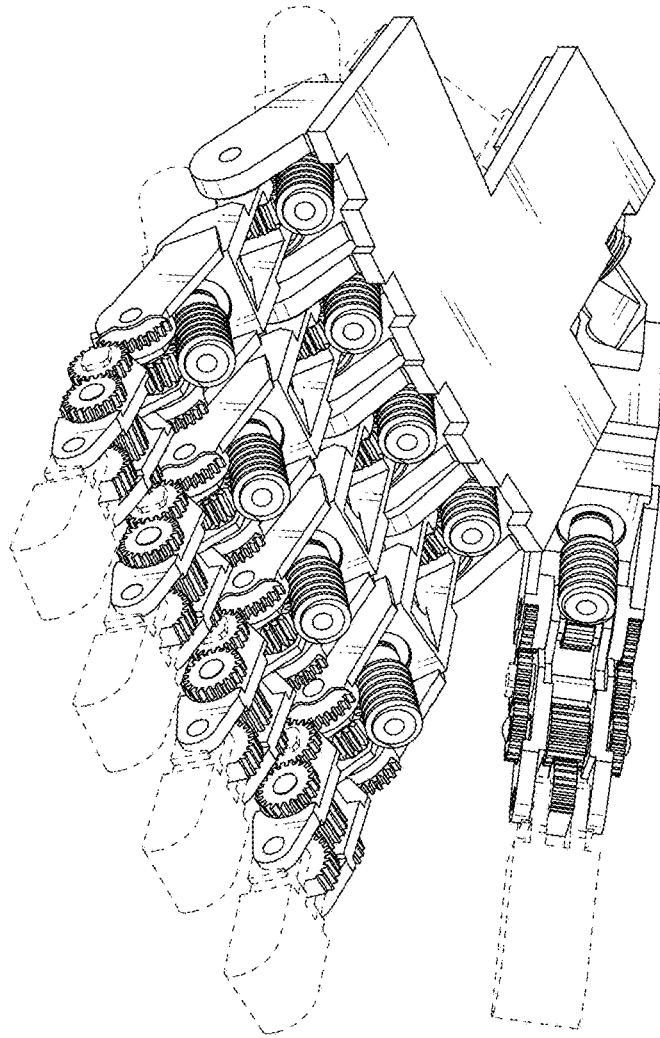

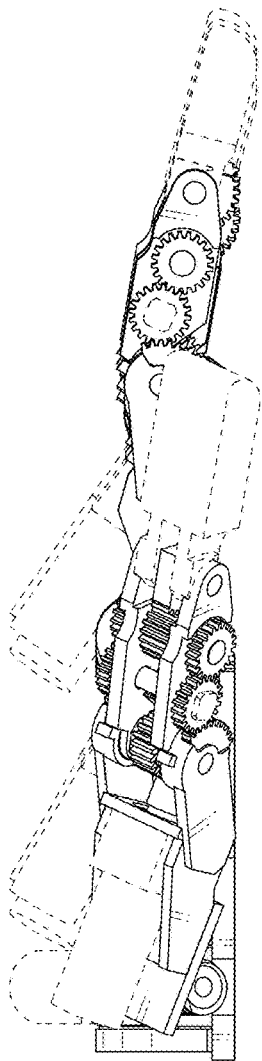

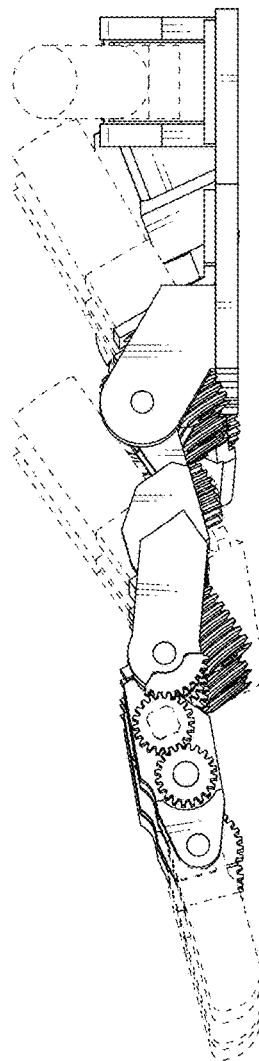

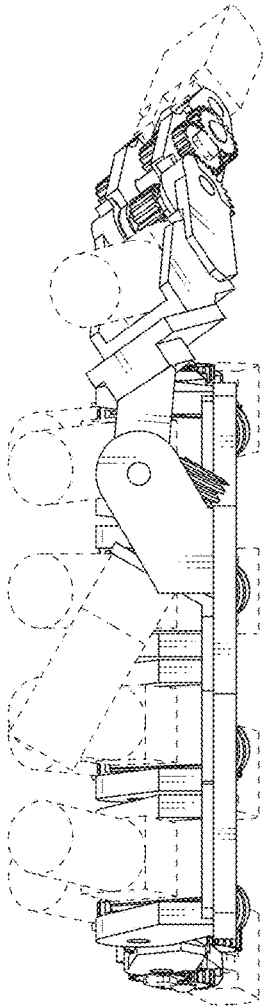

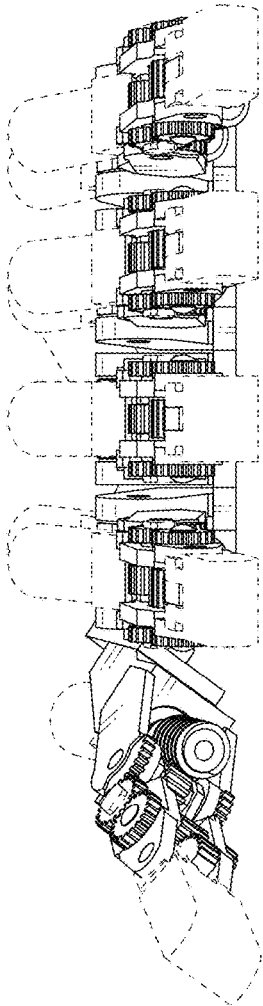

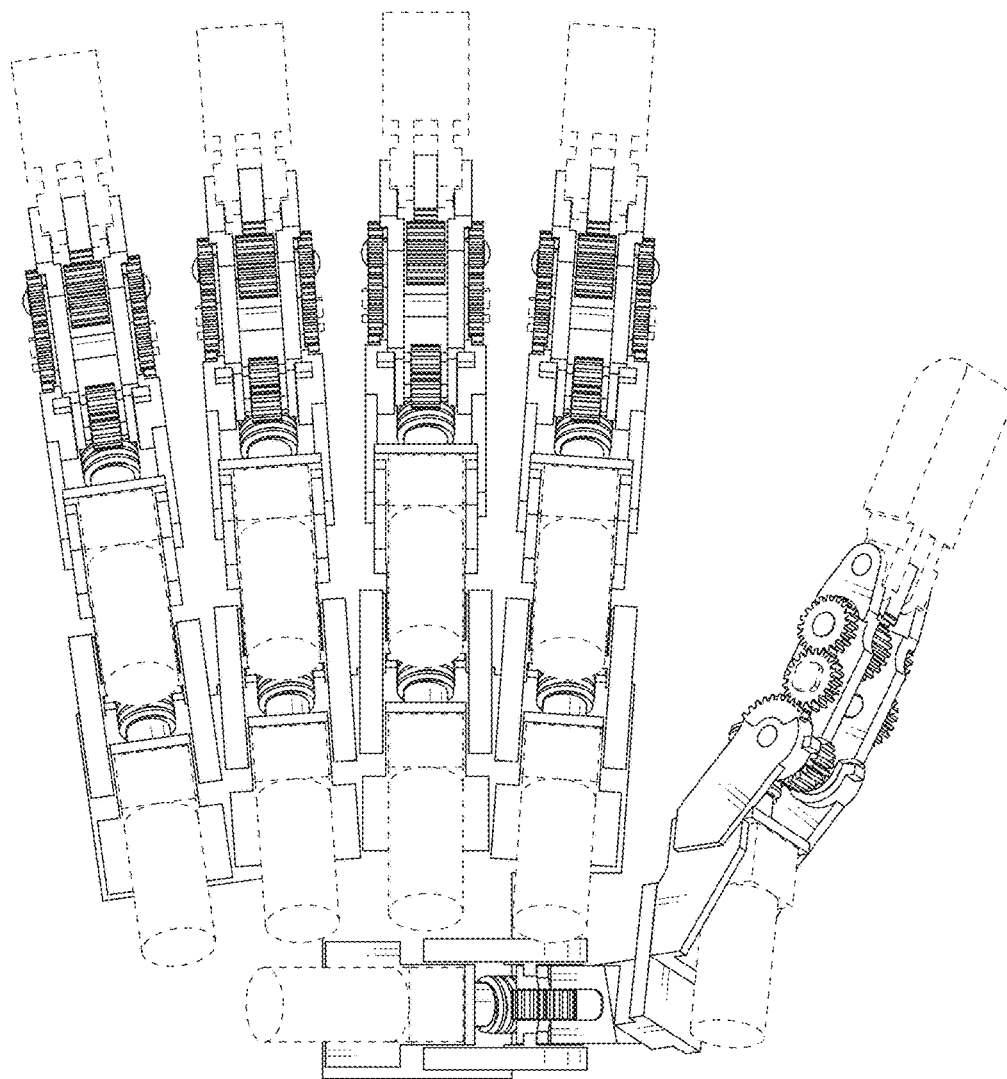

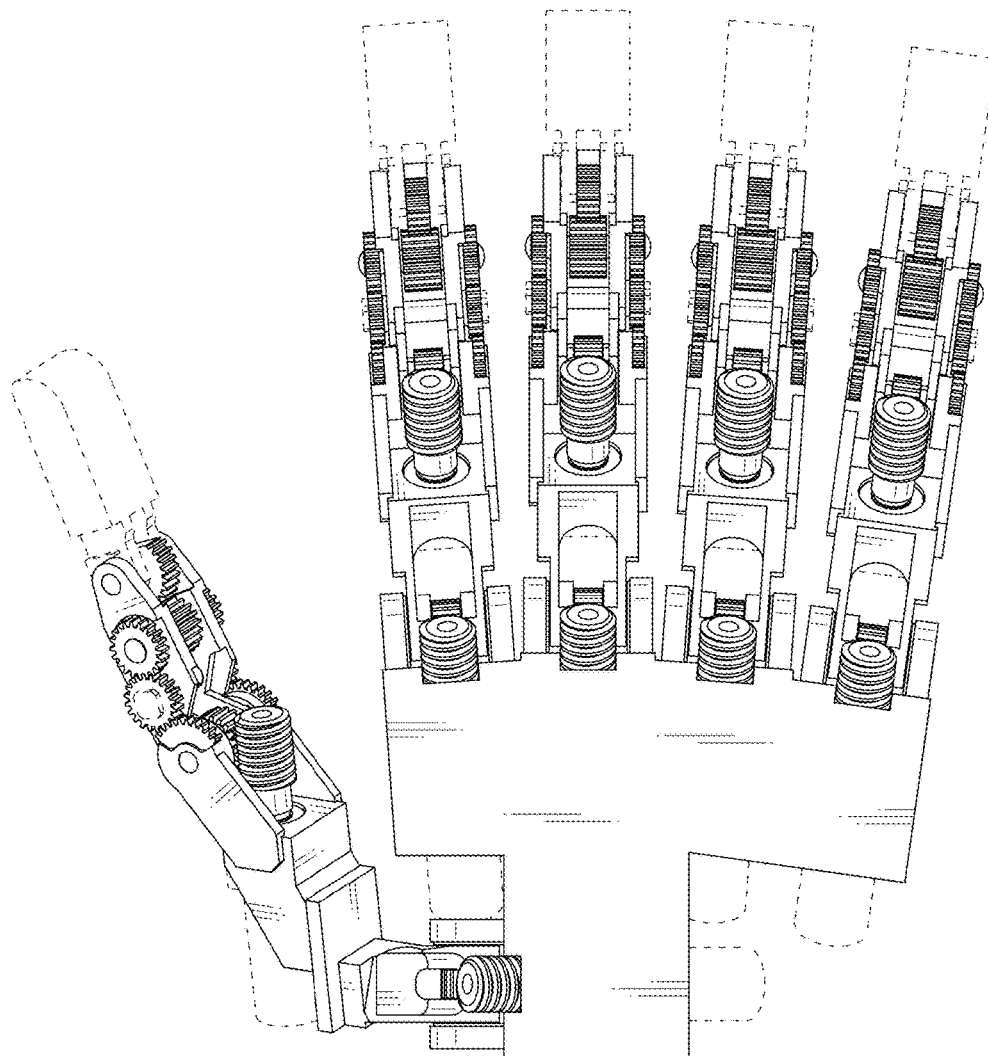

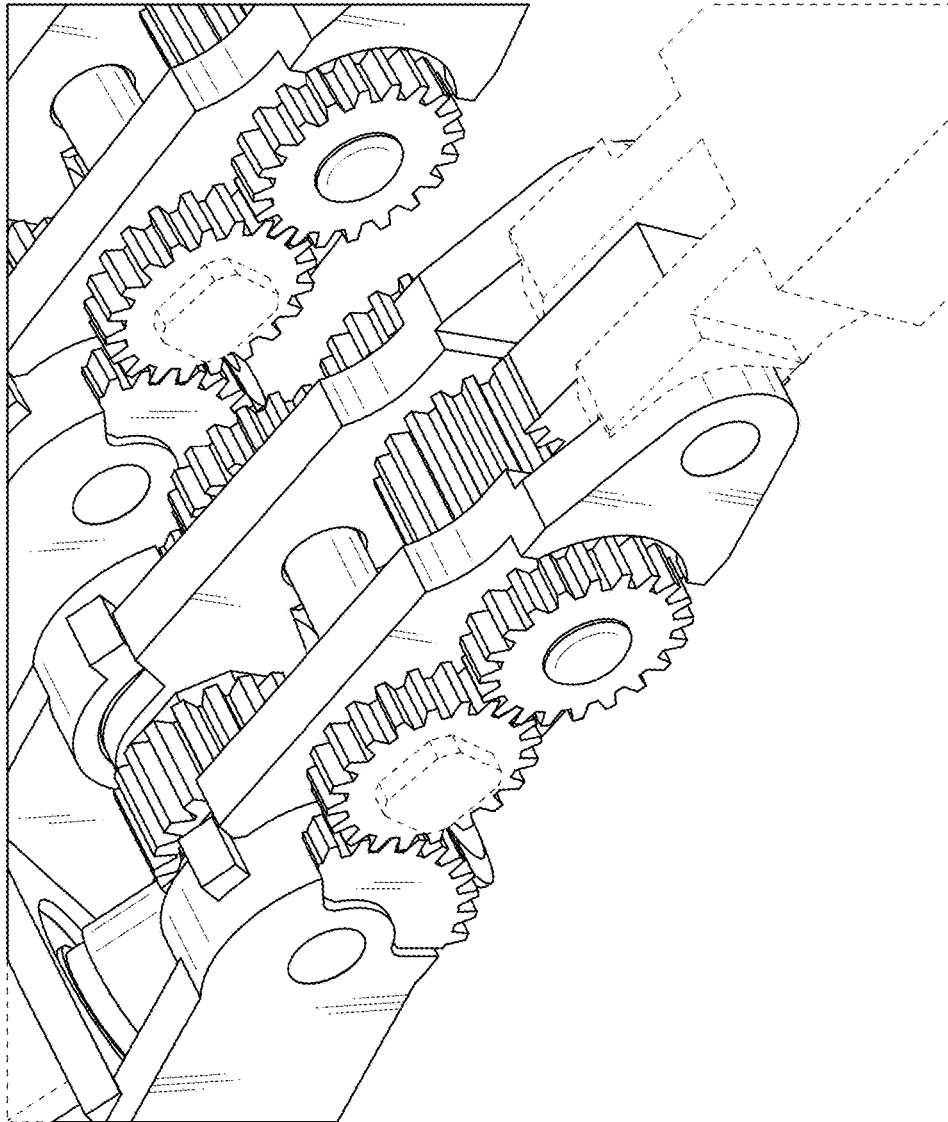
