
(57) **CLAIM**

We claim the ornamental design for a team room locker, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a team room locker according to the present invention;
FIG. 2 is a front elevational view thereof;

FIG. 4 is a top plan view thereof.






