The ornamental design for a bottle and cap, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a bottle and cap embodying our new design;
FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image of the front elevational view;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a perspective view thereof; and,
FIG. 7 is a perspective view thereof.














