


The ornamental design for an earphone caddy, as shown and described.

DESCRIPTION

FIG. 1 is a frontside perspective view of the earphone caddy; FIG. 2 is a backside perspective view of the earphone caddy; FIG. 3 is a top plan view of the earphone caddy; FIG. 4 is a bottom plan view of the earphone caddy; FIG. 5 is a left side elevation of the earphone caddy, a right side elevation being a mirror image thereof; FIG. 6 is a front elevation of the earphone caddy; and, FIG. 7 is a rear elevation of the earphone caddy.














