FIG. 1 is a top plan view of a praline or similar article showing my design;

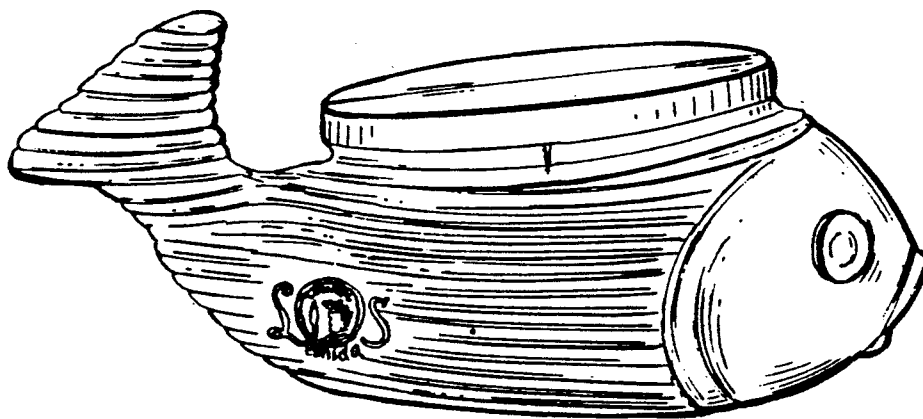
FIG. 2 is a left side elevational view thereof;

FIG. 6 is a front elevational view thereof.



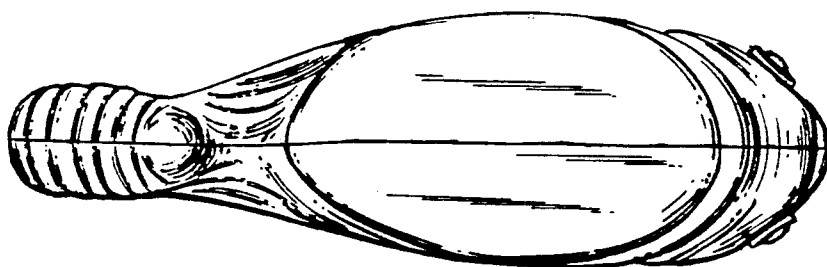

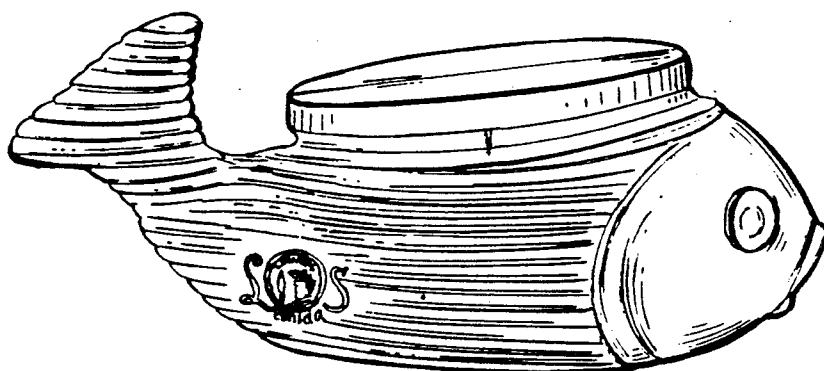

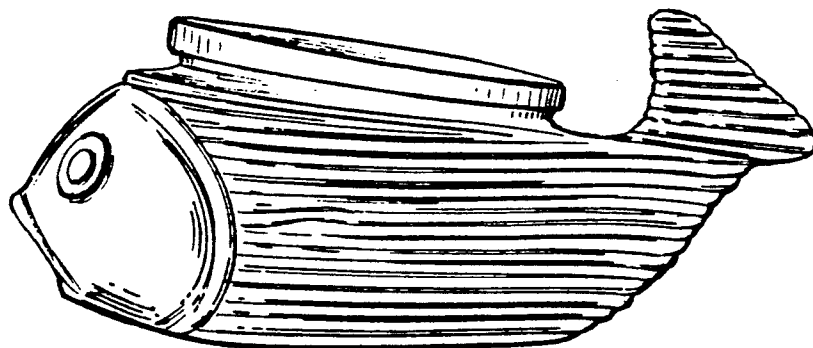

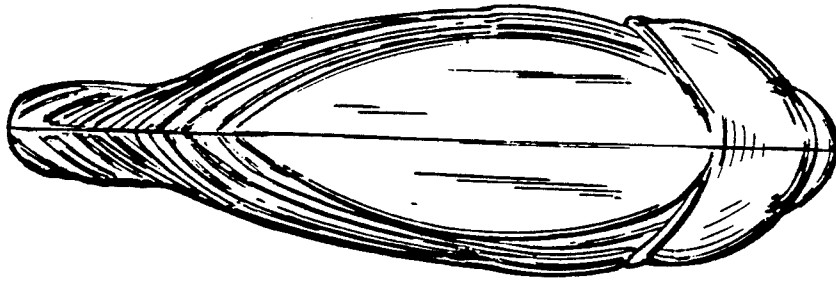

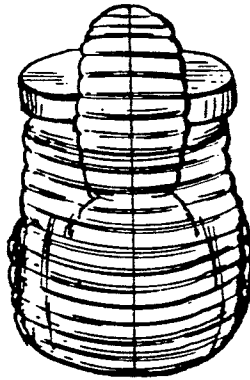

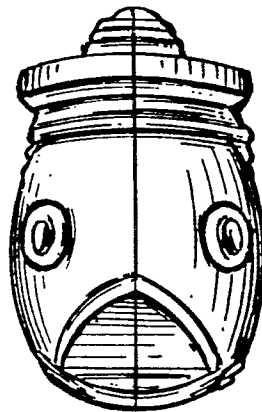
