The ornamental design for a bag, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of the bag.

FIG. 2 is a left side view of the bag.

FIG. 3 is a right side view of the bag.

FIG. 4 is a front view of the bag.

FIG. 5 is a back view of the bag.

FIG. 6 is a top view of the bag.


FIG. 7 is a bottom view of the bag.


















