(57) **CLAIM**

The ornamental design for a portable loud speaker, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the portable loud speaker.
FIG. 2 is a right side elevational view of the portable loud speaker, the left being a mirror image of the right.
FIG. 3 is a front elevational view of the portable loud speaker.
FIG. 4 is a rear elevational view of the portable loud speaker.
FIG. 5 is a bottom plan view of the portable loud speaker.
FIG. 6 is a top front right perspective view of the portable loud speaker; and,
FIG. 7 is a top rear right perspective view of the portable loud speaker.

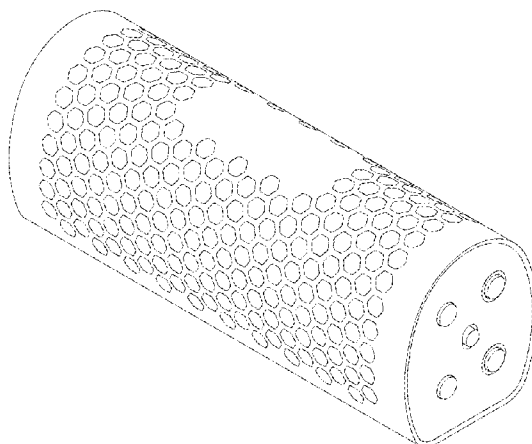
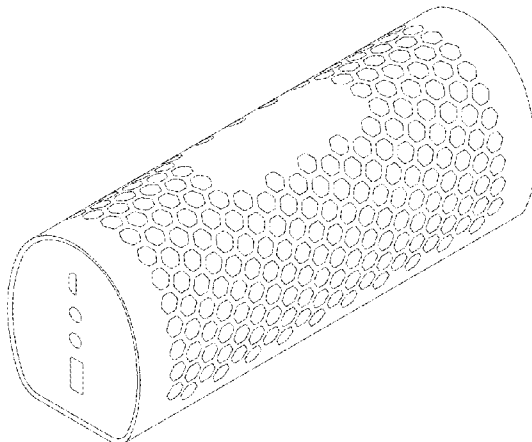

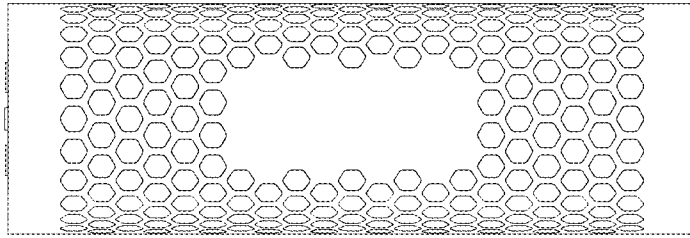

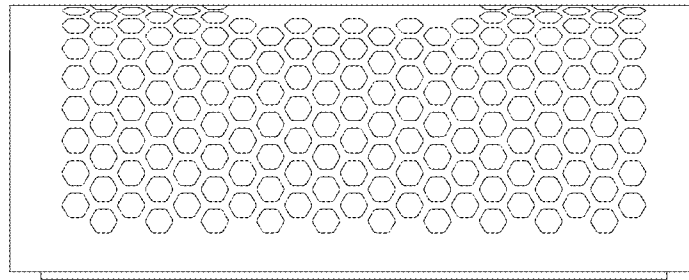

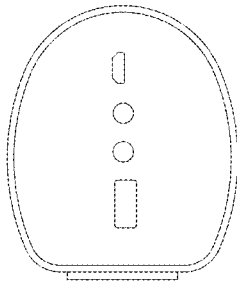

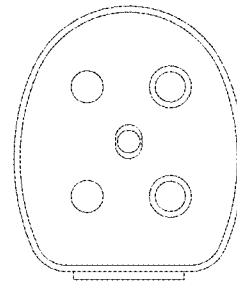

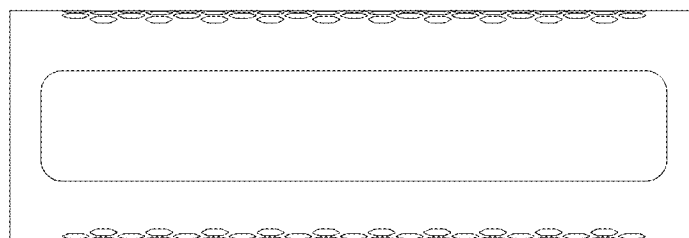

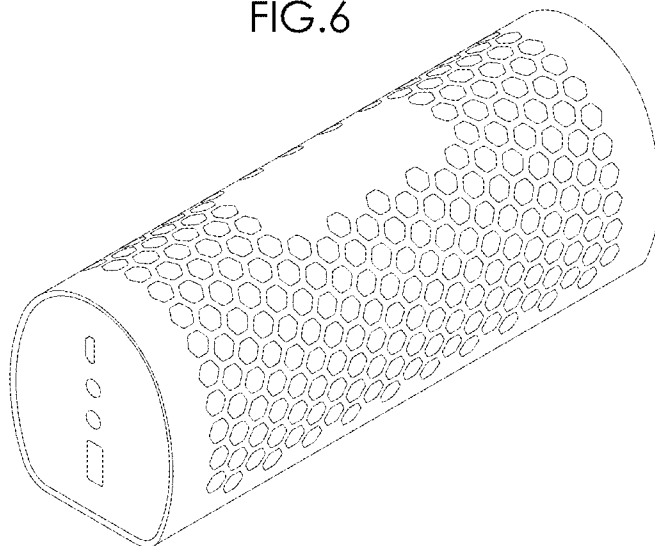
