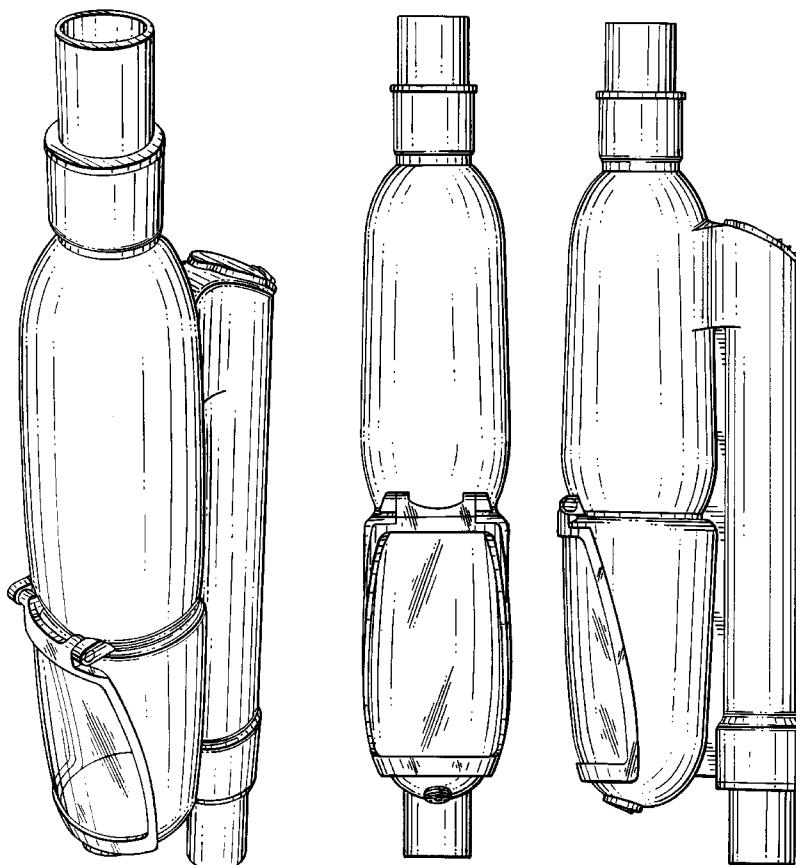

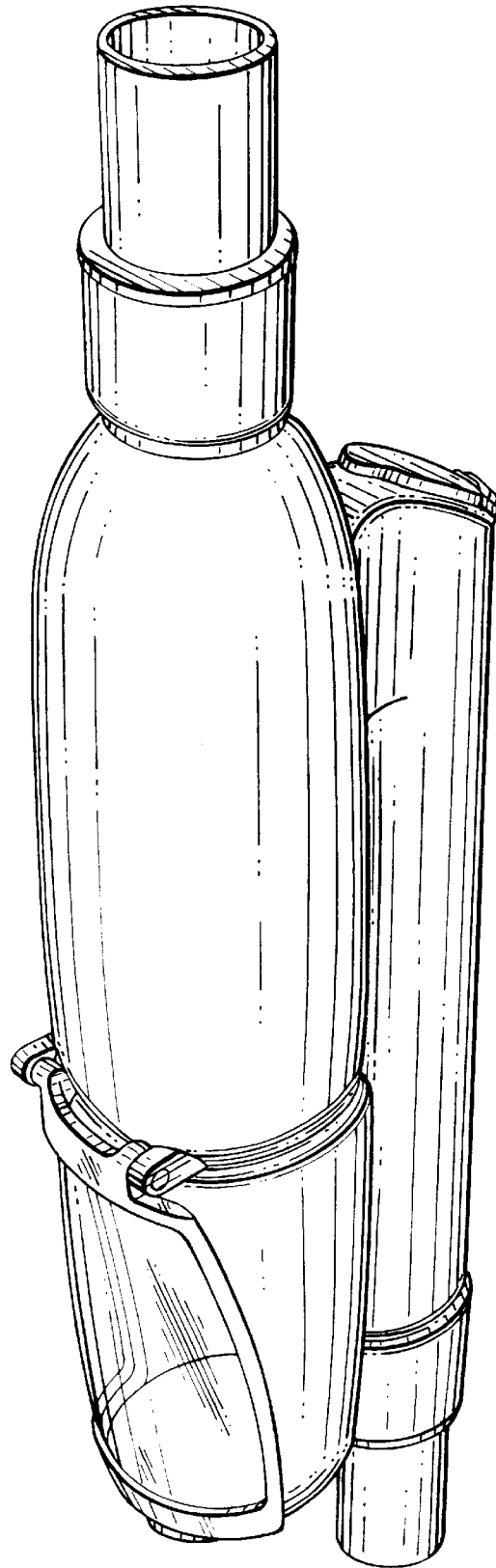
The ornamental design for a cyclonic separation device, as

**DESCRIPTION**

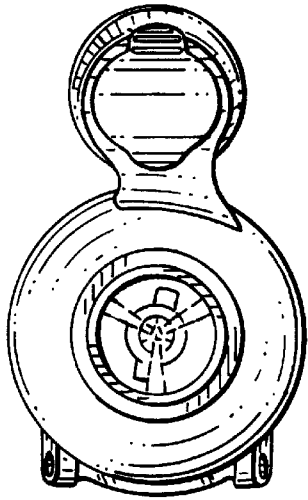
FIG. 1 is a top, front and right side perspective view of a

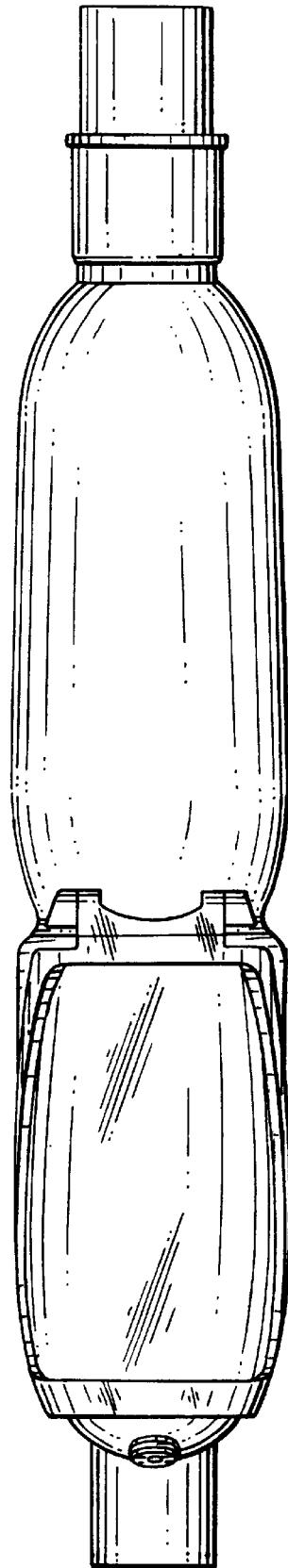




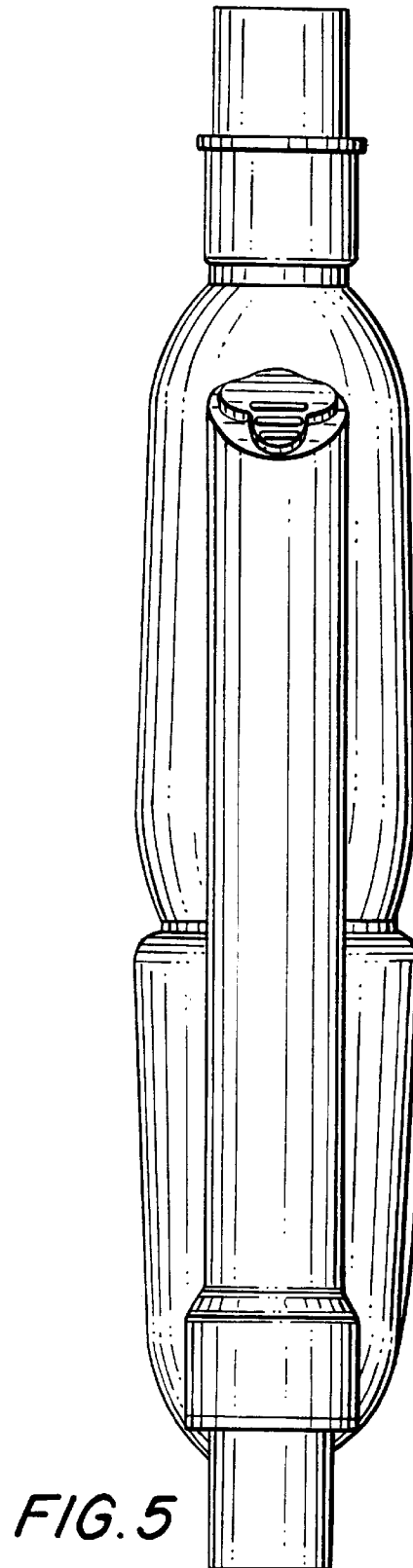
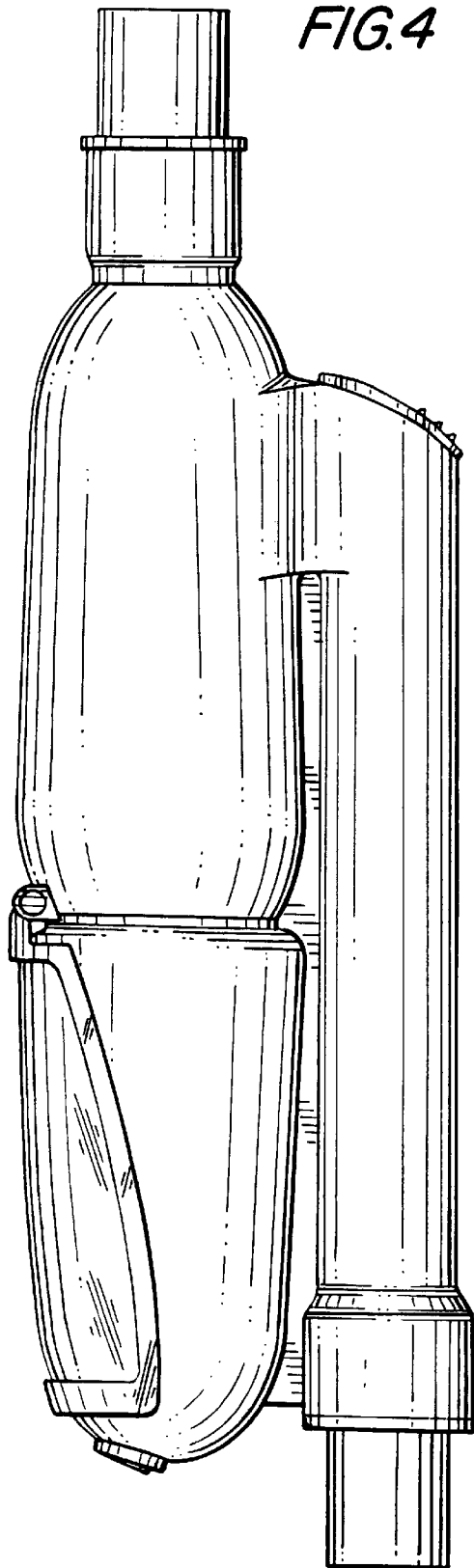

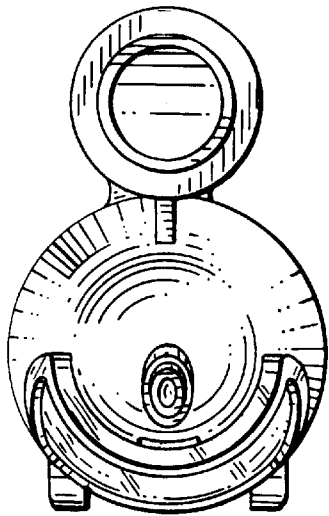
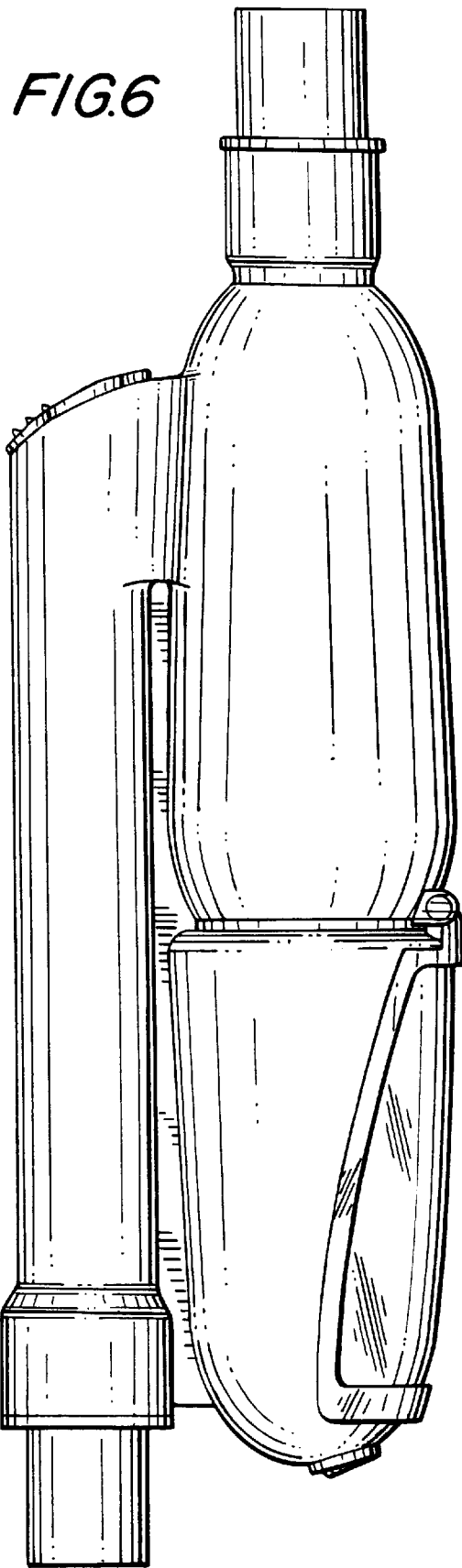
