DESCRIPTION

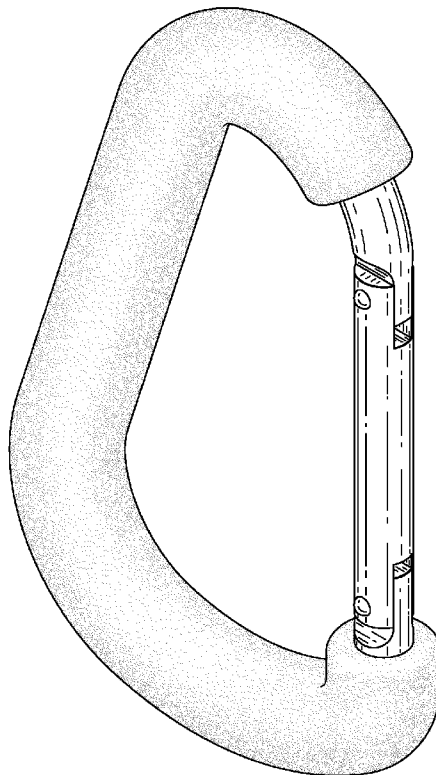
FIG. 1 is a perspective view of one embodiment of a carabiner showing my new design;

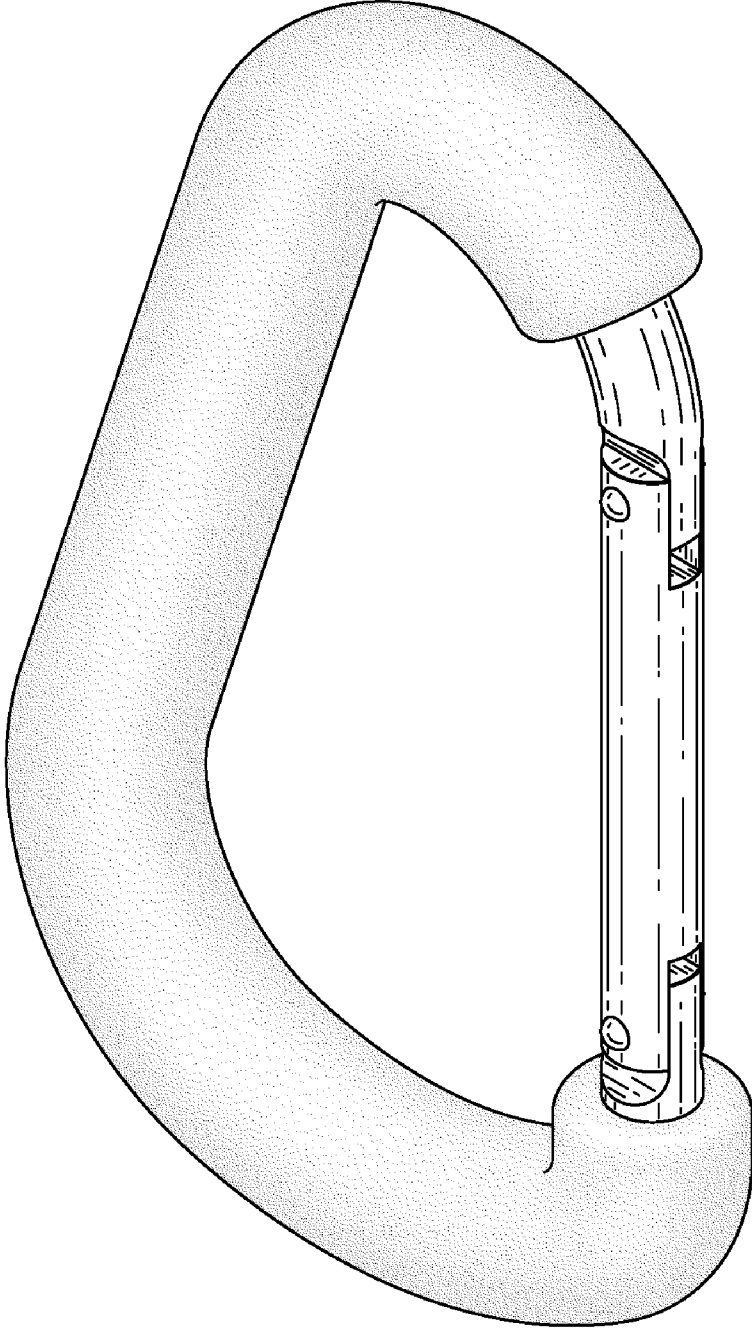

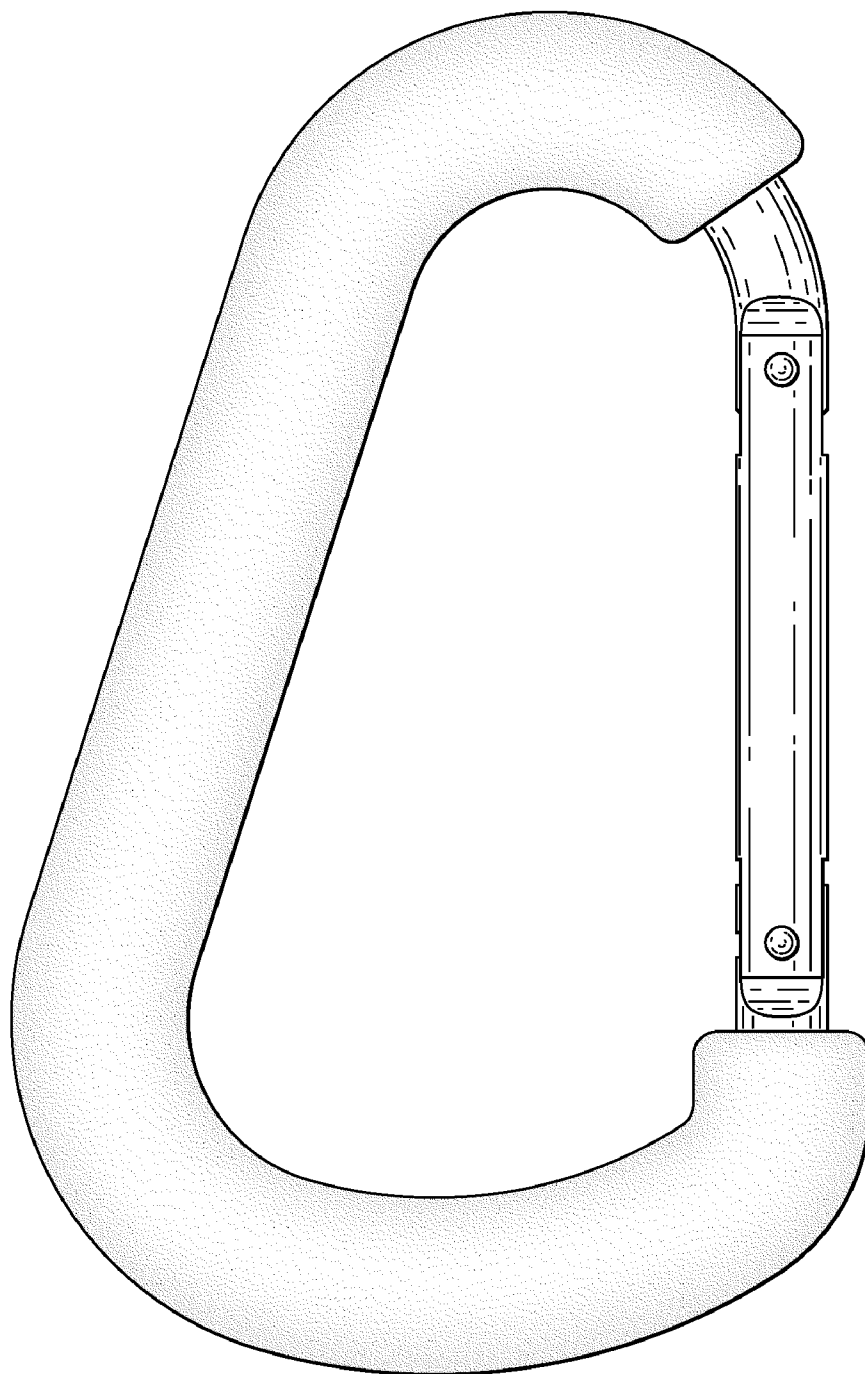

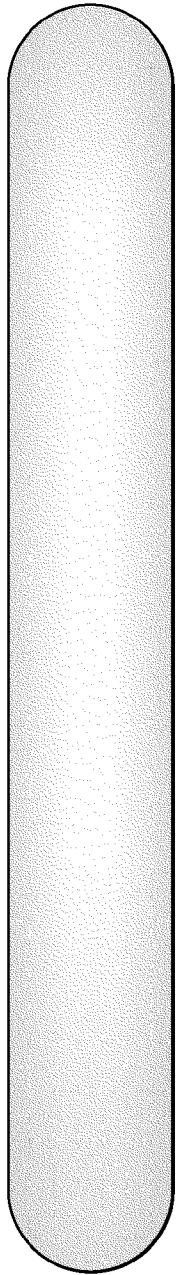

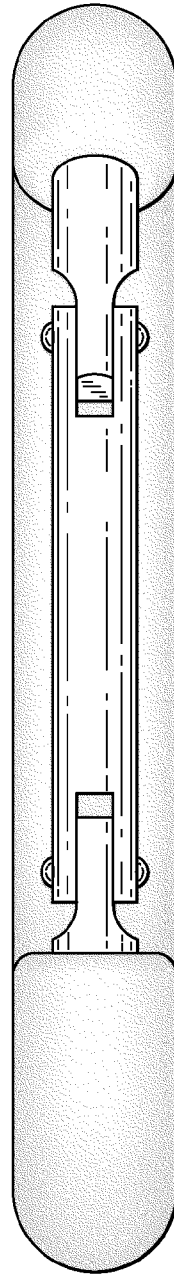

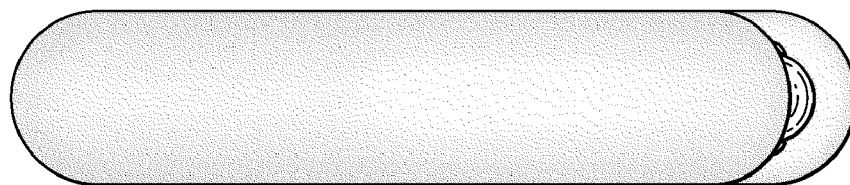

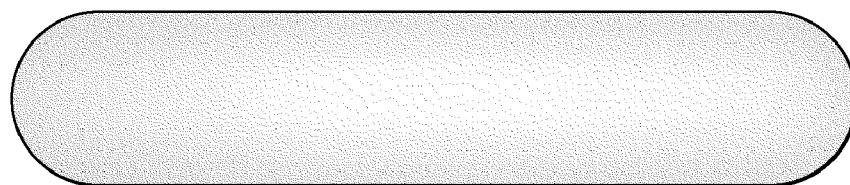
