(57) **CLAIM**



The ornamental design for a rectangular food container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a rectangular food container showing my new design;
 FIG. 2 is a front elevational view thereof; the rear elevational view being identical thereof;
 FIG. 3 is a right side elevational view thereof; the left side elevational view being identical thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is an exploded top perspective view of a rectangular food container of FIG. 1 shown open thereof;
 FIG. 7 is an exploded front elevational view thereof; and,
 FIG. 8 is a cross-sectional view of a rectangular food container taken along line 8-8 of FIG. 1.

The broken lines in FIG. 5 of the rectangular food container are for the purpose of illustrating environment, and form no part of the claimed design.
















