The ornamental design for a battery cartridge, as shown and described.

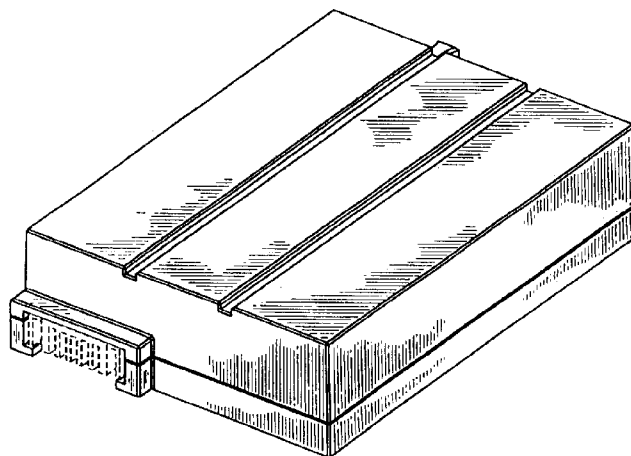
DESCRIPTION

FIG. 1 illustrates a top perspective view of a battery cartridge looking from a connector end;

- FIG. 2 illustrates a perspective view thereof looking from a withdrawal end;
- FIG. 3 illustrates a bottom perspective view thereof;
- FIG. 4 illustrates a side elevation view thereof;
- FIG. 5 illustrates a plan view thereof looking from a top side thereof;
- FIG. 6 illustrates an elevation view of the connector end thereof;
- FIG. 7 illustrates an elevation view of the withdrawal end thereof;
- FIG. 8 illustrates a plan view looking from a bottom side thereof;
- FIG. 9 illustrates a top perspective view of a second embodiment of a battery cartridge without chamfered edges looking from a connector end;
- FIG. 10 illustrates a perspective view thereof without chamfered edges looking from a withdrawal end;
- FIG. 11 illustrates a bottom perspective view thereof without chamfered edges;
- FIG. 12 illustrates a side elevation view thereof without chamfered edges;
- FIG. 13 illustrates a plan view thereof without chamfered edges looking from a top side thereof;
- FIG. 14 illustrates an elevation view of the connector end thereof without chamfered edges;
- FIG. 15 illustrates a plan view looking from a bottom side thereof without chamfered edges; and,
- FIG. 16 illustrates an elevation view of the withdrawal end thereof without chamfered edges.

The broken lines throughout the drawings are included for the purpose of illustrating portions of the battery cartridge that form no part of the claimed design.

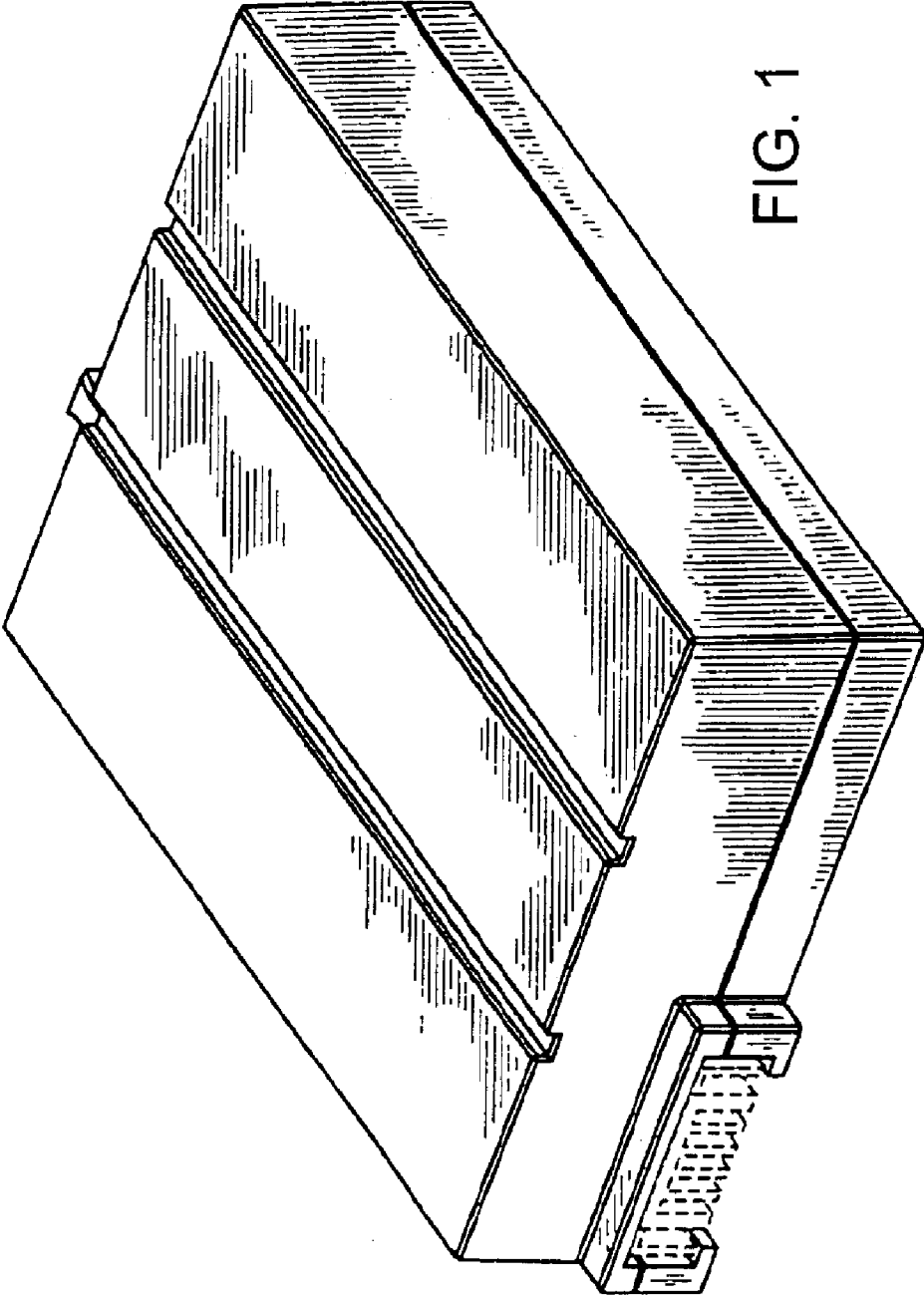

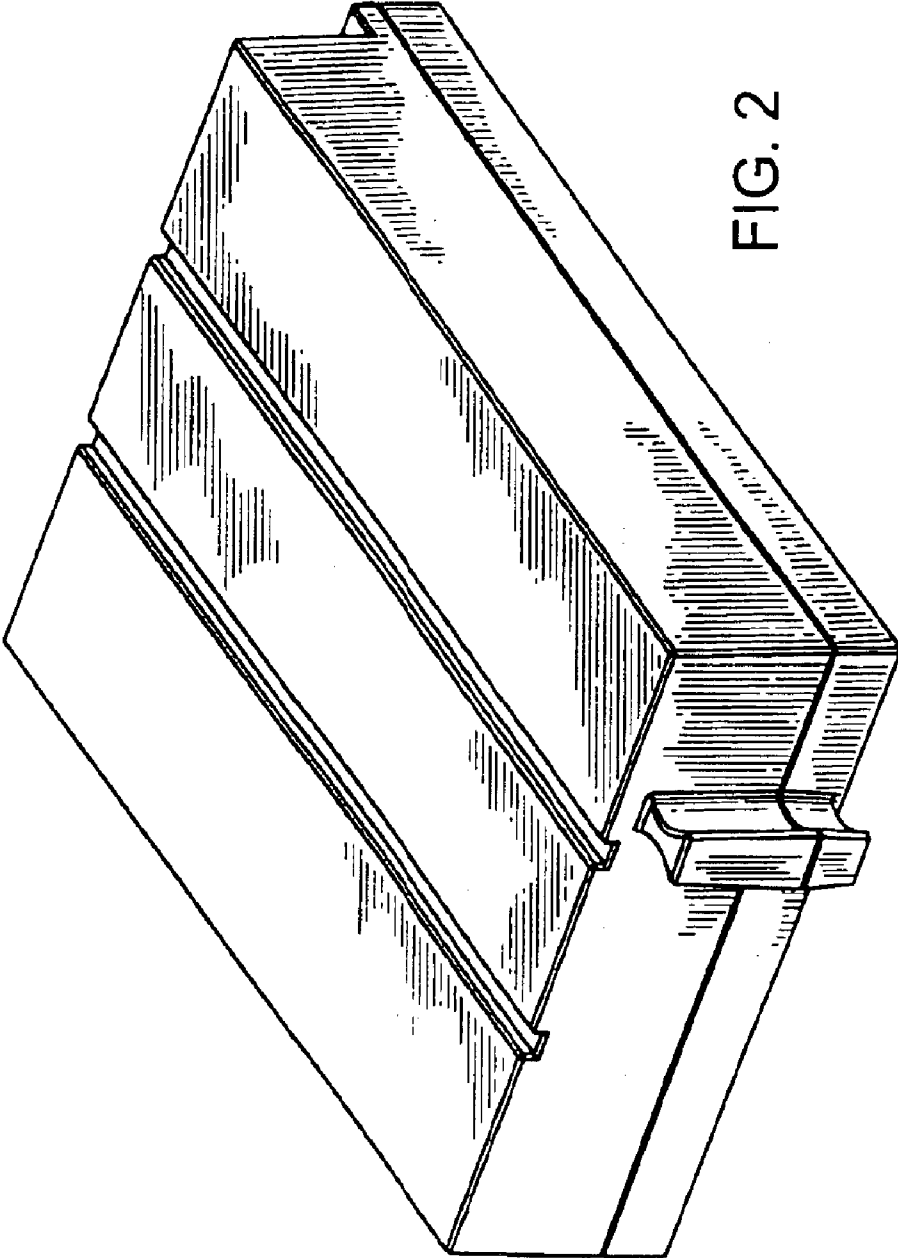

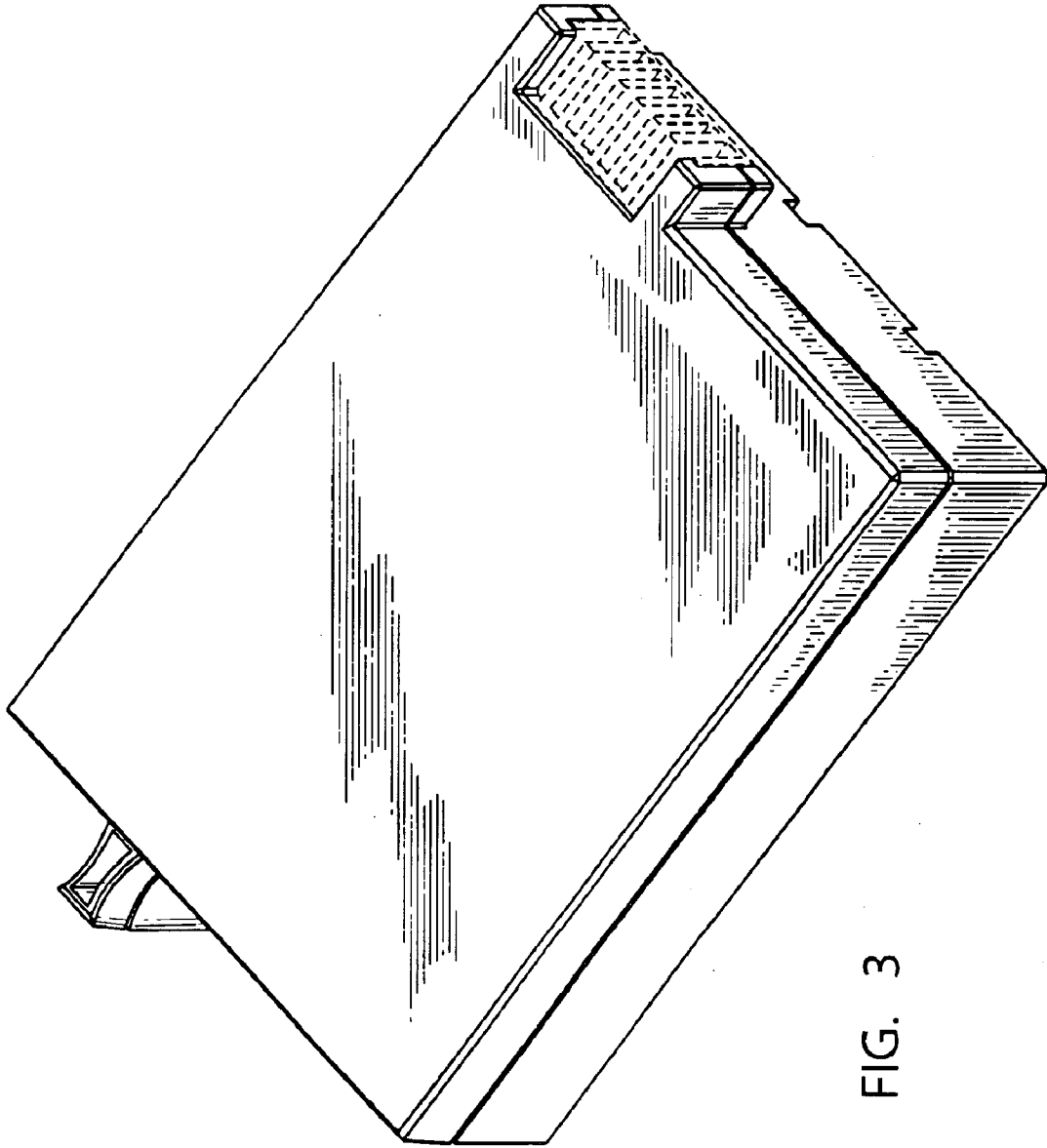

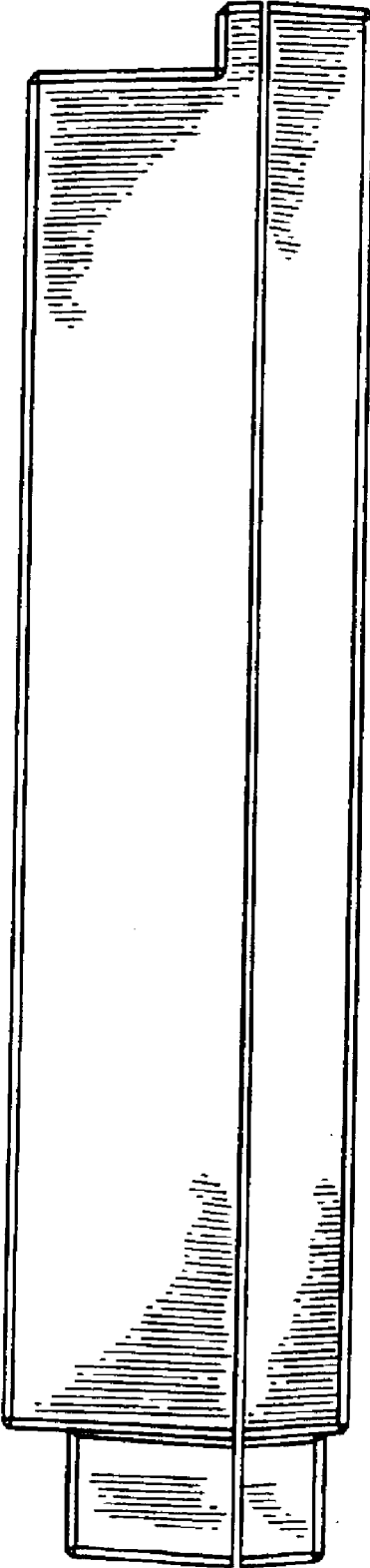

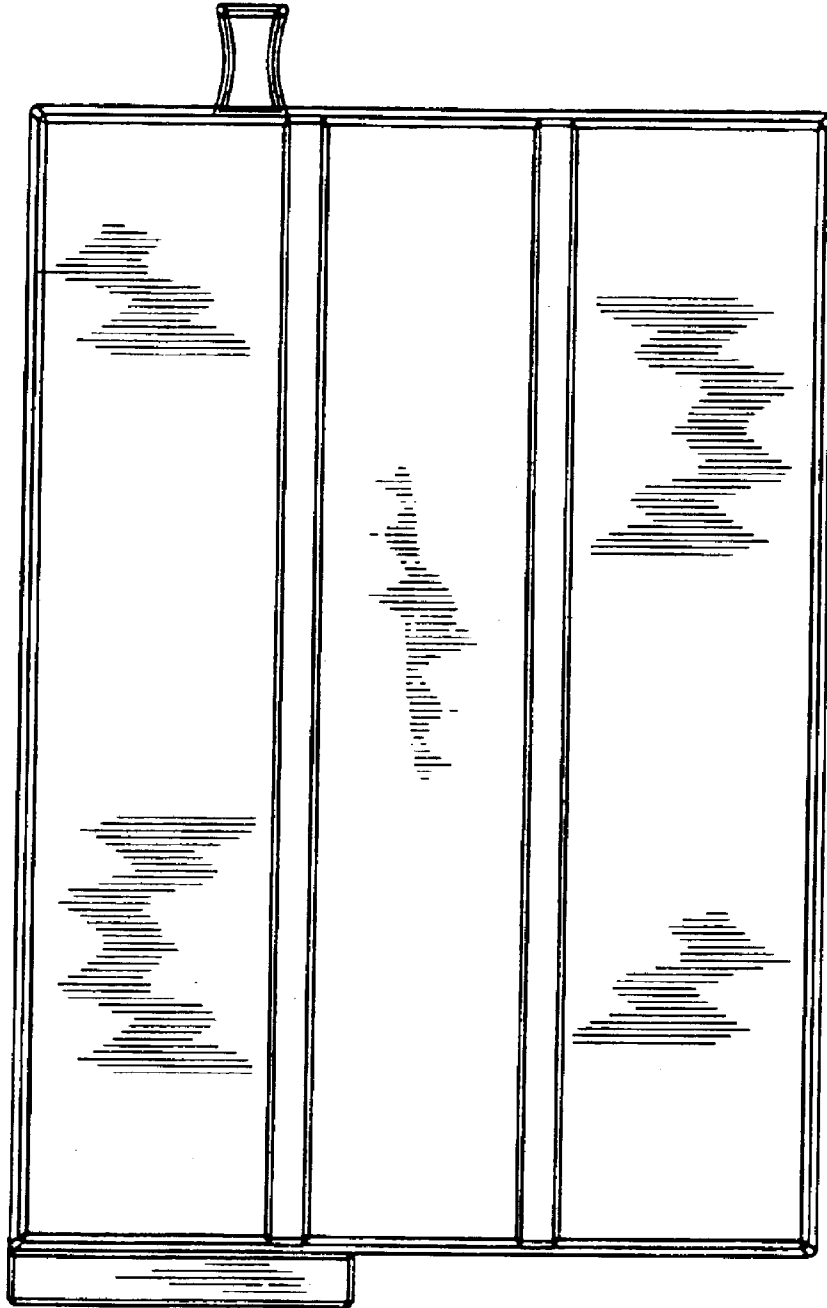

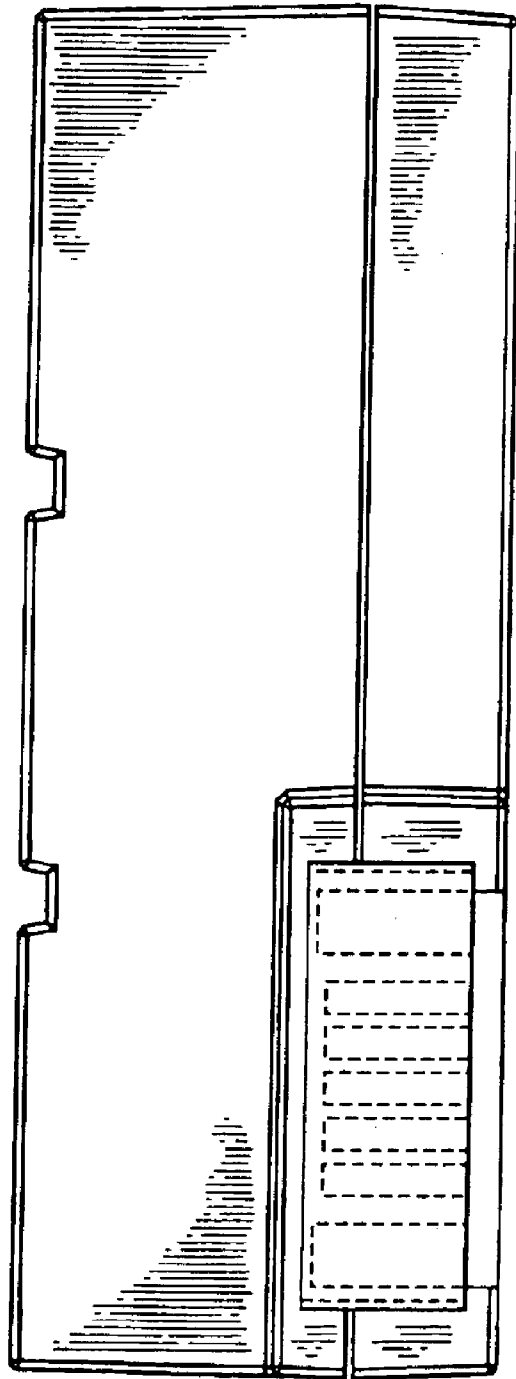

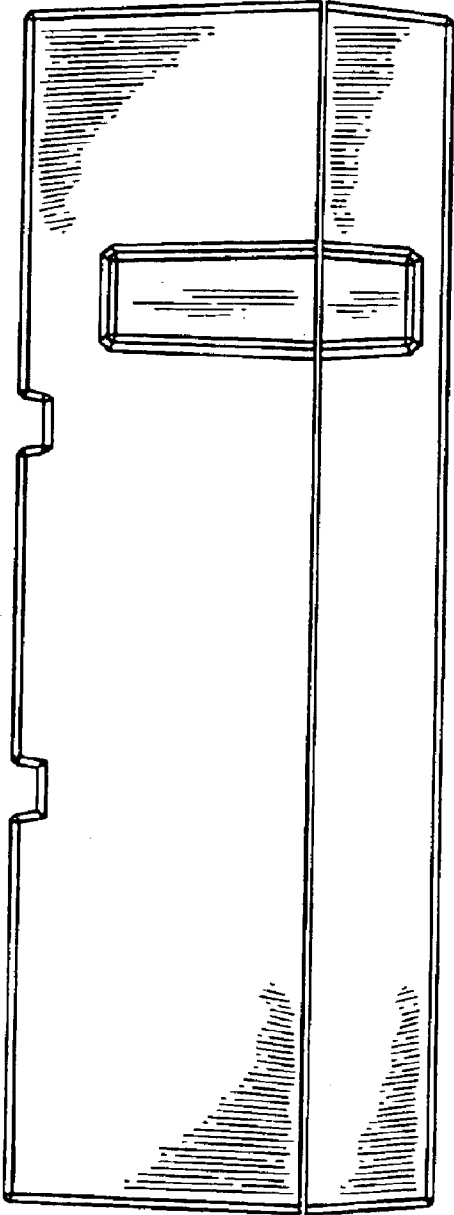

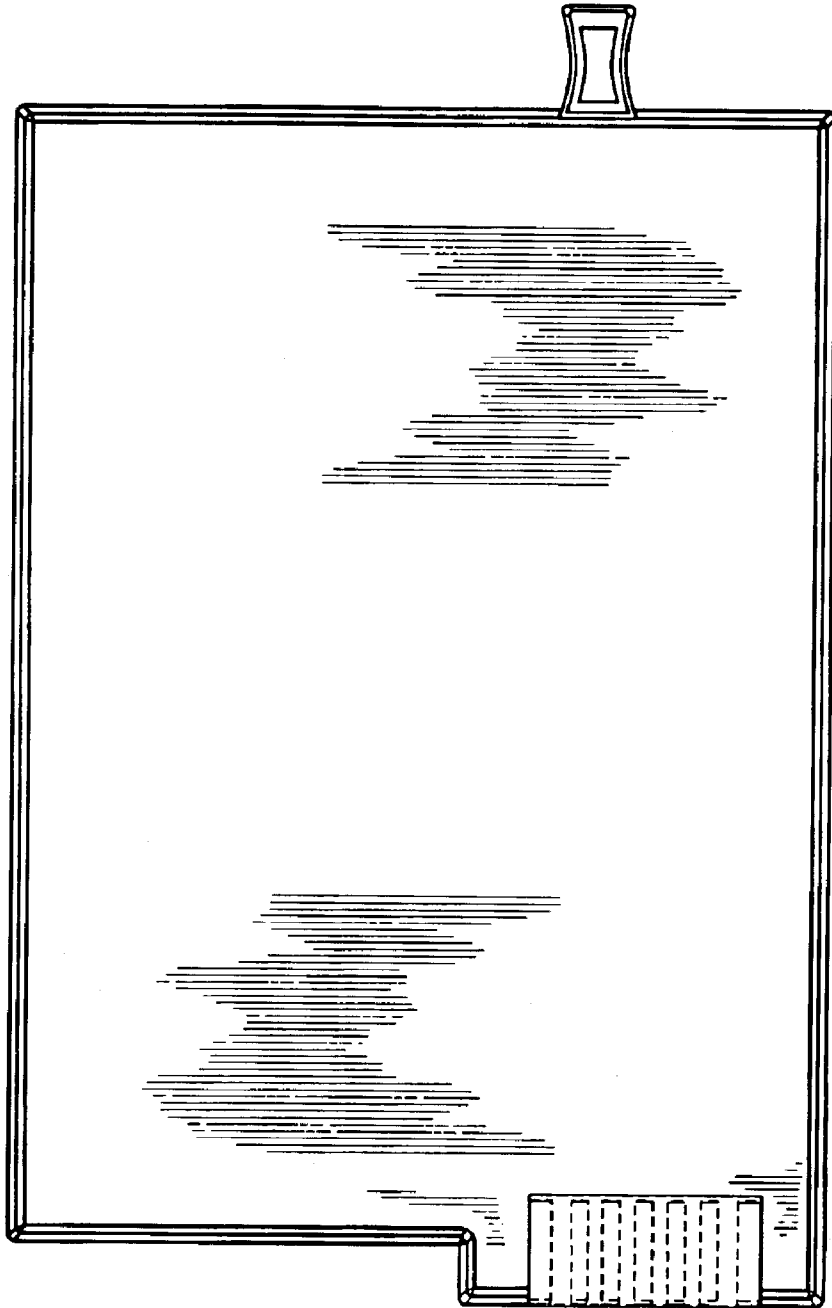

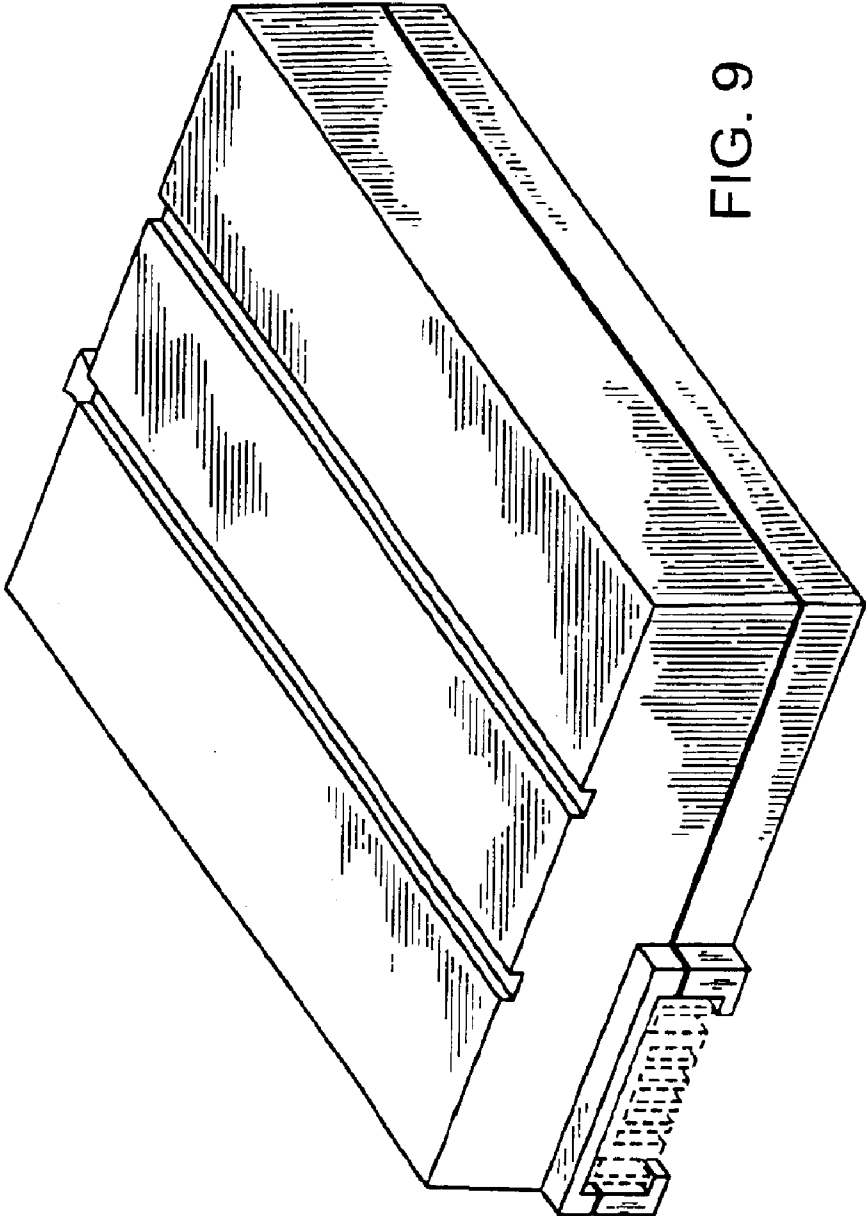

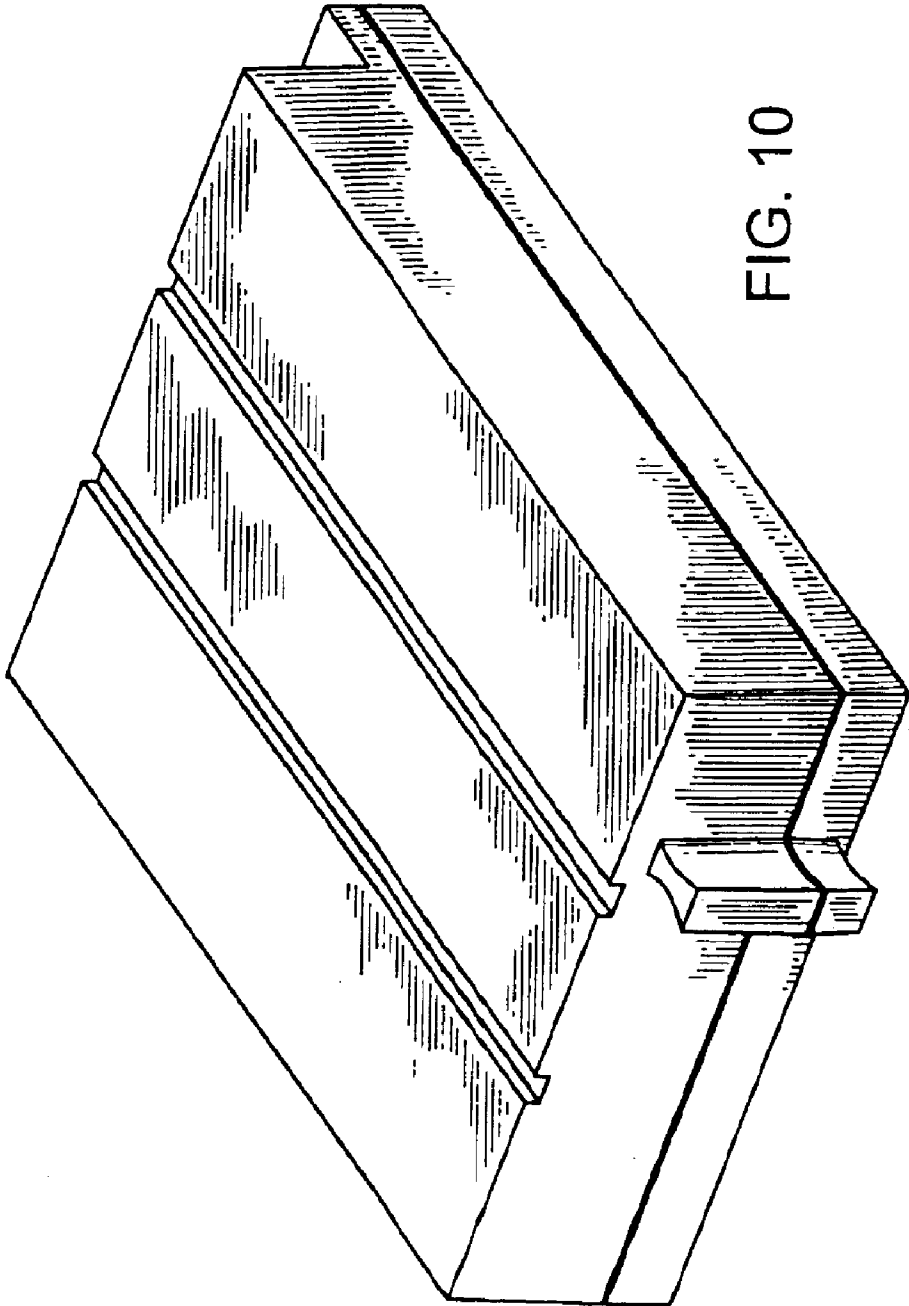

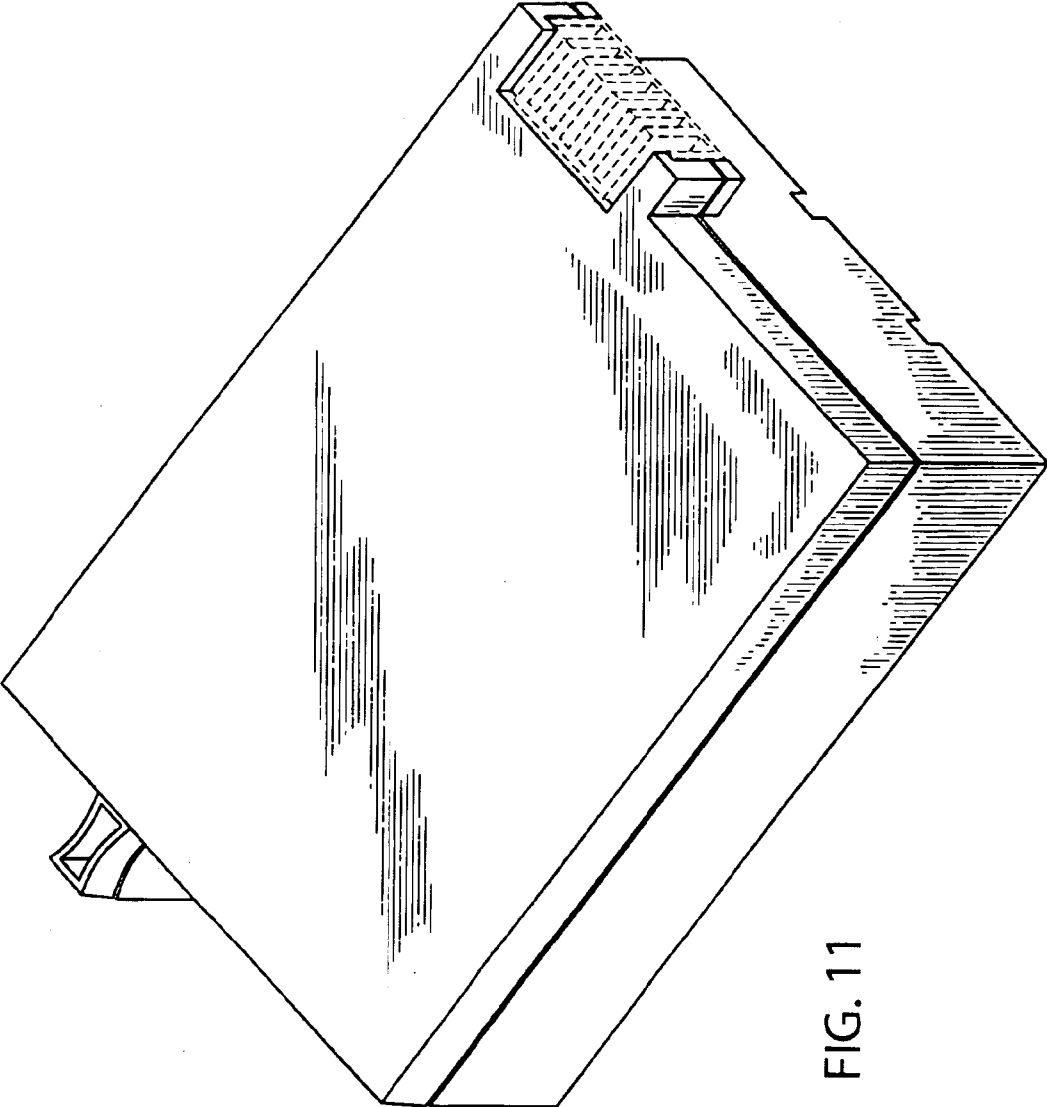

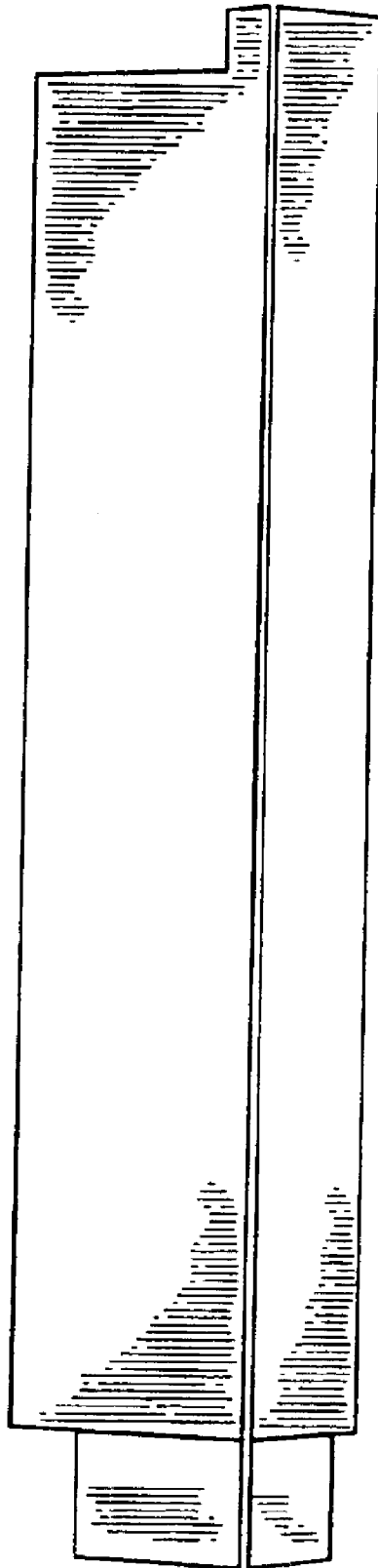

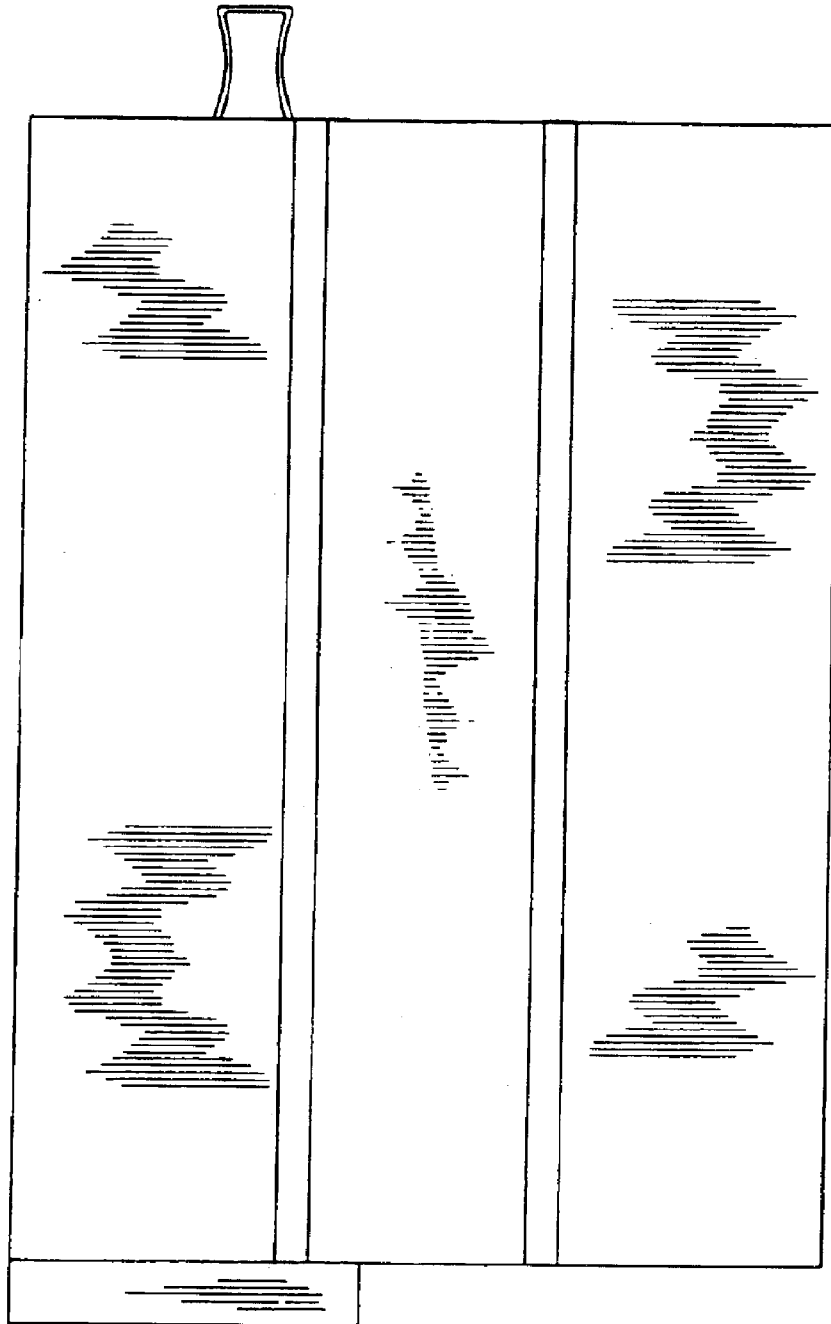

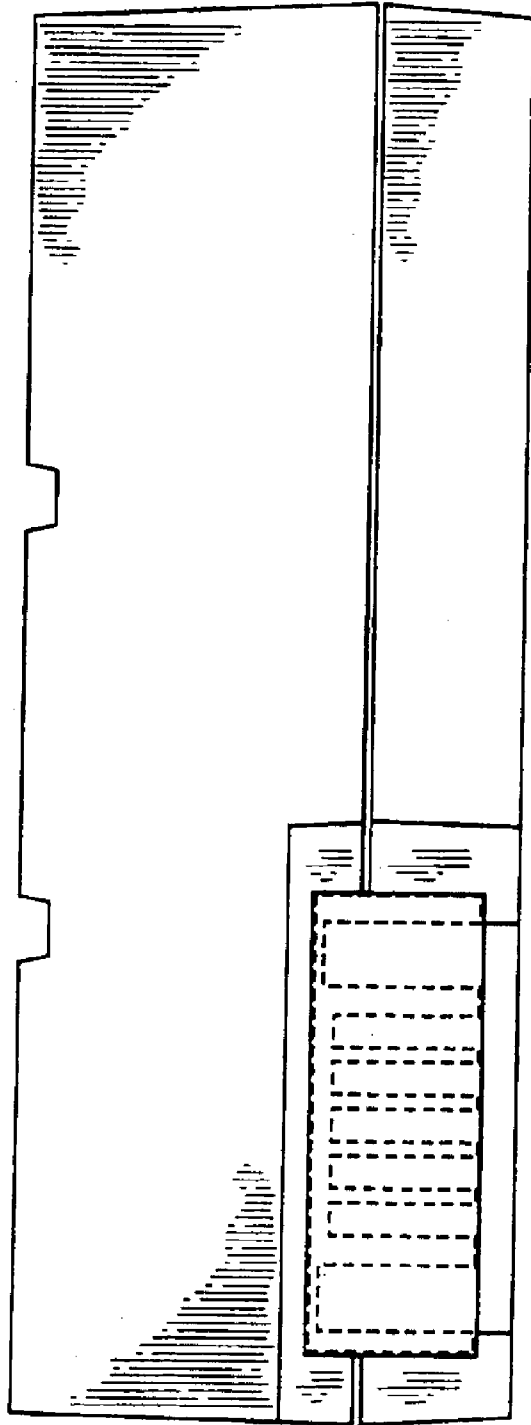

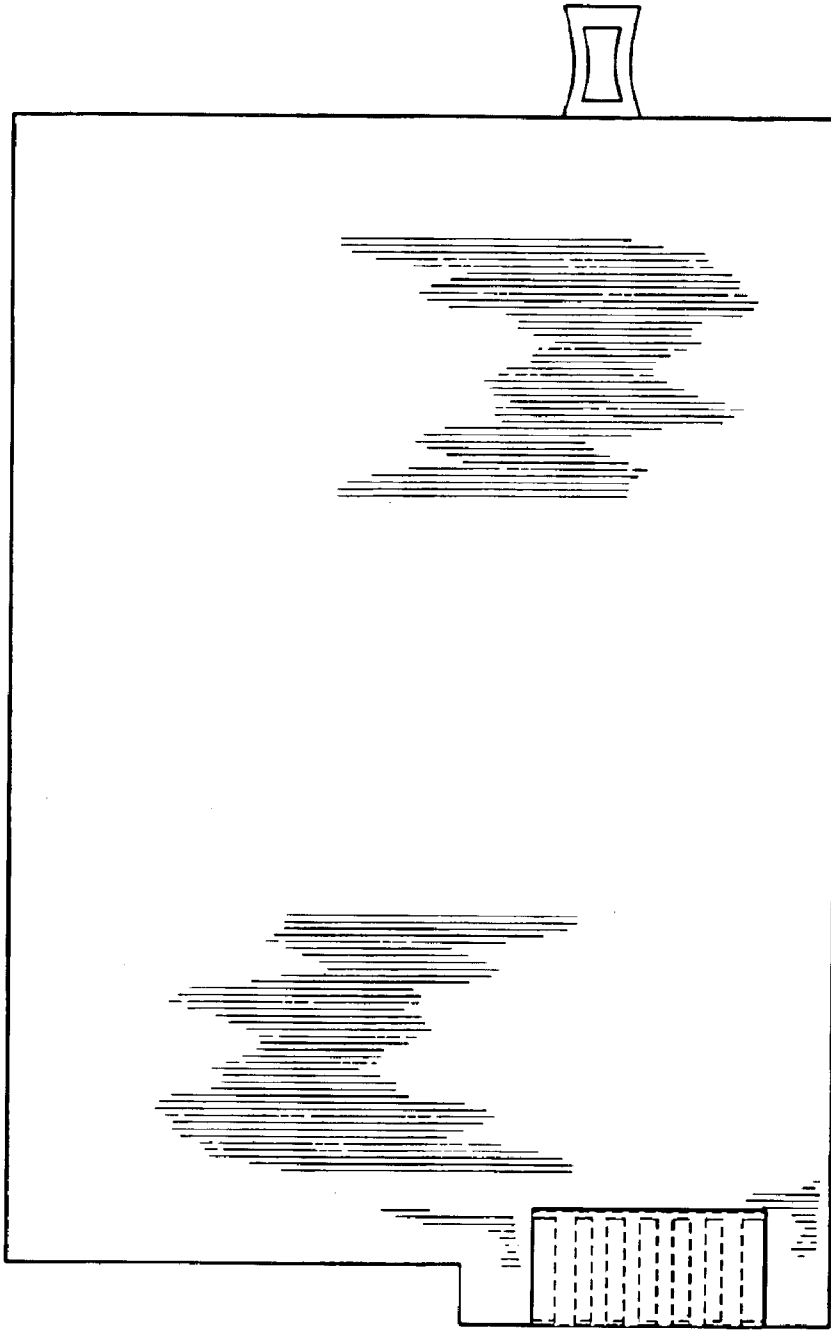

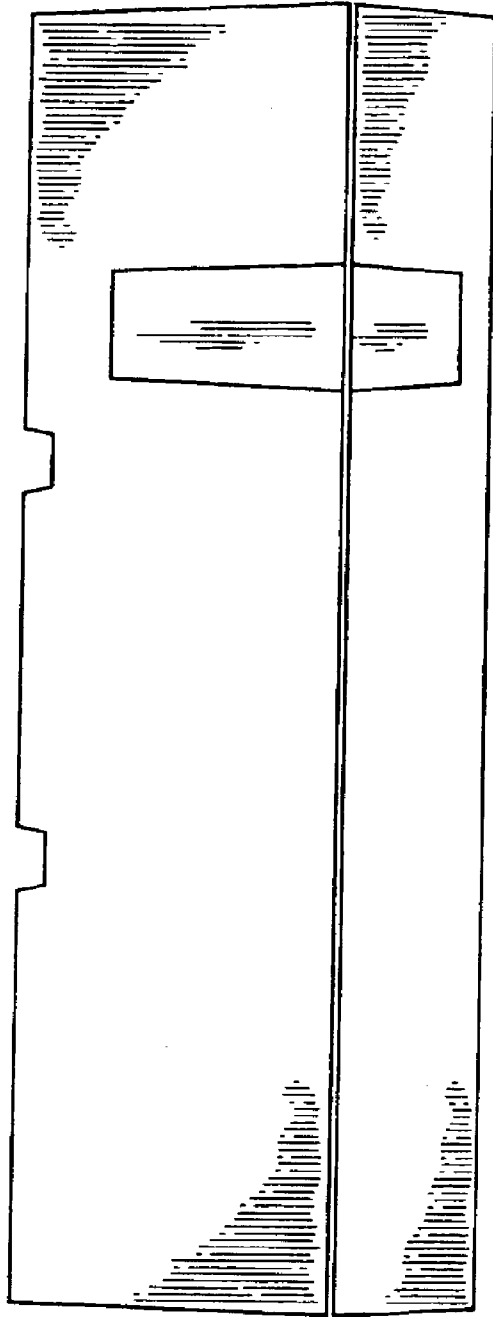
