

(57) **CLAIM**  
The ornamental design for a car body for a rail vehicle, as shown and described.

**DESCRIPTION**

Figure 1.1 is a perspective view of a car body for a rail vehicle showing our new design; Figure 1.2 is a front elevation view thereof; Figure 1.4 is a left side elevation view thereof; Figure 1.5 is a right side elevation view thereof; and Figure 1.6 is a top plan view thereof. The broken lines in the reproductions illustrate portions of the car body for a rail vehicle that form no part of the claimed design.










