DESCRIPTION

FIG. 1 is a top plan view of a disposable diaper with integral disposal bag, showing my new design;

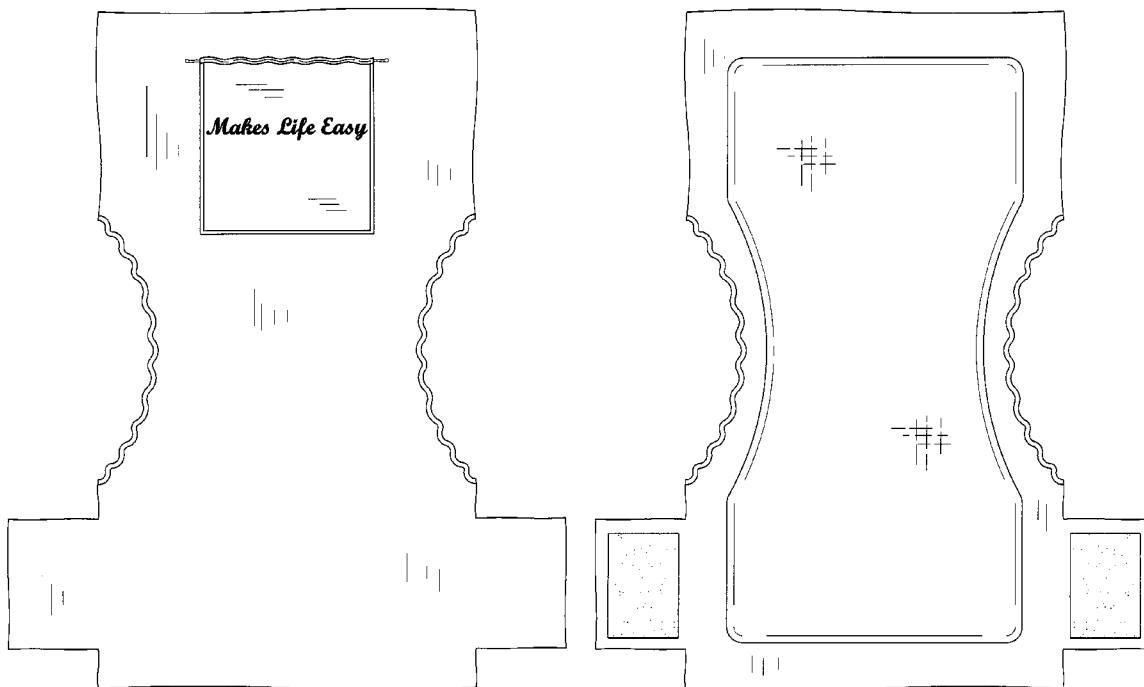
FIG. 2 is a bottom plan view thereof;

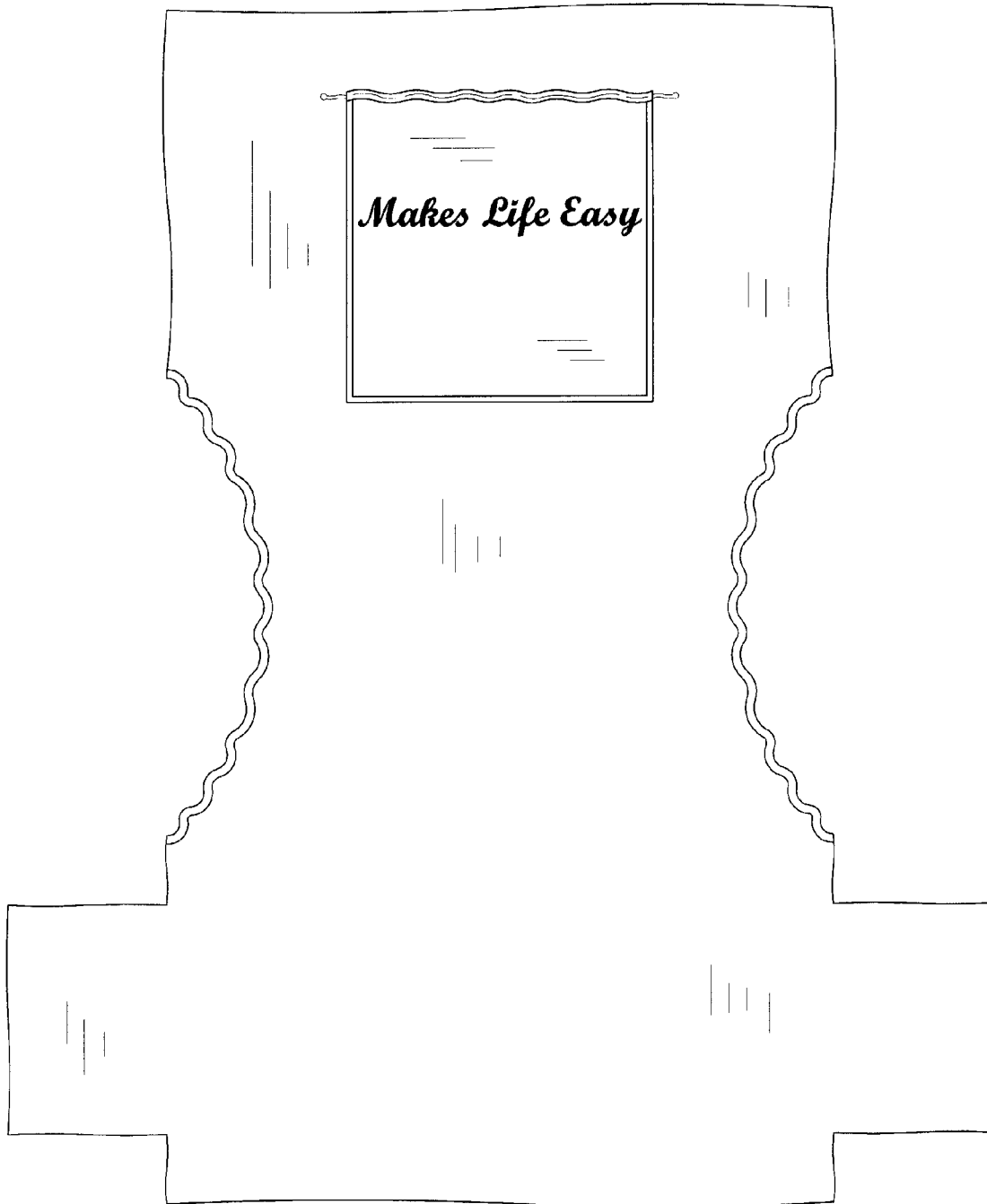

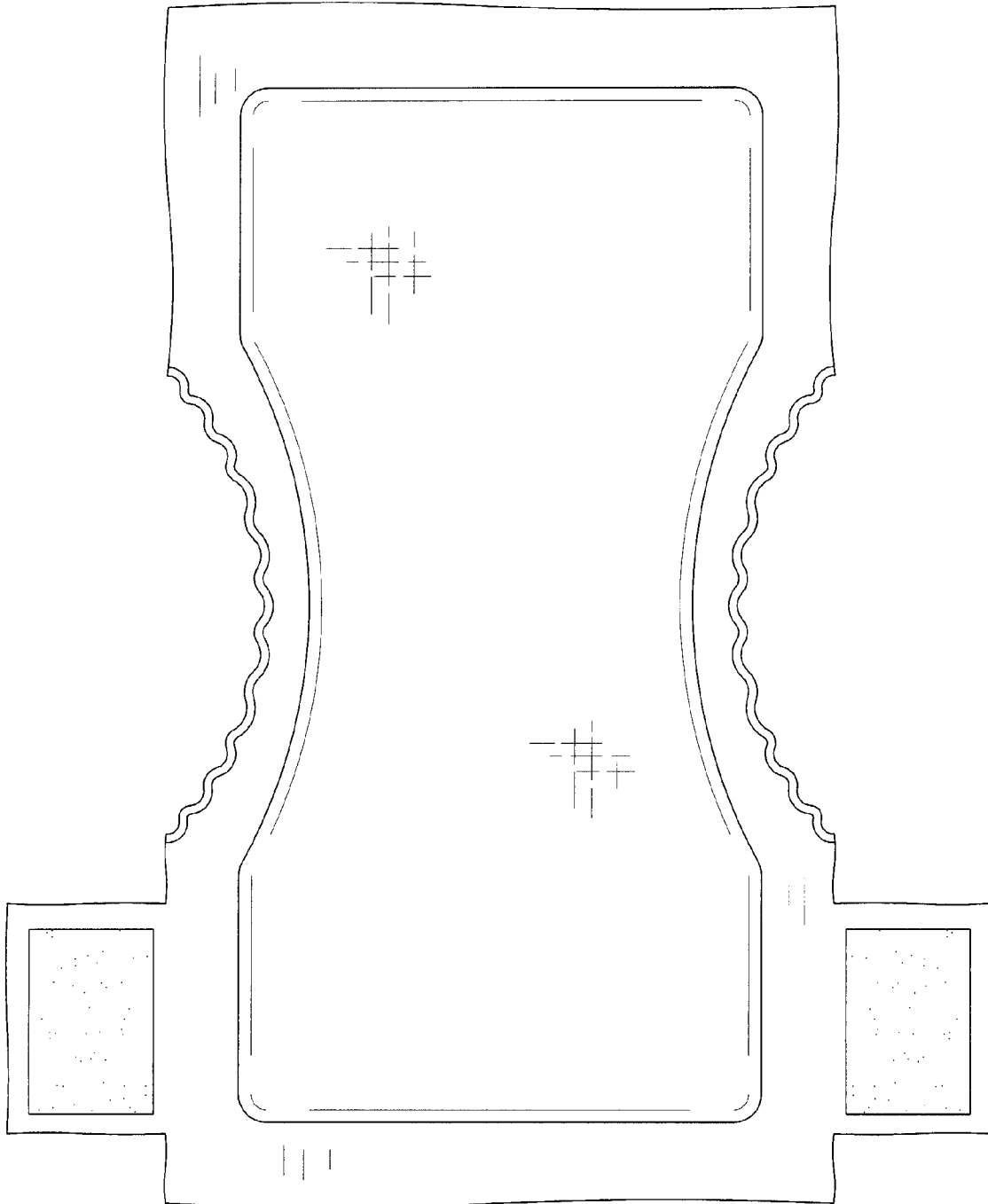

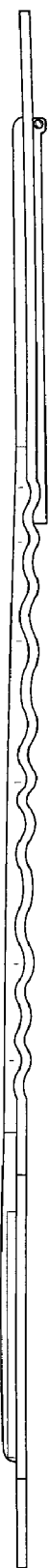

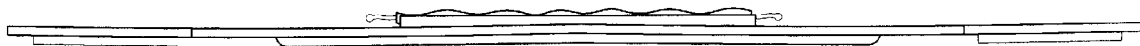
