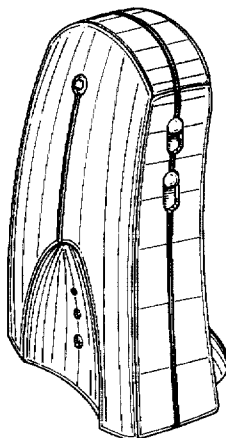
[57] **CLAIM**

The ornamental design for a housing for a nursery monitor, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of a housing for a nursery monitor embodying the principles of the present invention; FIG. 2 is front elevational view of the unit of FIG. 1; FIG. 3 is a side-elevational view of the unit of FIG. 1; FIG. 4 is a rear elevational view of the unit of FIG. 1; FIG. 5 is an elevational view of the other side of the unit of FIG. 1; FIG. 6 is a top plan view of the unit of FIG. 1; and, FIG. 7 is a bottom plan view of the unit of FIG. 1.

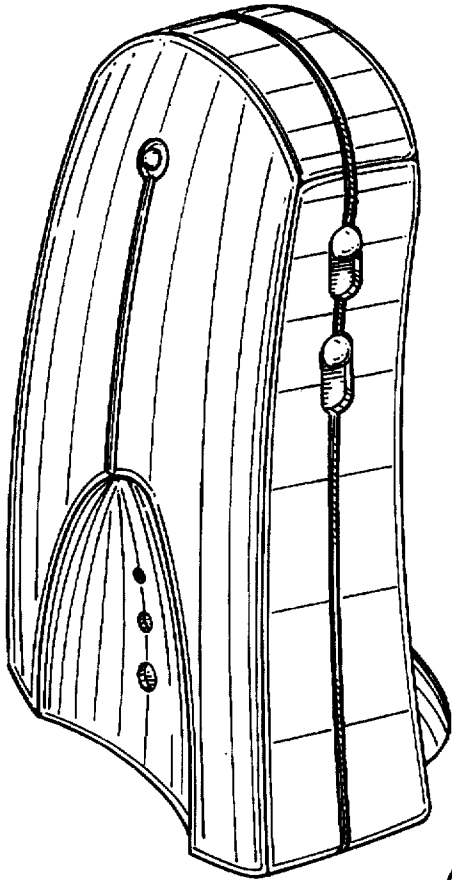

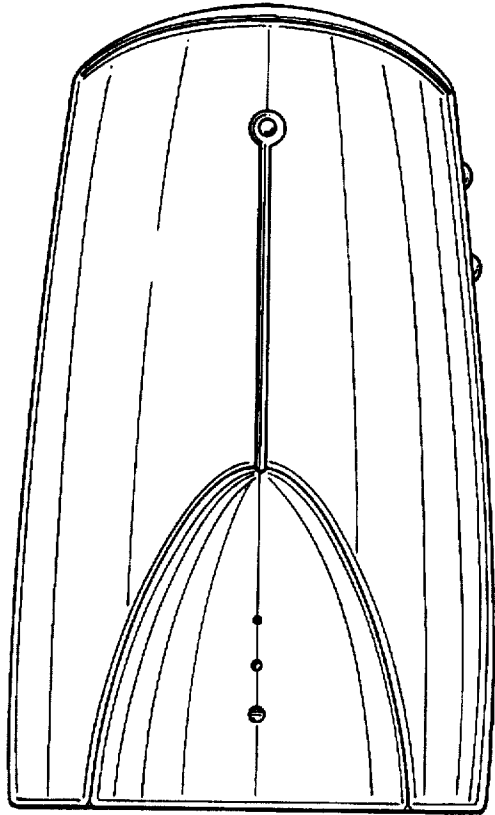

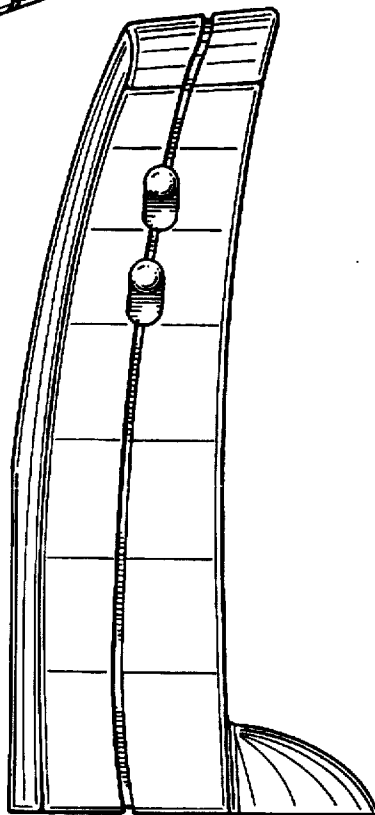

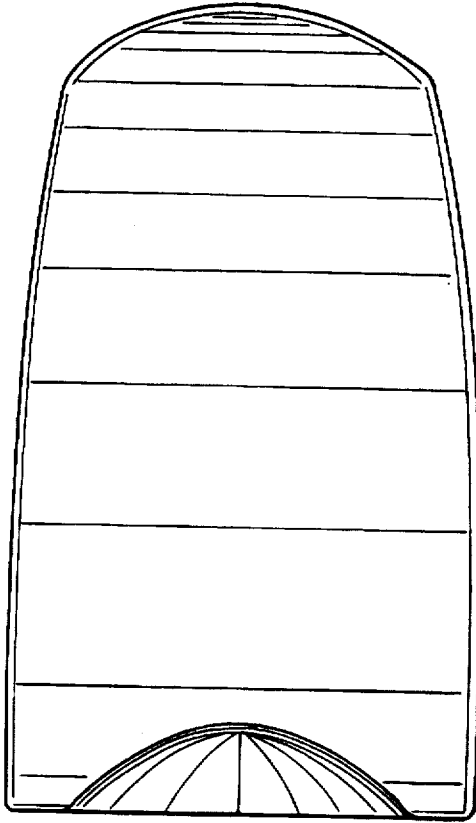

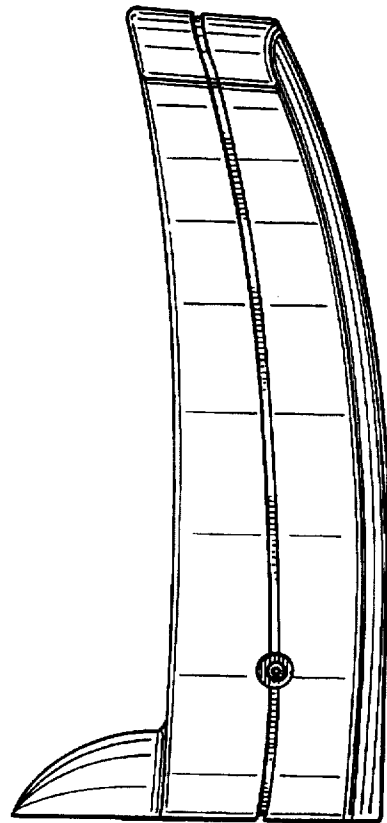

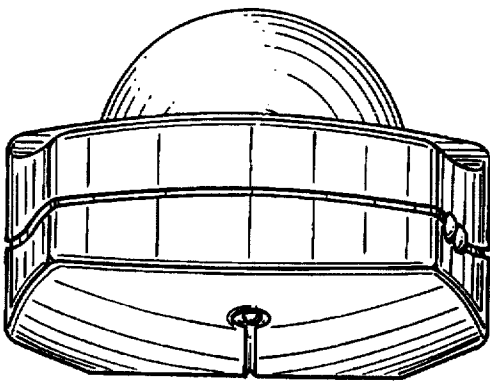
