The ornamental design for a dishwasher door control panel, as shown and described.


**DESCRIPTION**

FIG. 1 is a partial front perspective view thereof taken from the bottom;  
 FIG. 2 is a front view of a dishwasher door control panel according to our new ornamental design;  
 FIG. 2A is an enlarged detail view of FIG. 2;  
 FIG. 3 is a perspective view thereof; and,  
 FIG. 4 is an enlarged cross section taken along lines 4-4 of FIG. 2.

The broken lines of the dishwasher, dishwasher compartment and/or components thereof show surrounding structure or environment and do not form part of the claimed design. Where included, the dotted lines represent the border between claimed and unclaimed subject matter and do not form a part of the claimed design.

The bottom and rear parts of the dishwasher door, and the bottom, rear and top of the dishwasher compartment are unornamented and form no part of the claimed design.








