The broken lines depict portions of the light fixture that form no part of the claimed design.

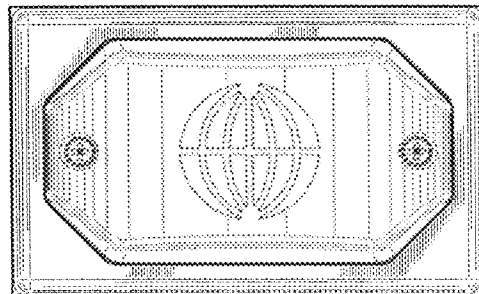
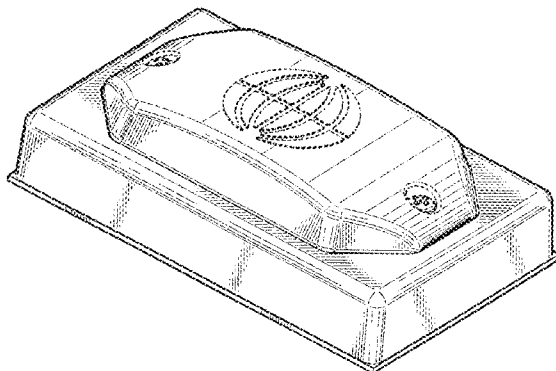

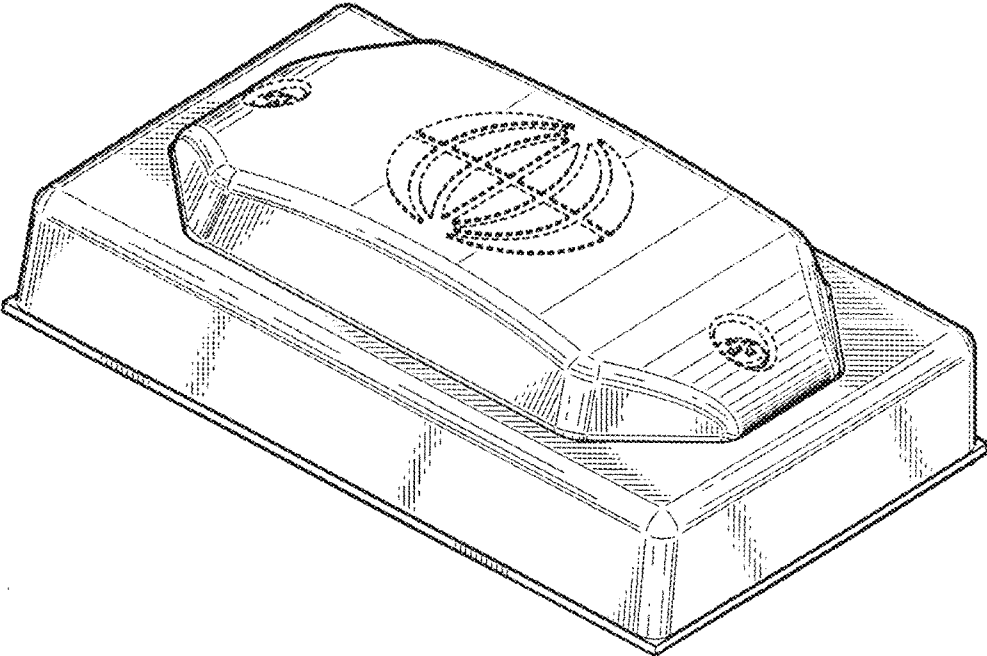

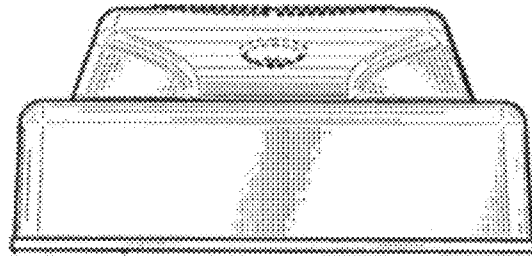

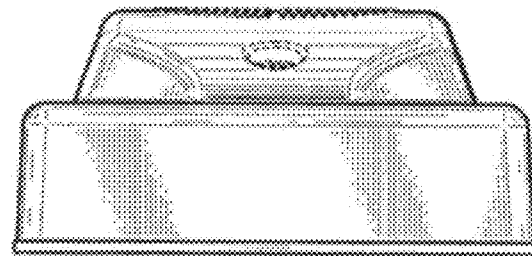

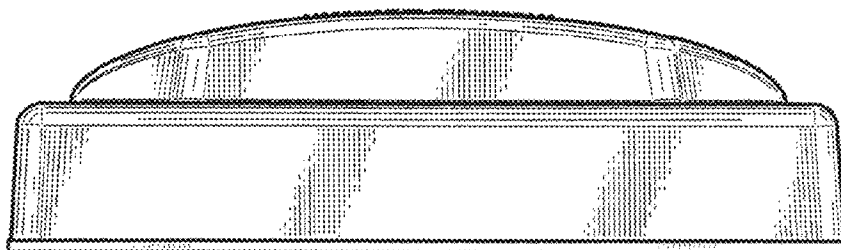

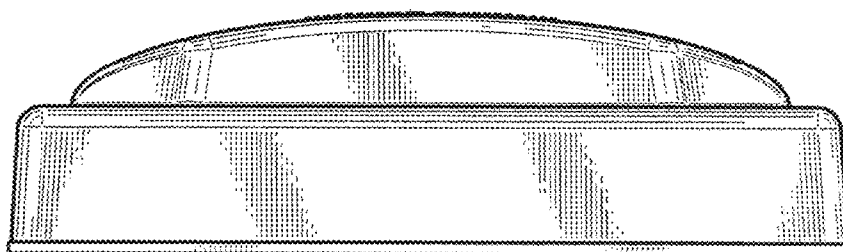

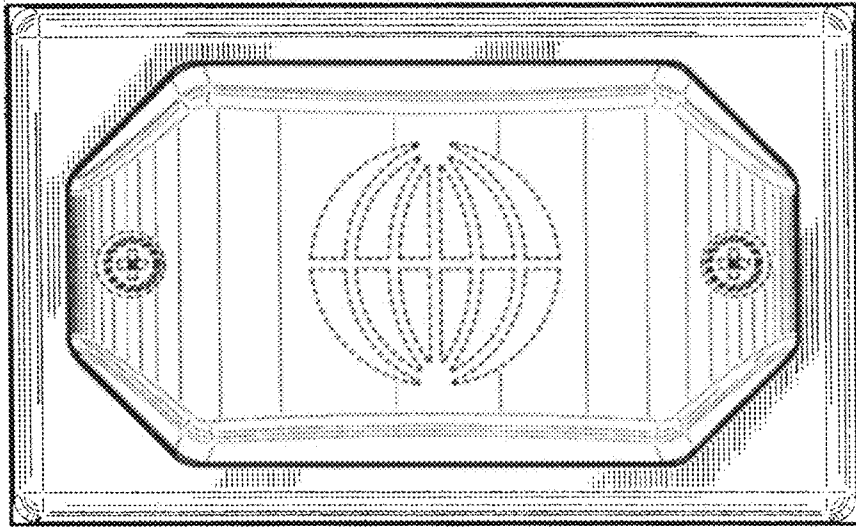

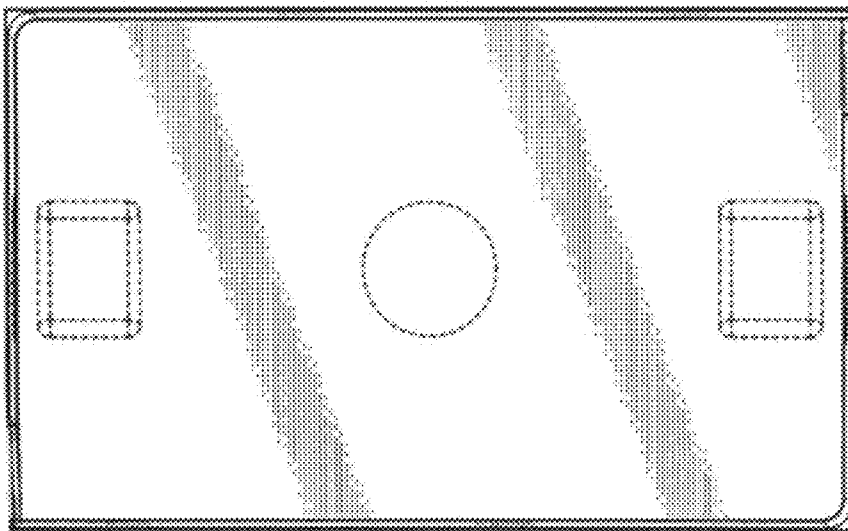
