(57) **CLAIM**  
The ornamental design for a chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a chair.  
FIG. 2 is a front elevation view thereof.  
FIG. 3 is a rear elevation view thereof.  
FIG. 4 is a right side elevation view thereof. A left side elevation view is a mirror image of the right side elevation view.  
FIG. 5 is a top plan view thereof.  
FIG. 6 is a bottom plan view thereof.  
FIG. 7 is a cross-sectional view taken along the line 7-7 in FIG. 2, which omits the internal structure; and,  
FIG. 8 is cross-sectional view taken along the line 8-8 in FIG. 4, which omits the internal structure.  
The portions of the chair shown in broken lines are for the purpose of showing environmental structure only and form no part of the claimed design.
















