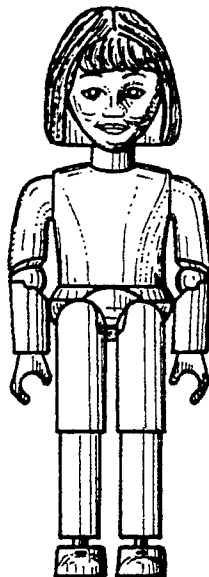

**DESCRIPTION**

FIG. 1 is a top perspective view of girl doll showing our new design;  
FIG. 2 is a bottom perspective view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right side elevational view thereof;

FIG. 9 is a top perspective view in an alternative position.



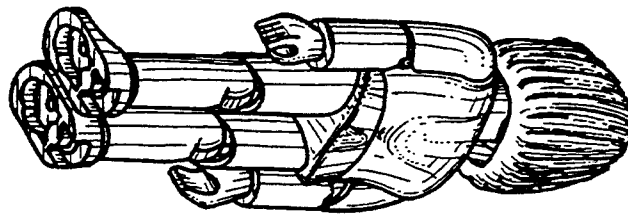

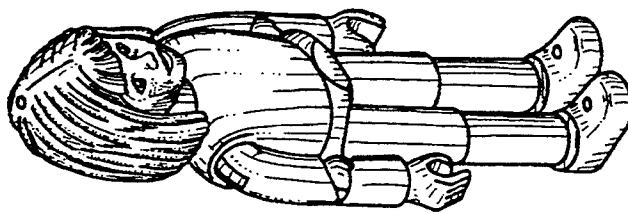

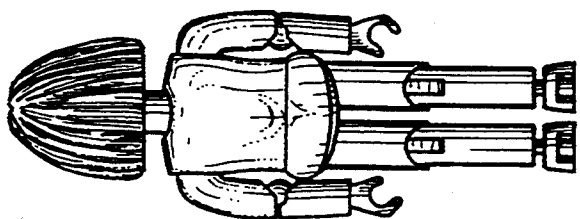

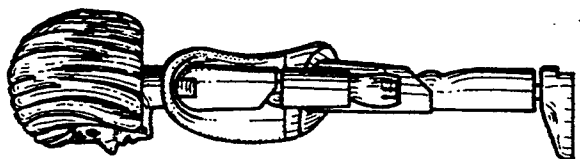

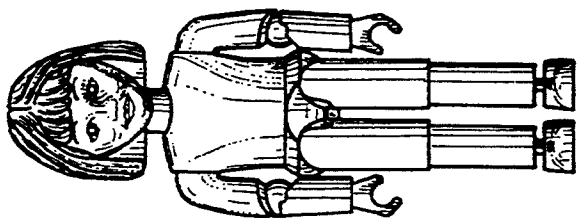

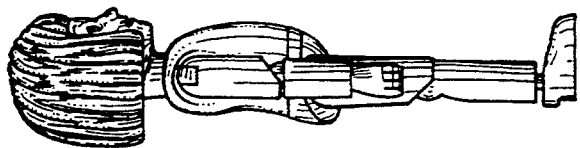

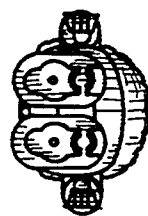

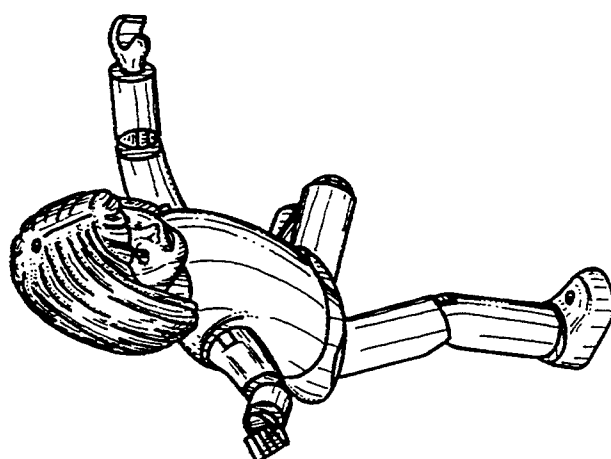
