FIG. 3 is a rear view of the privacy/security enclosure of FIG. 1;

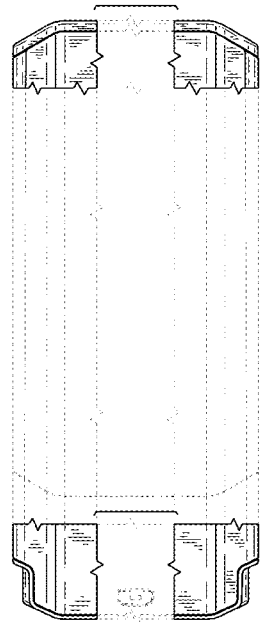
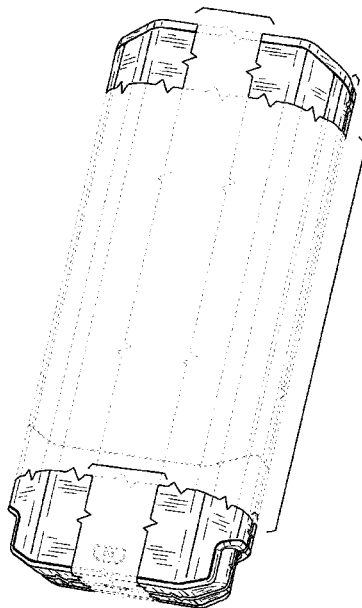
FIG. 4 is a side view of the privacy/security enclosure of FIG. 1;

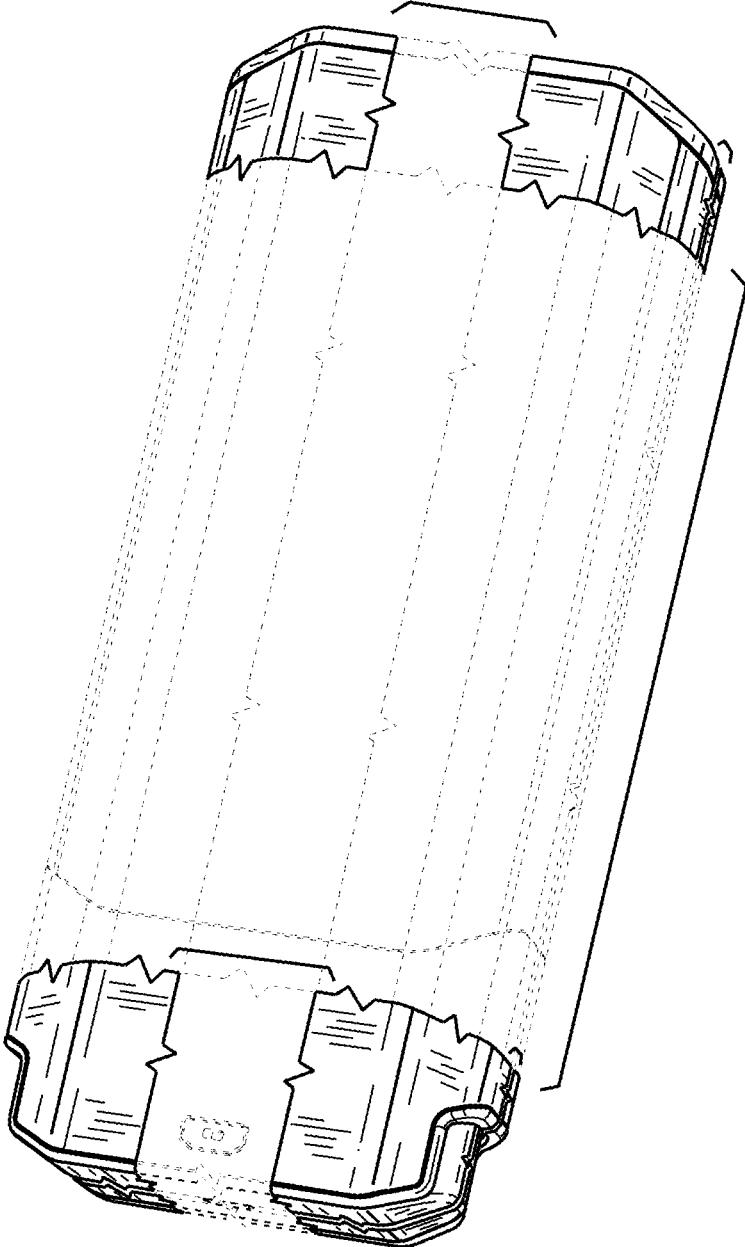

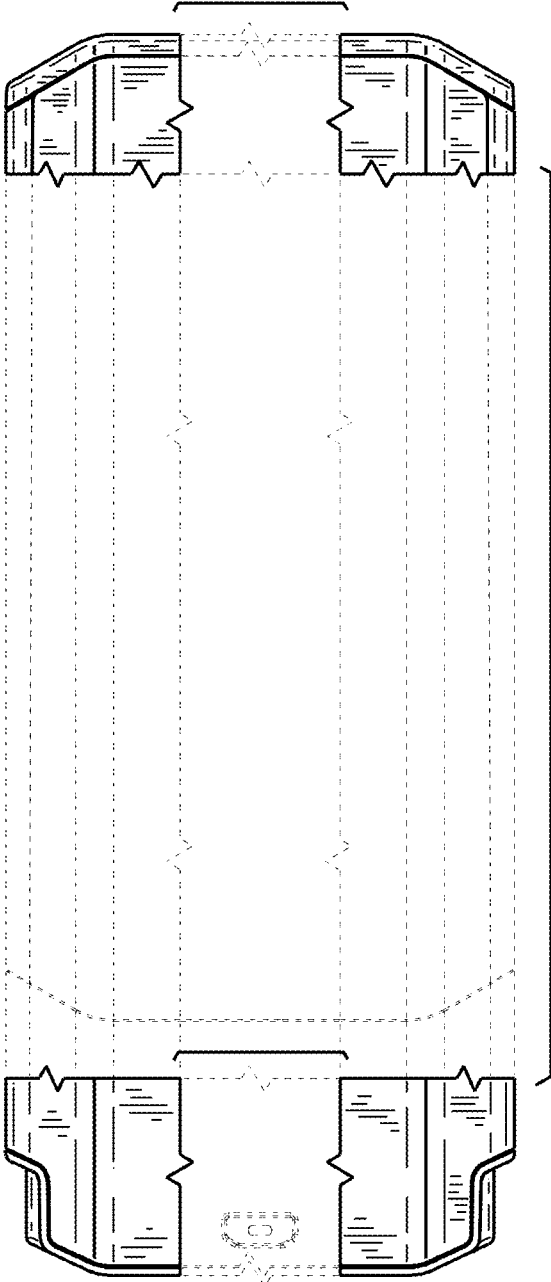

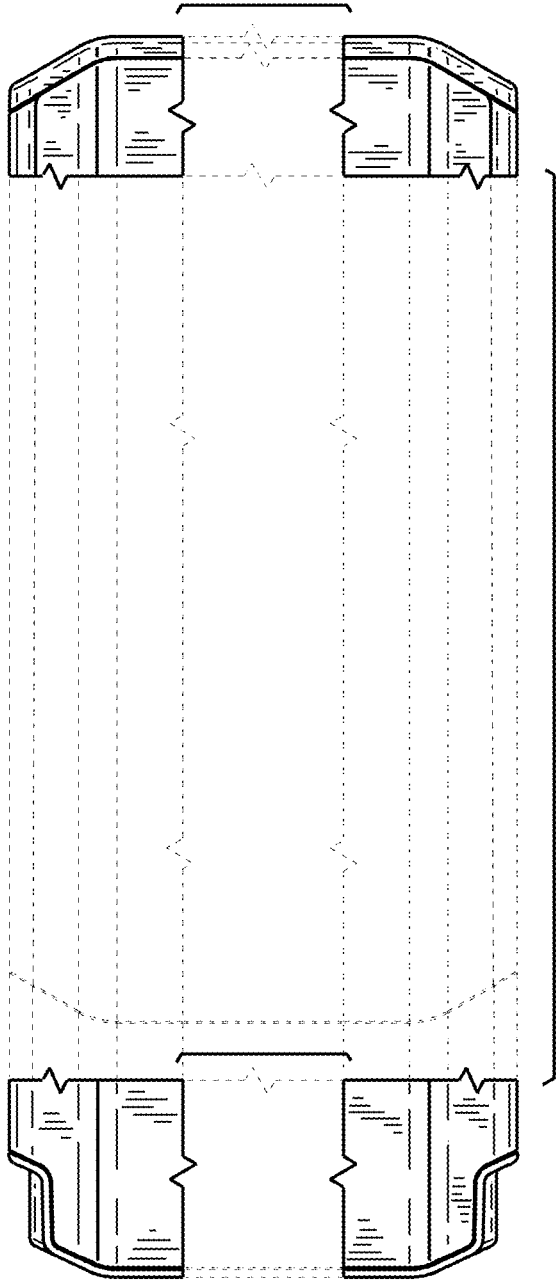

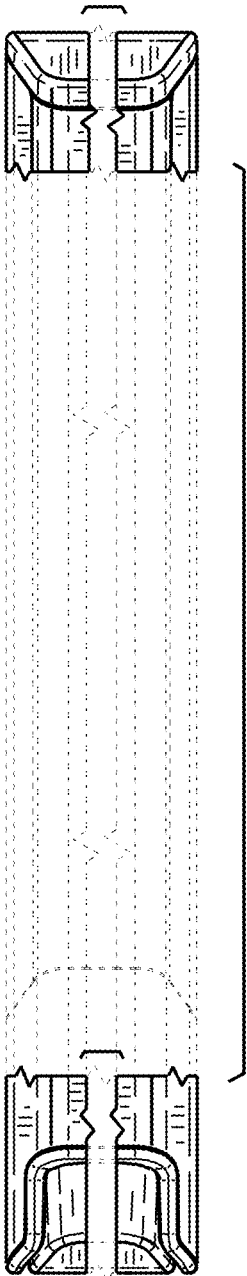

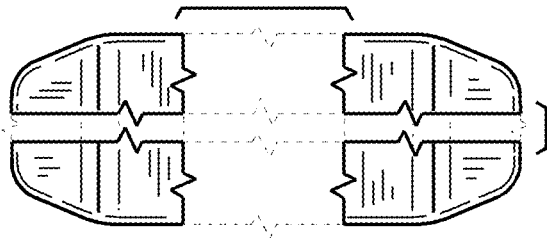

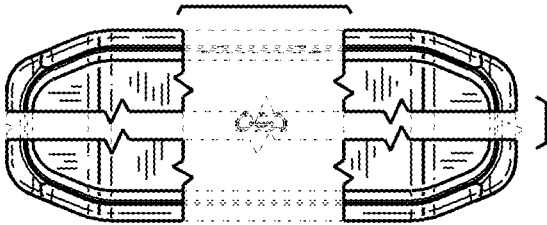
