
(57) **CLAIM**

The ornamental design for a plastic container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the plastic container showing our new design as seen from the top, front; FIG. 2 is a rear elevational view thereof; FIG. 3 is a side elevational view thereof; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof. The broken lines in the drawings are for environmental purposes only and form no part of the claimed design.










