FIG. 1 is a top perspective end view of a metal panel showing our new design;

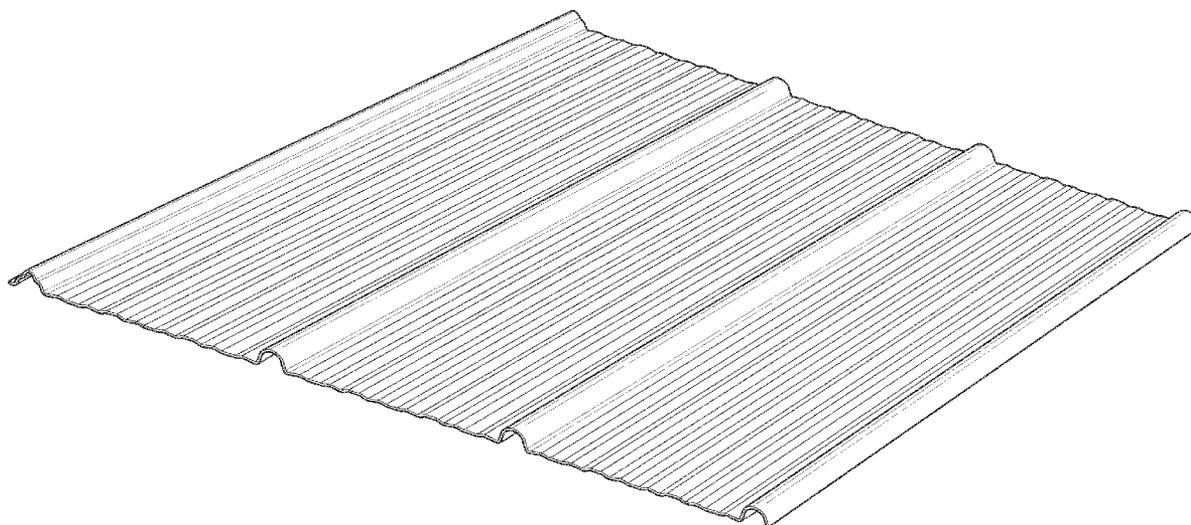
FIG. 2 is a bottom perspective end view thereof;

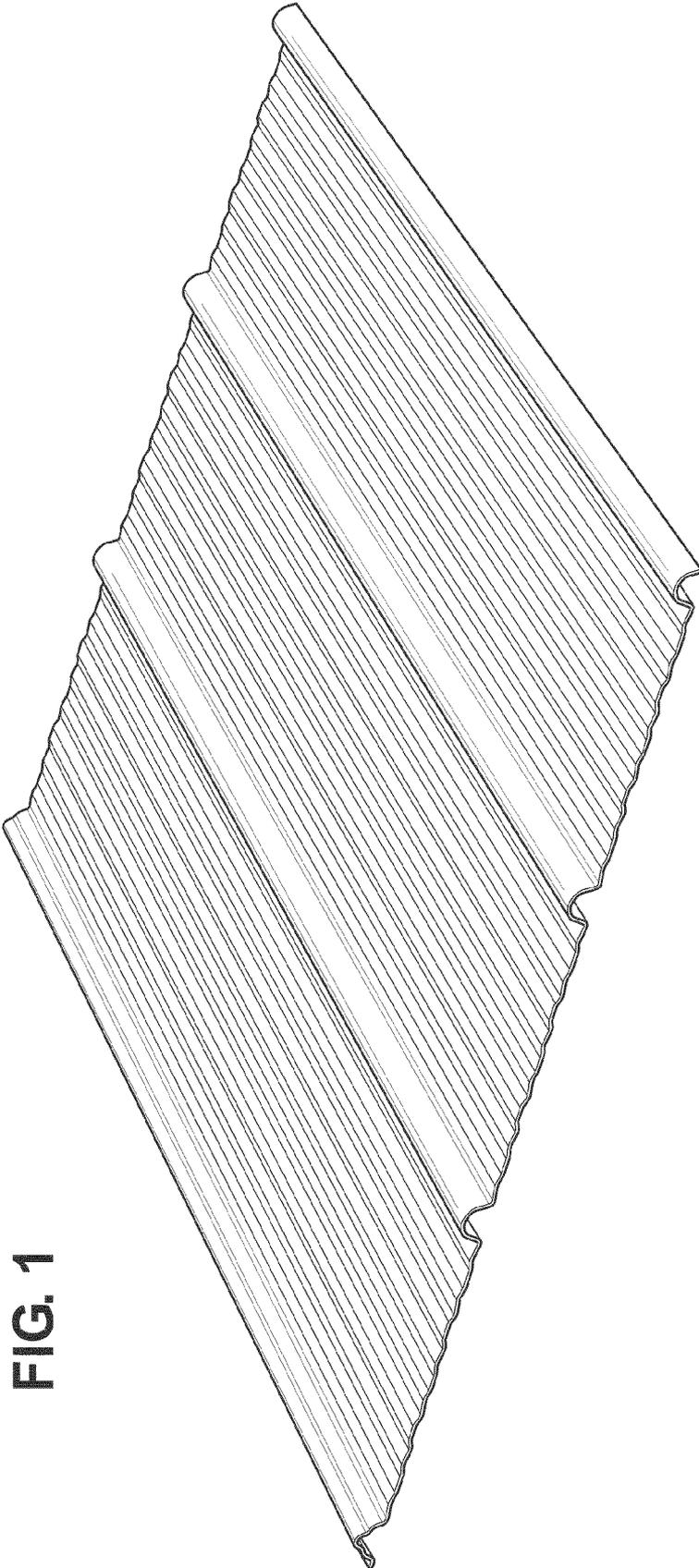

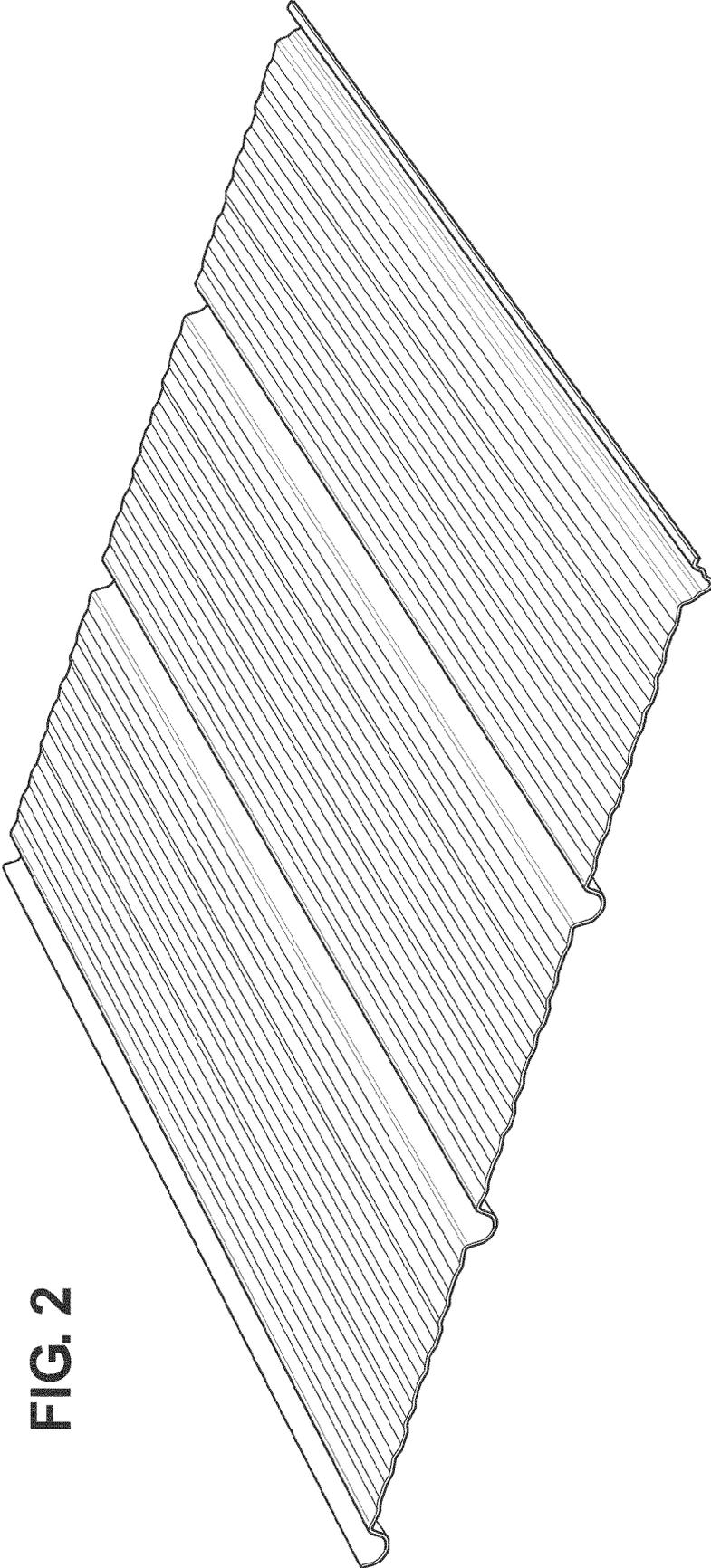
