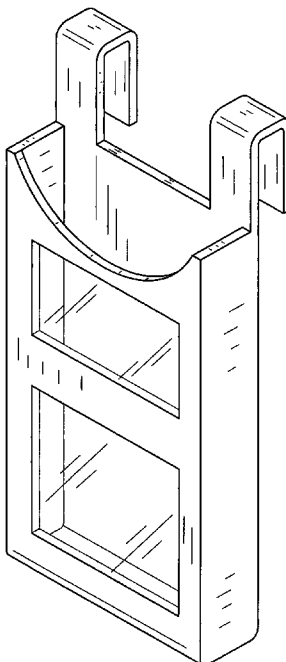
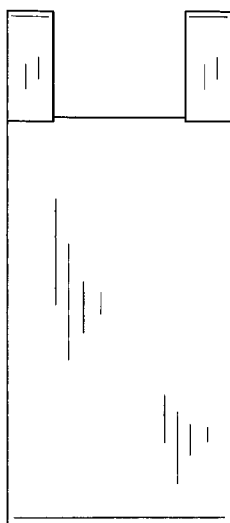
(57) **CLAIM**

The ornamental design for a motor vehicle cell phone holder, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the motor vehicle cell phone holder. FIG. 2 is a rear view of the motor vehicle cell phone holder. FIG. 3 is a side view of the motor vehicle cell phone holder. FIG. 4 is top view of the motor vehicle cell phone holder. FIG. 5 is a bottom view of the motor vehicle cell phone holder; and, FIG. 6 is a perspective of the motor vehicle cell phone holder.

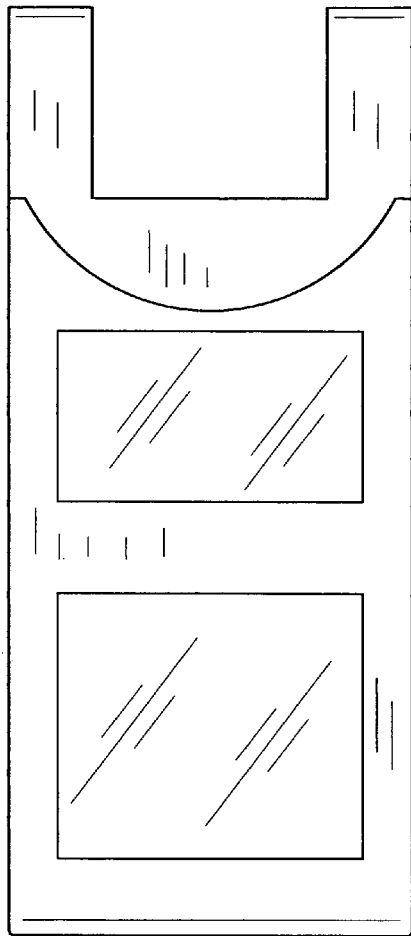

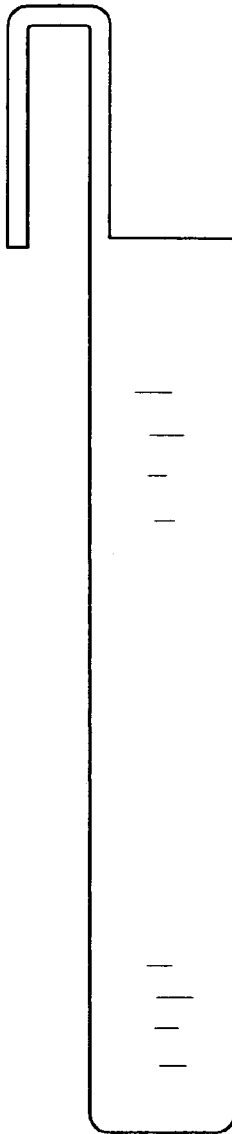

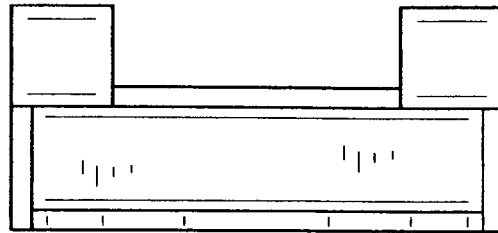

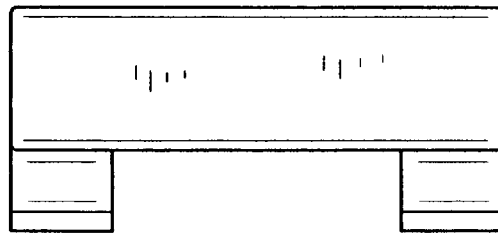

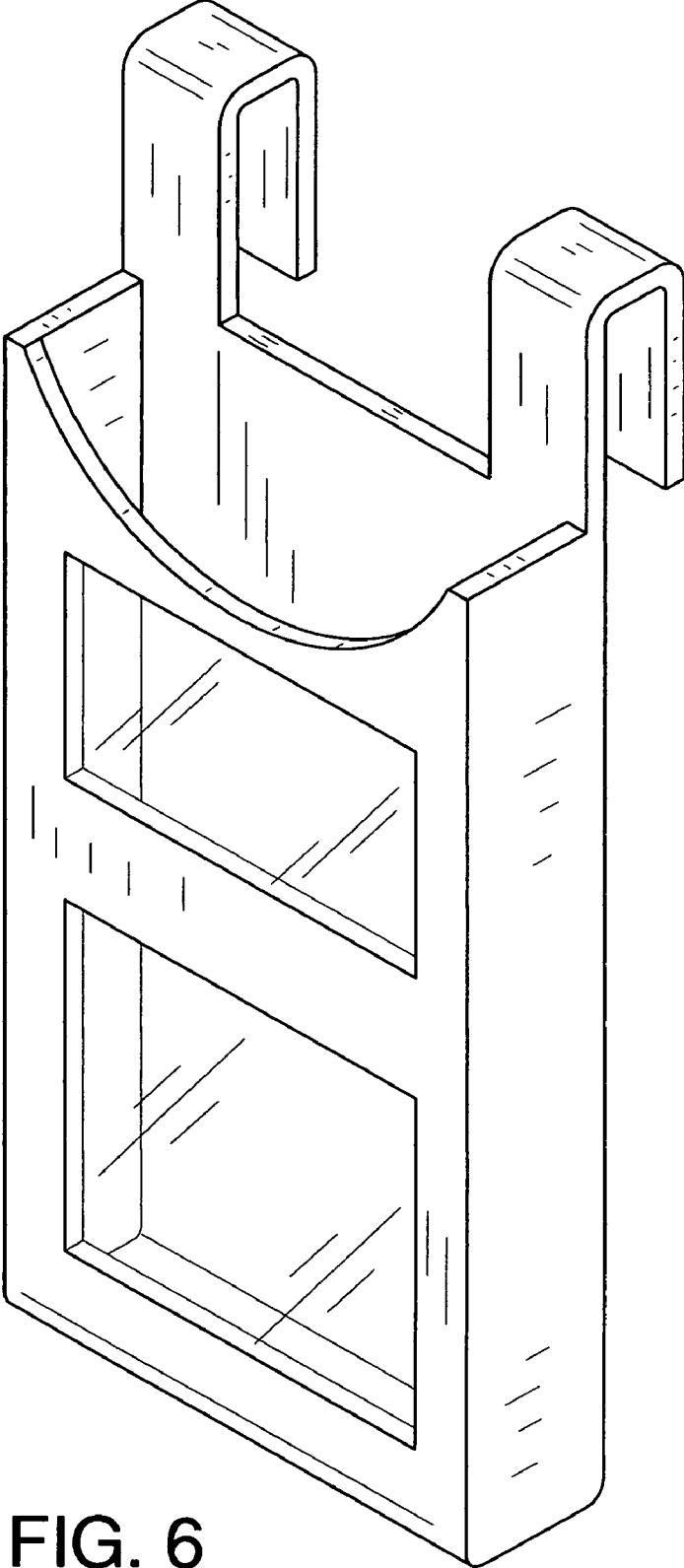
