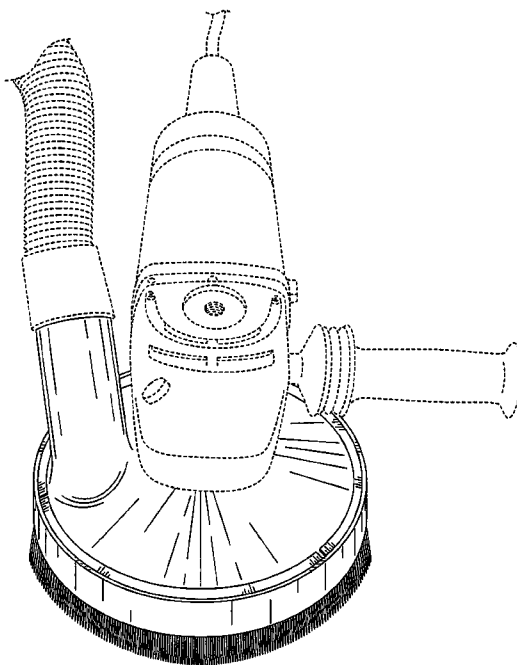
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the present invention; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines shown in the drawings illustrate environmental structure for the grinder attachment that forms no part of the claimed design.

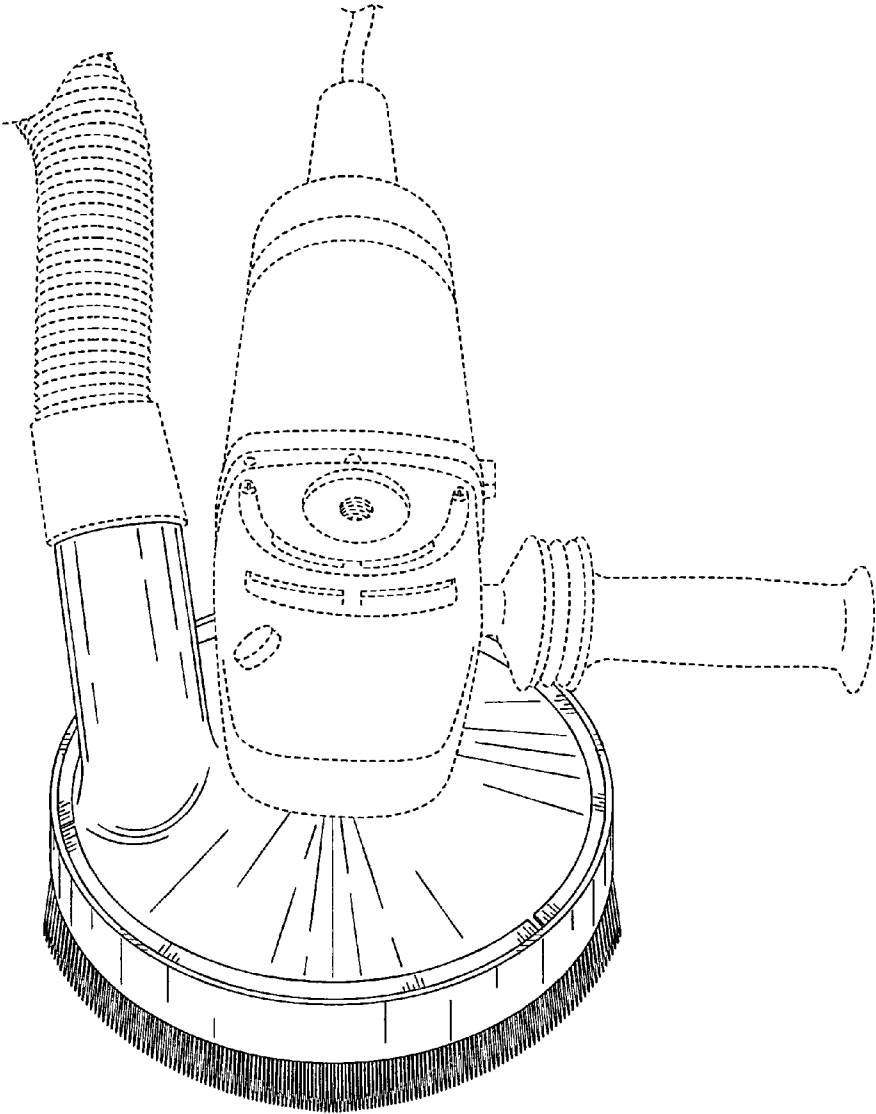

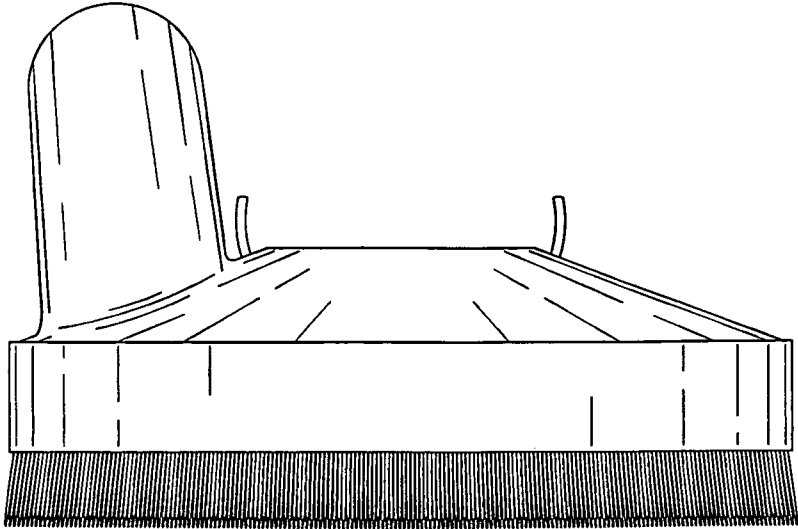

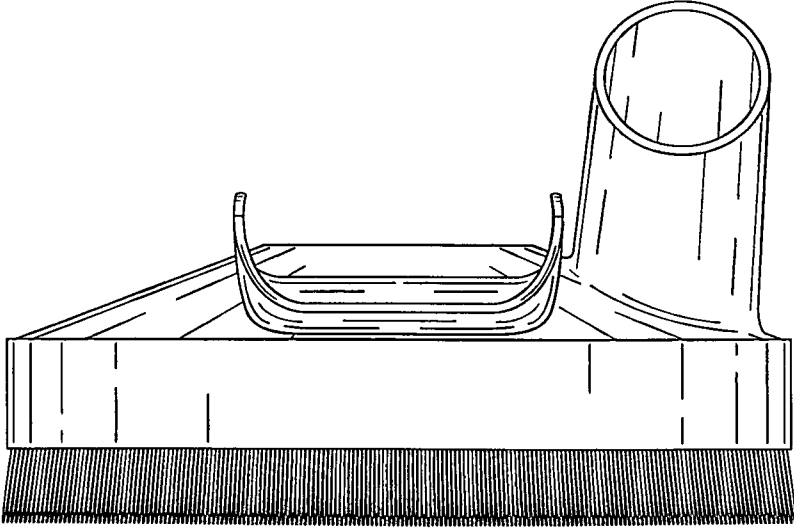

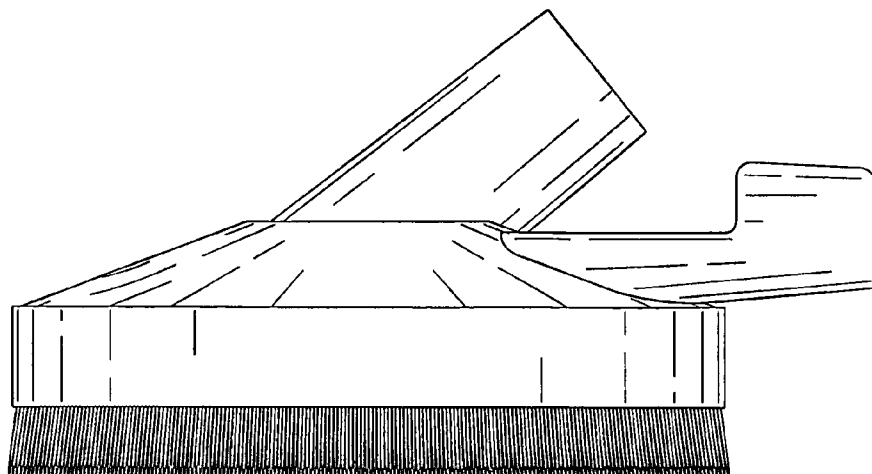

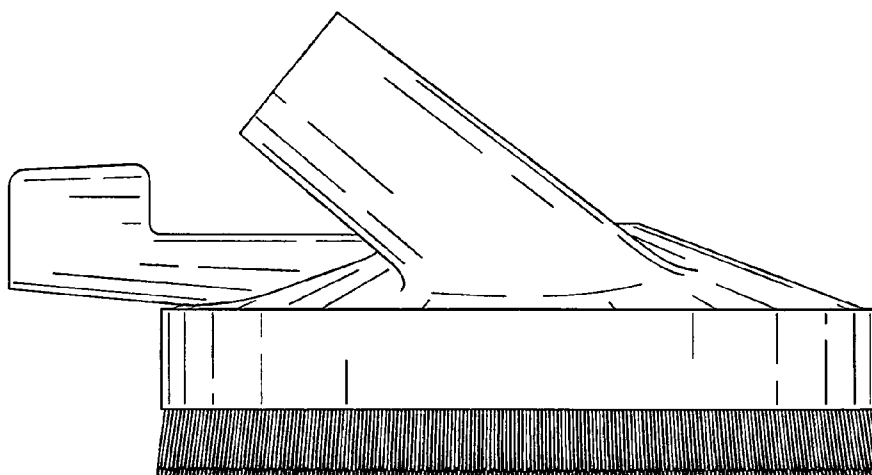

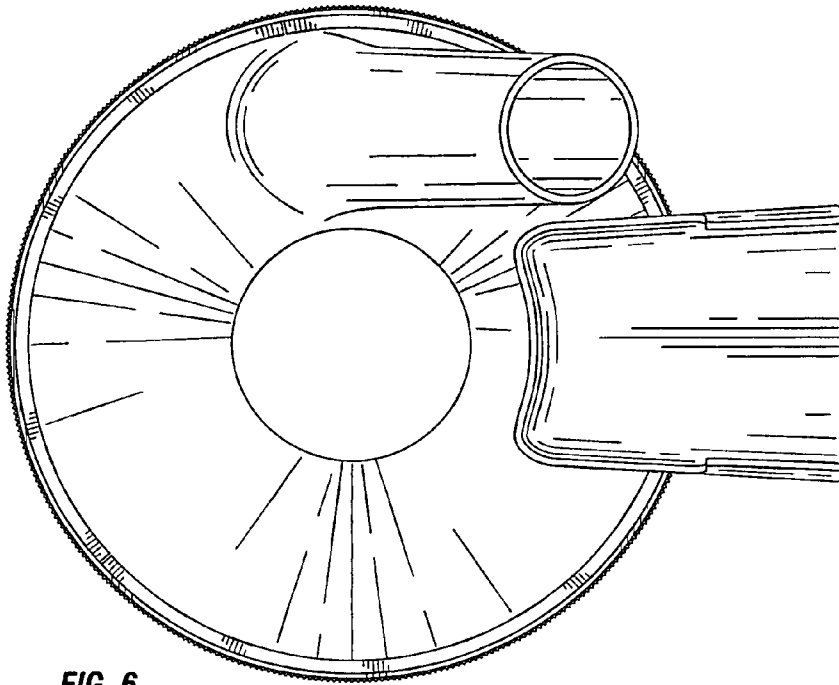

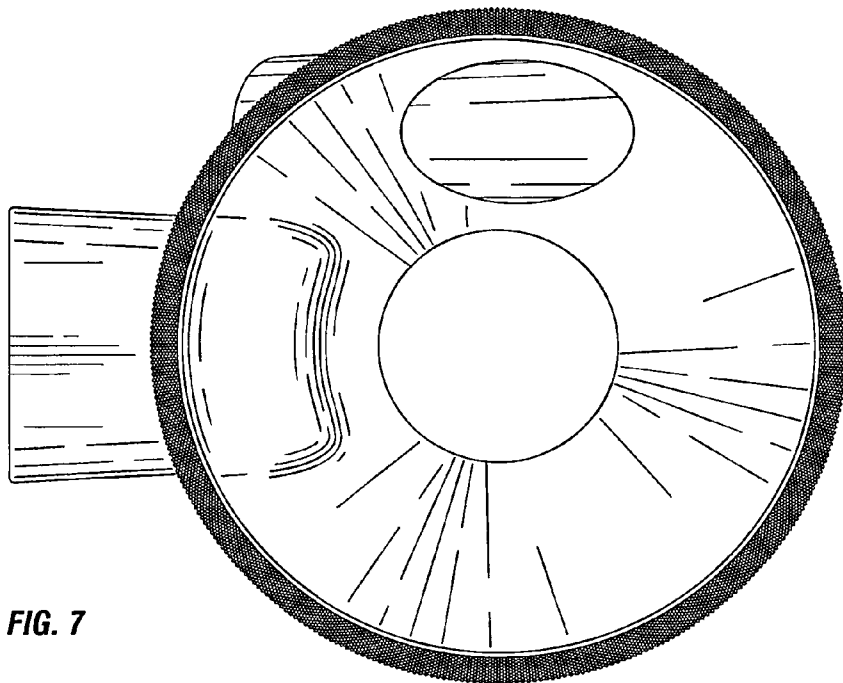
