The ornamental design for the storage belt carrier, as shown and described.

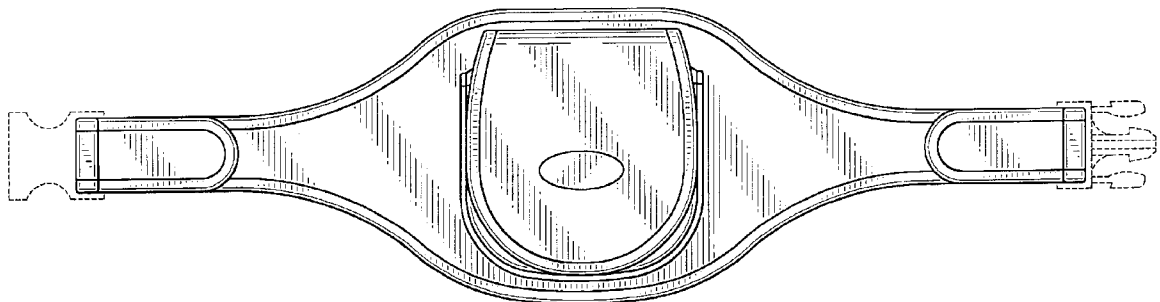
DESCRIPTION

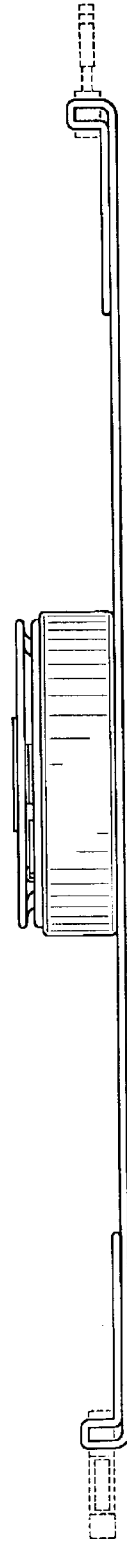
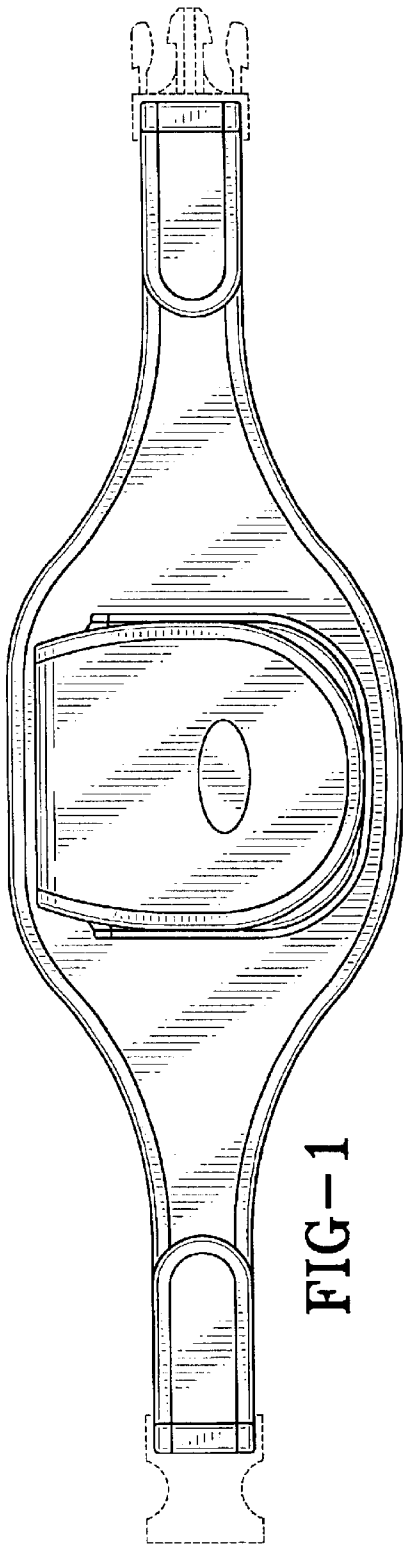
FIG. 1 is a front elevational view of the storage belt carrier showing my new design;

FIG. 10 is a rear elevational view of FIG. 7;
FIG. 11 is a front elevational view of a second embodiment of the storage belt carrier;

FIG. 13 is a front elevational view similar to FIG. 11, with the closure flap being shown in an open position; and,
FIG. 14 is a top plan view of FIG. 13.

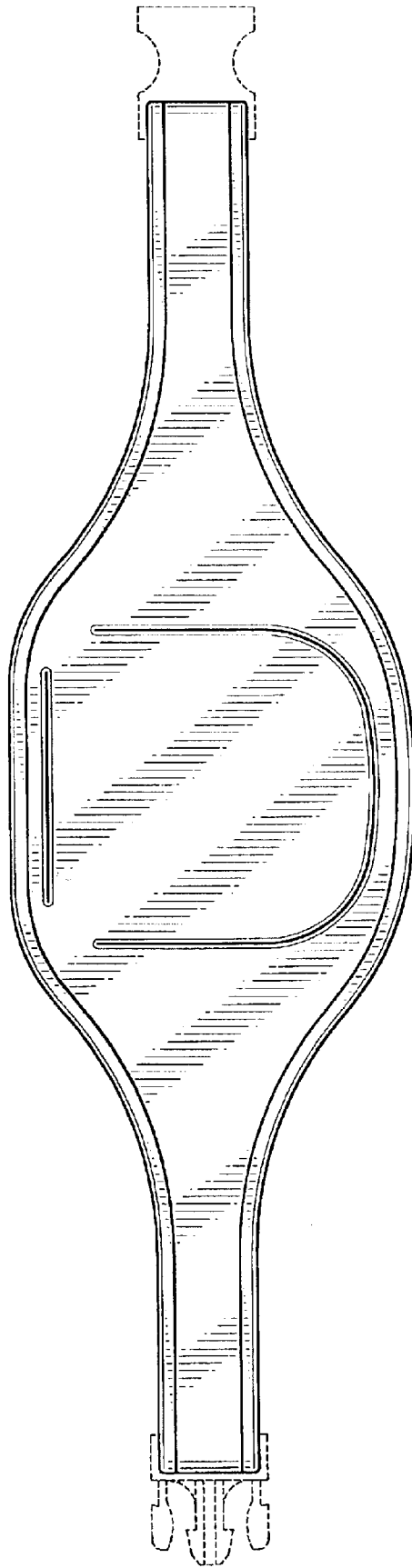

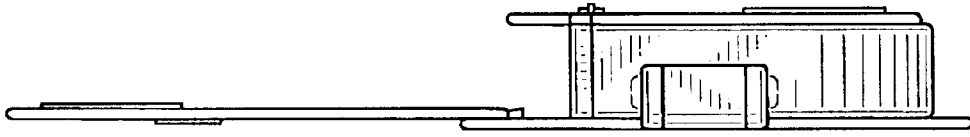

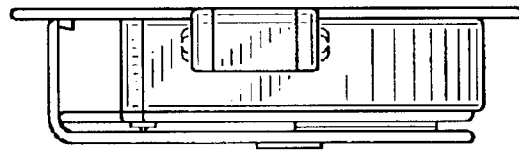

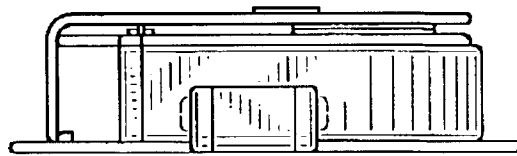
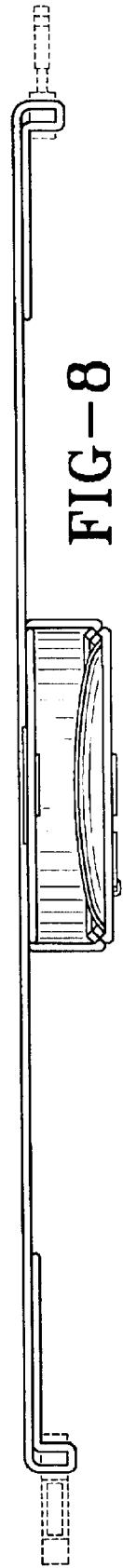
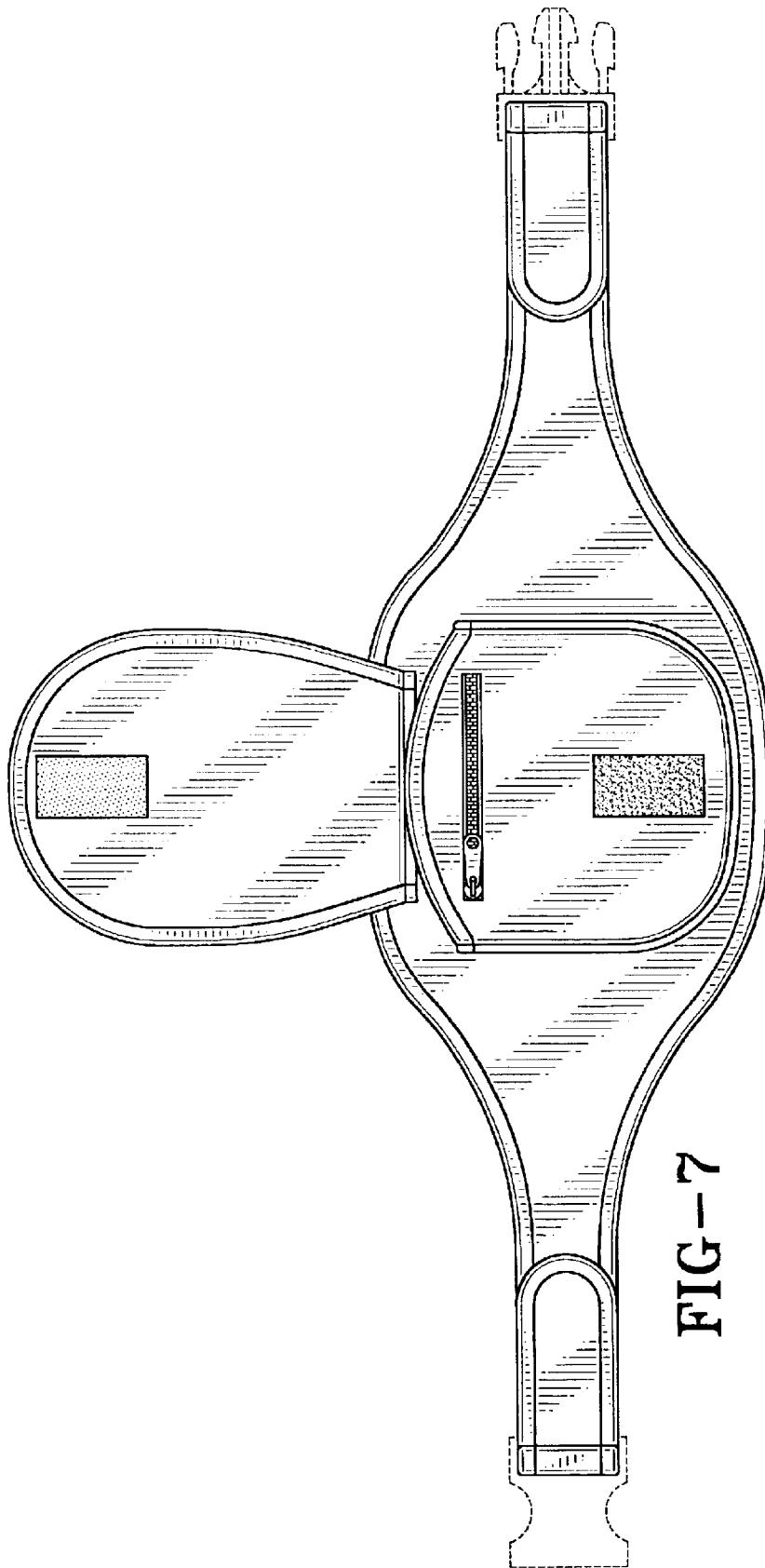

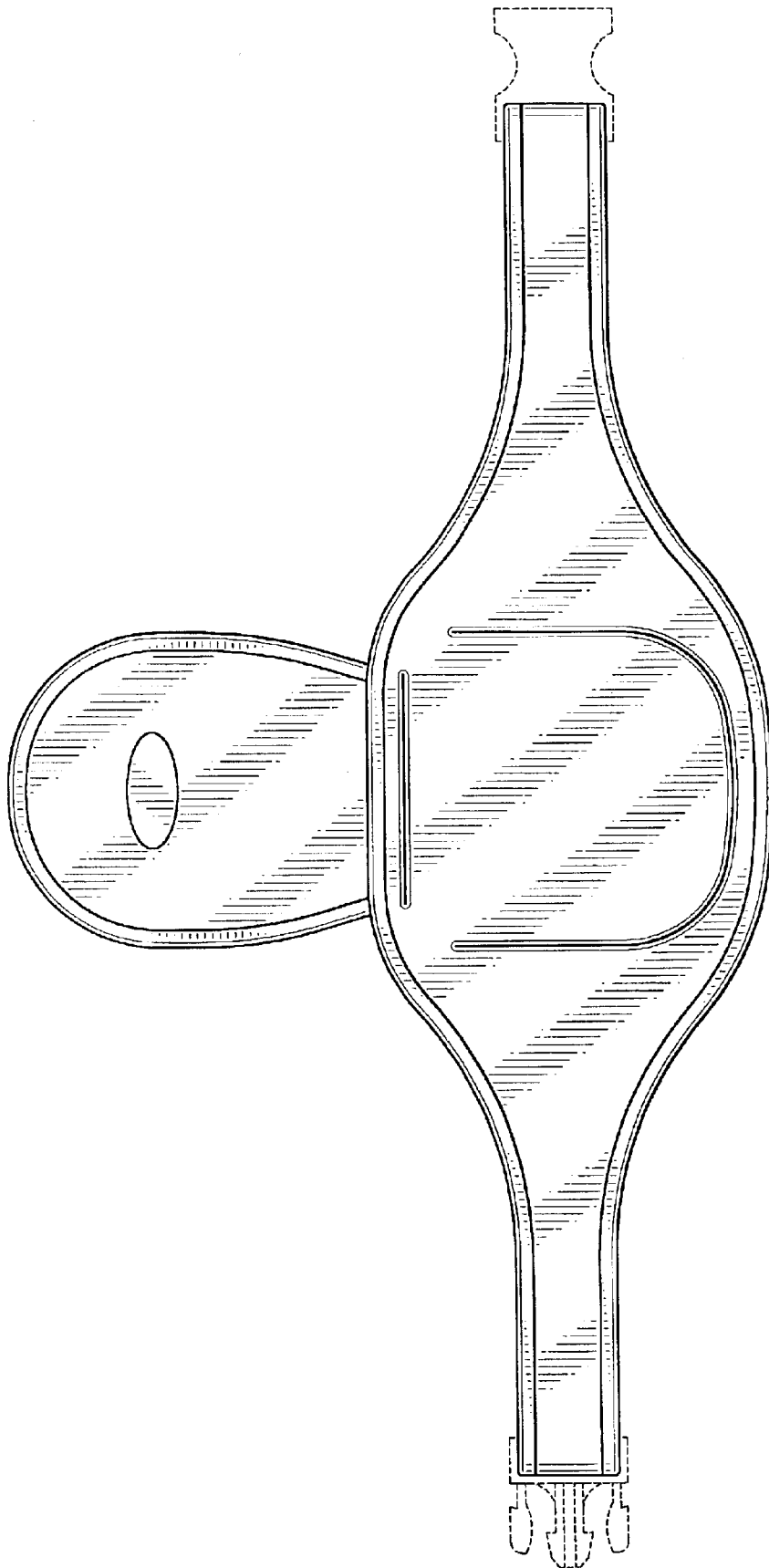

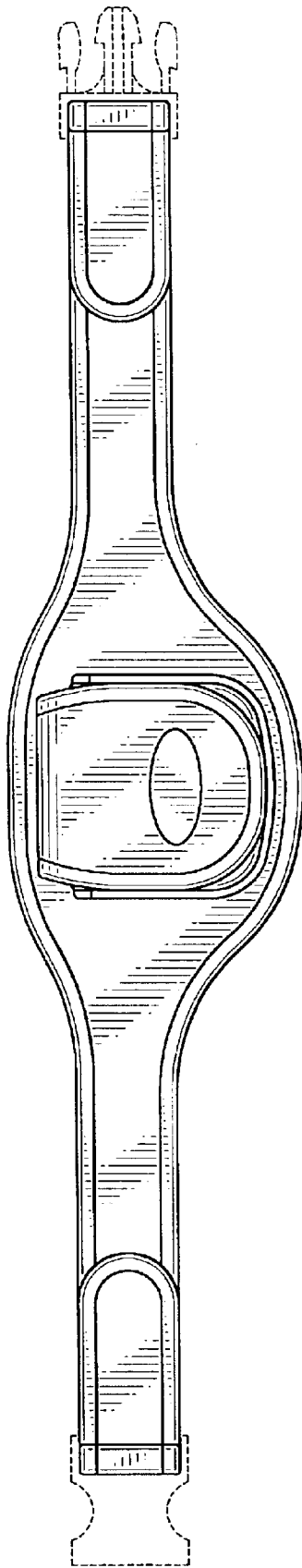

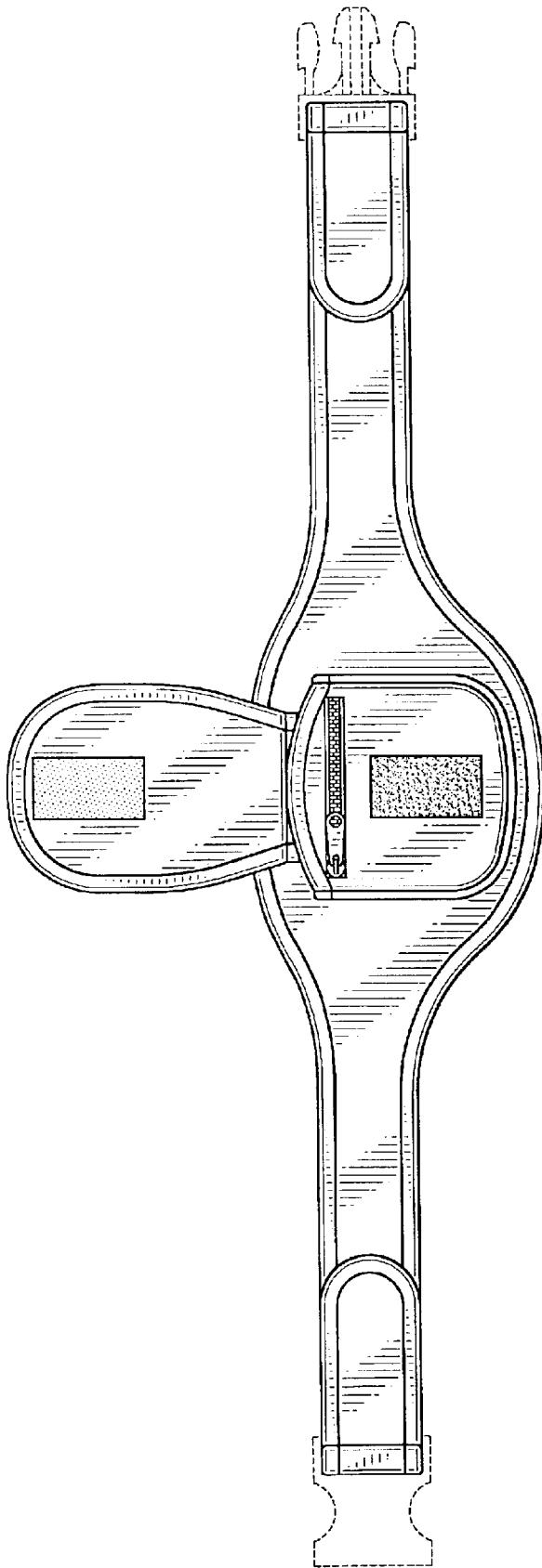
