**DESCRIPTION**


FIG. 1 is a perspective view of a side ledge for aircraft  
showing our new design;


FIG. 2 is a front view of the side ledge for aircraft of FIG.

1; and,


FIG. 5 is a top view of the side ledge for aircraft of FIG. 1.









