FIG. 15 is a bottom plan view thereof; and,

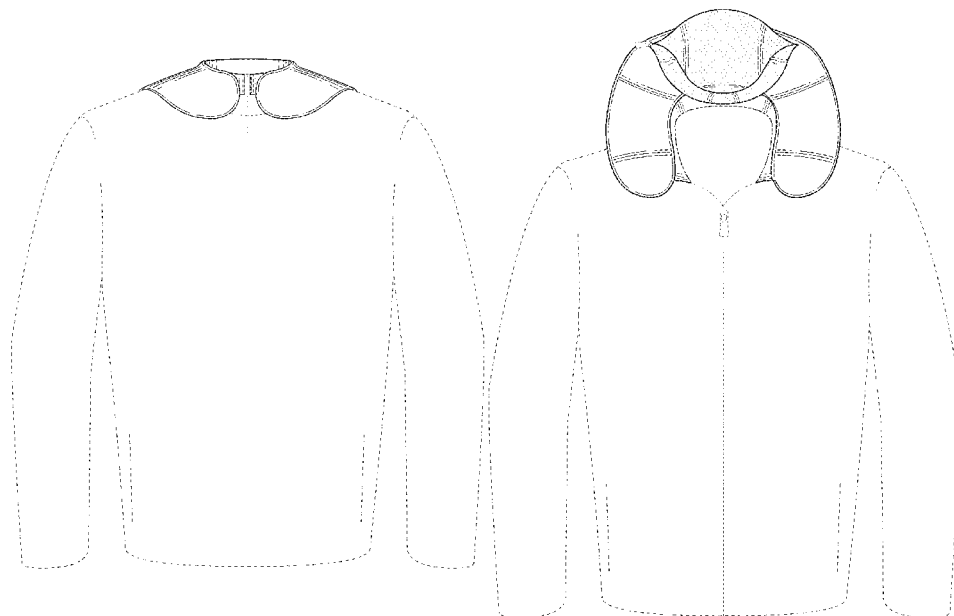
FIG. 16 is perspective view of a collar for a jacket convertible into a neck pillow with the collar in a partially unzipped configuration.

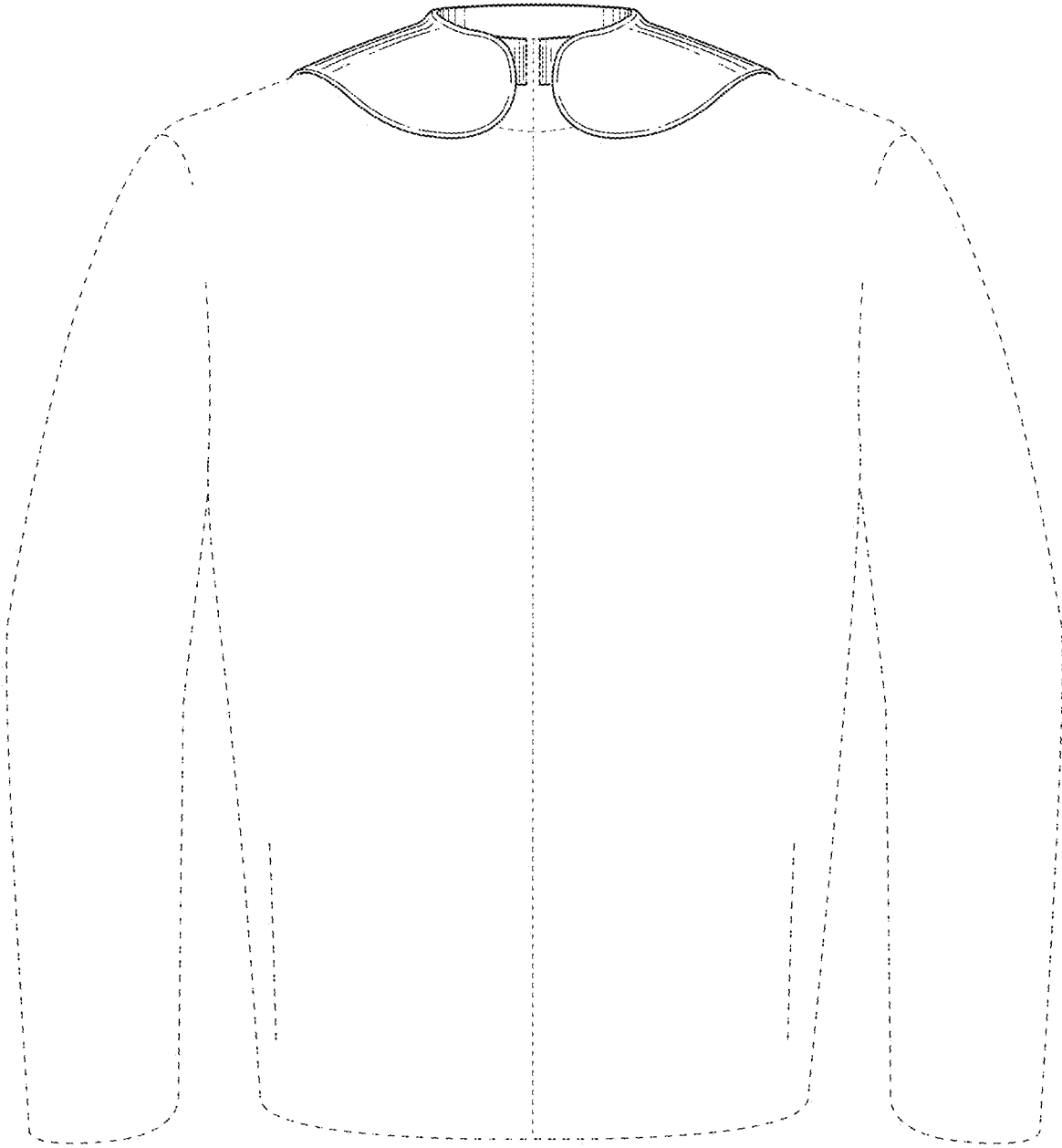

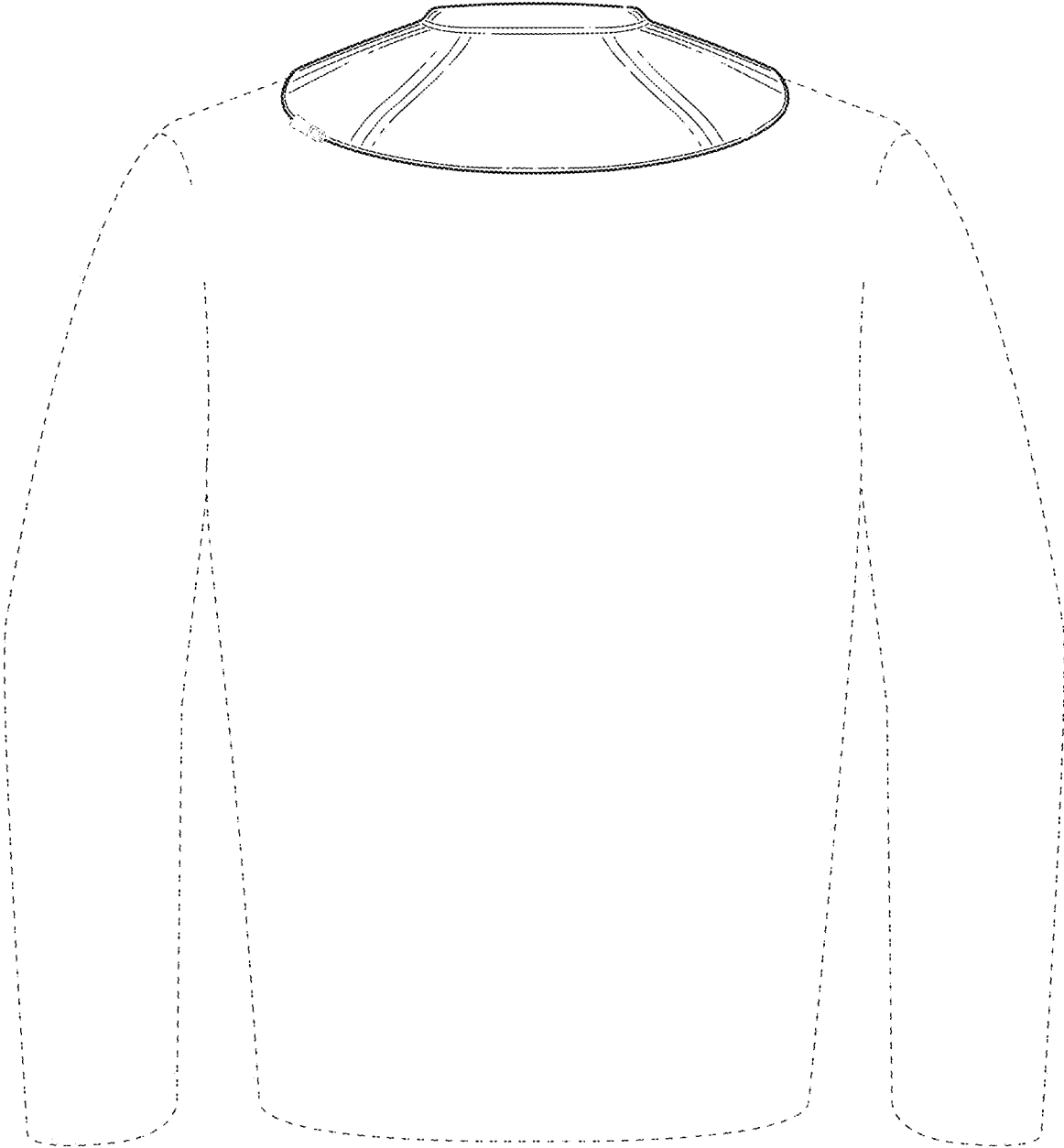

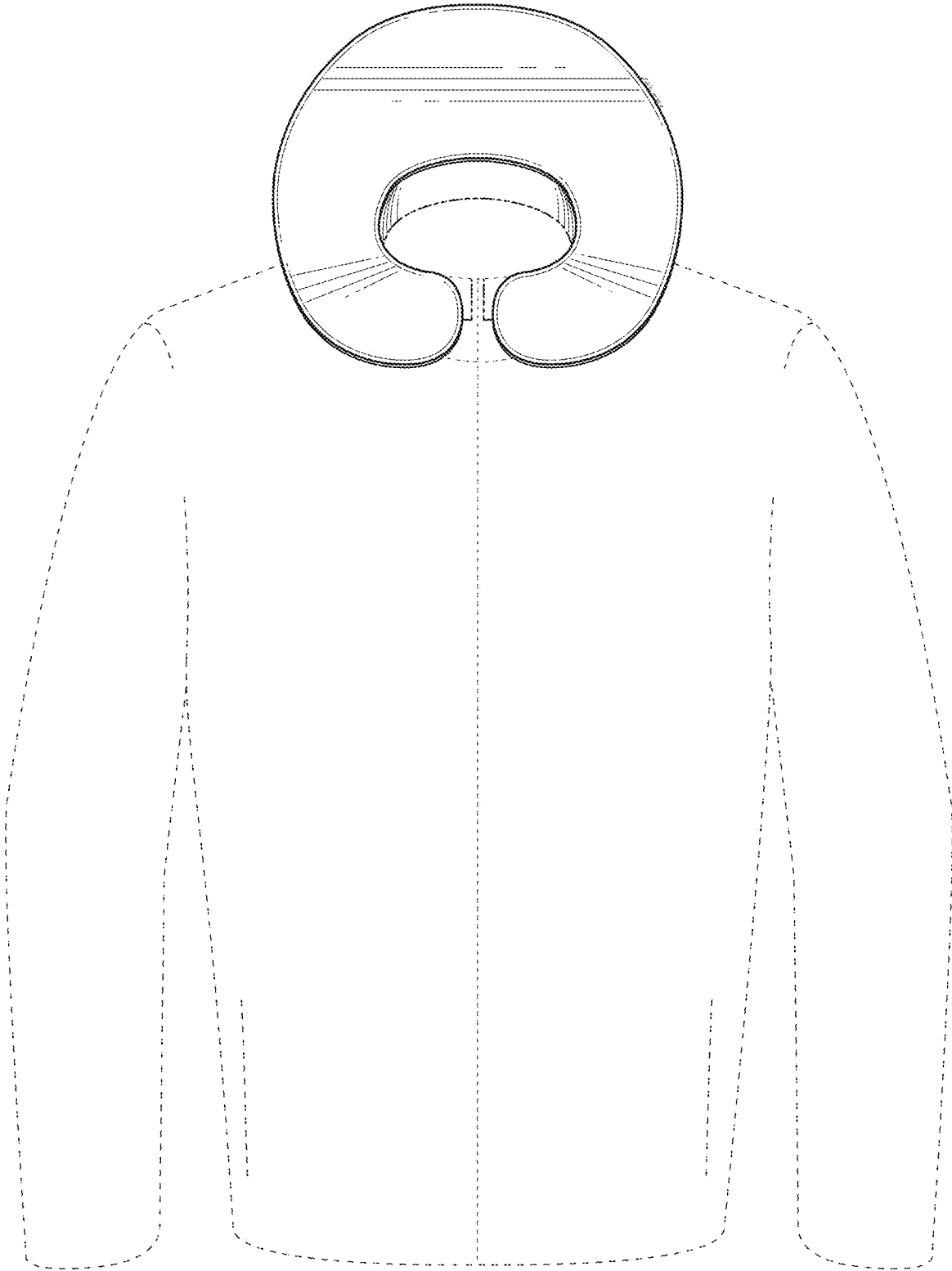

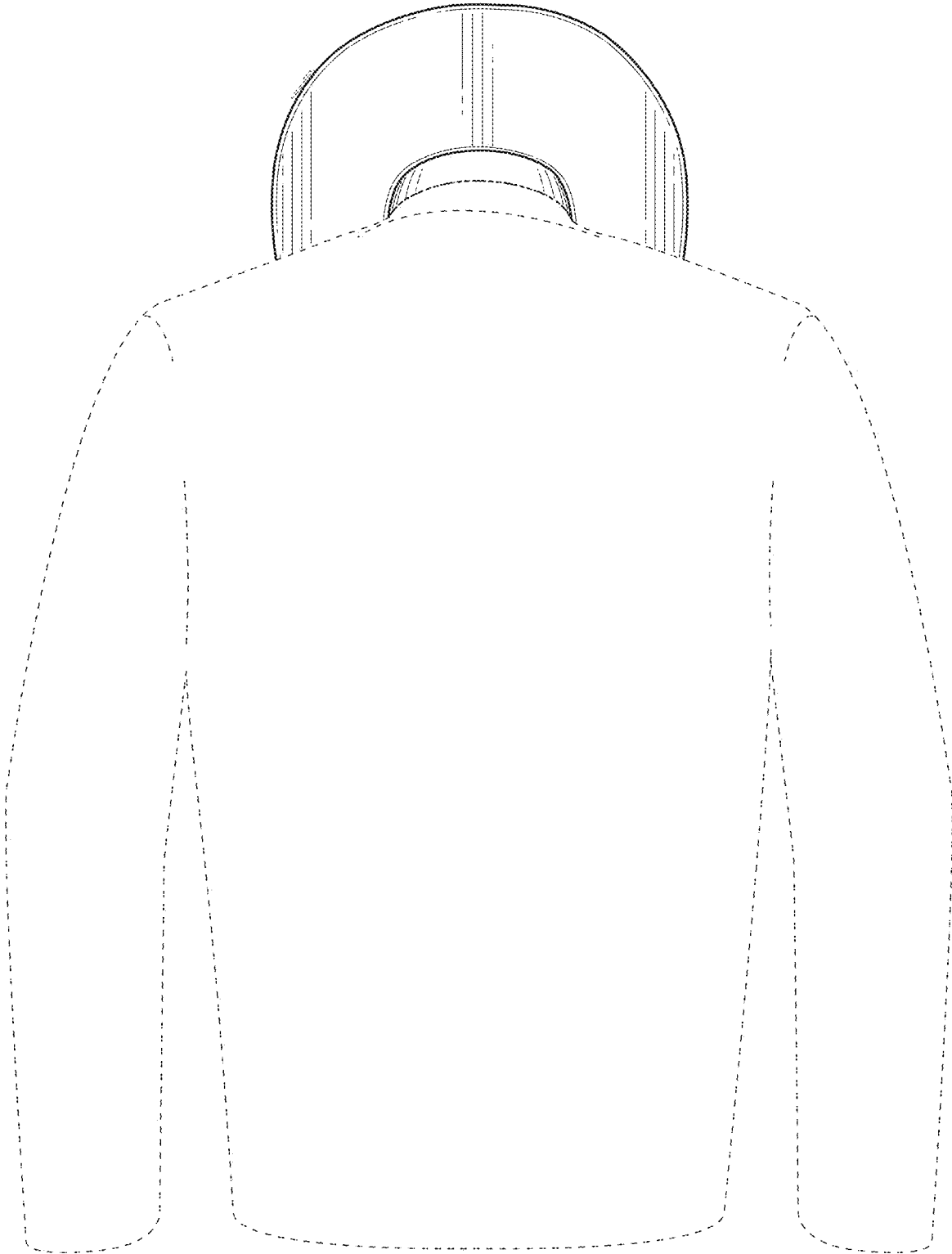

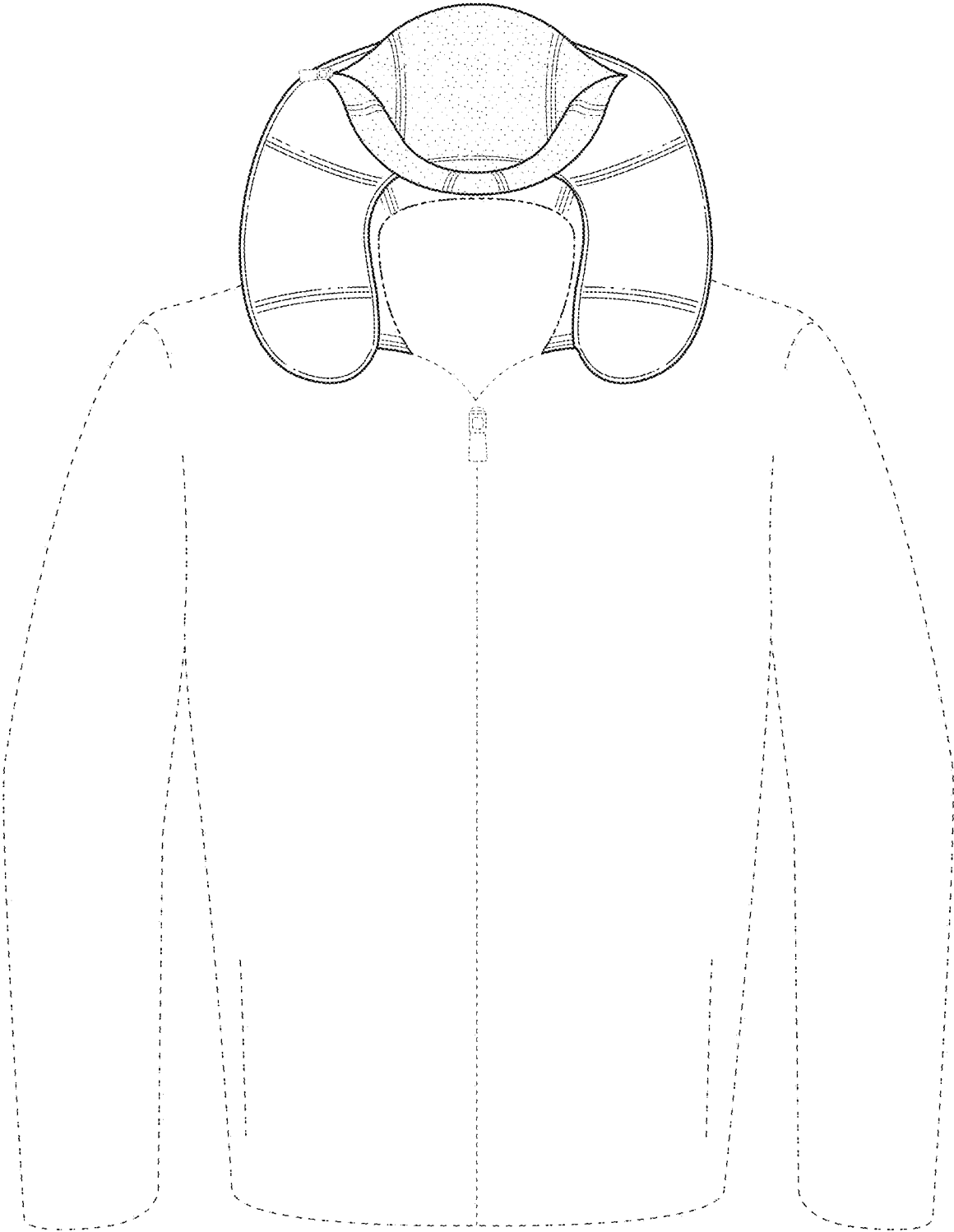

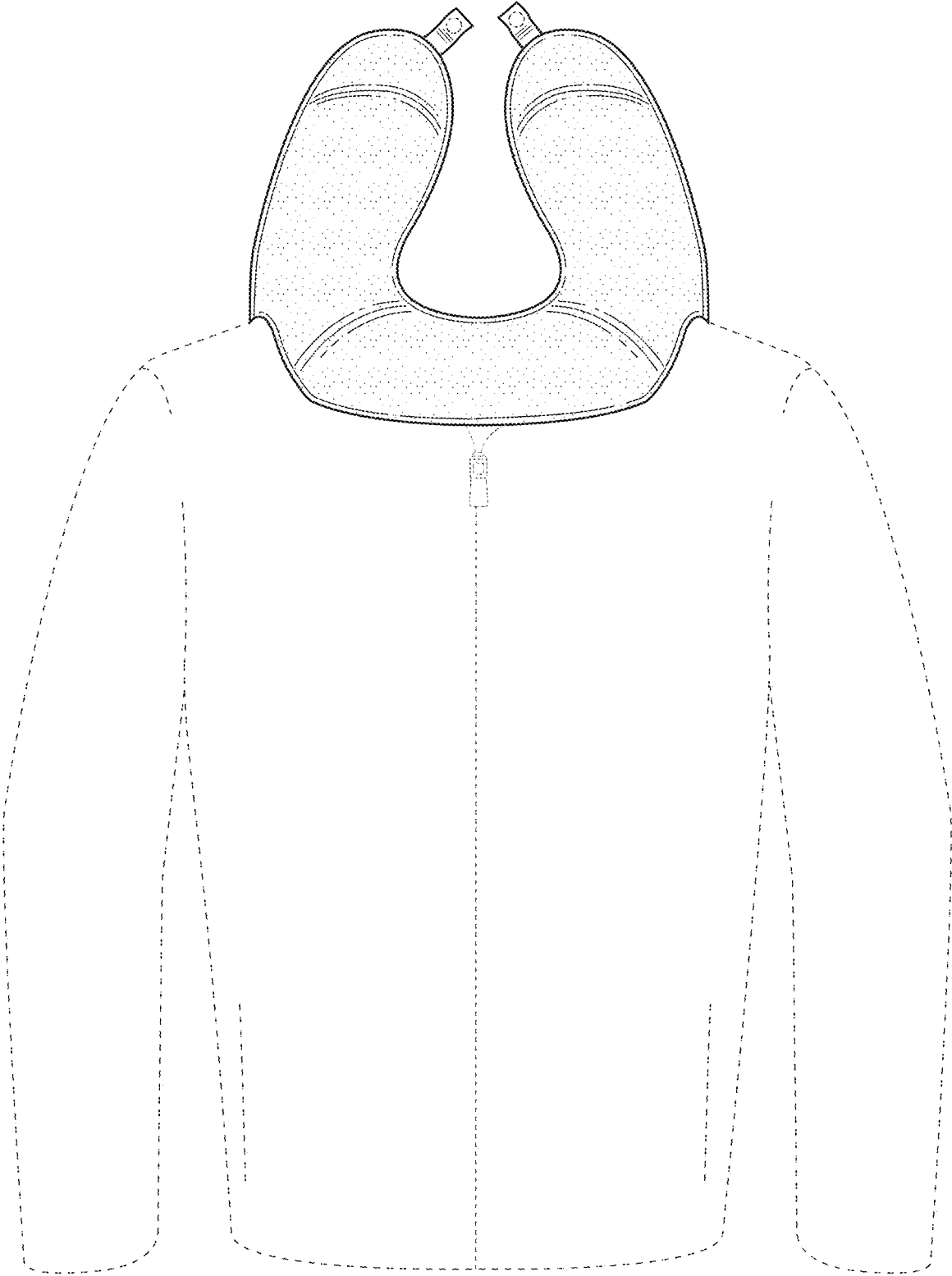

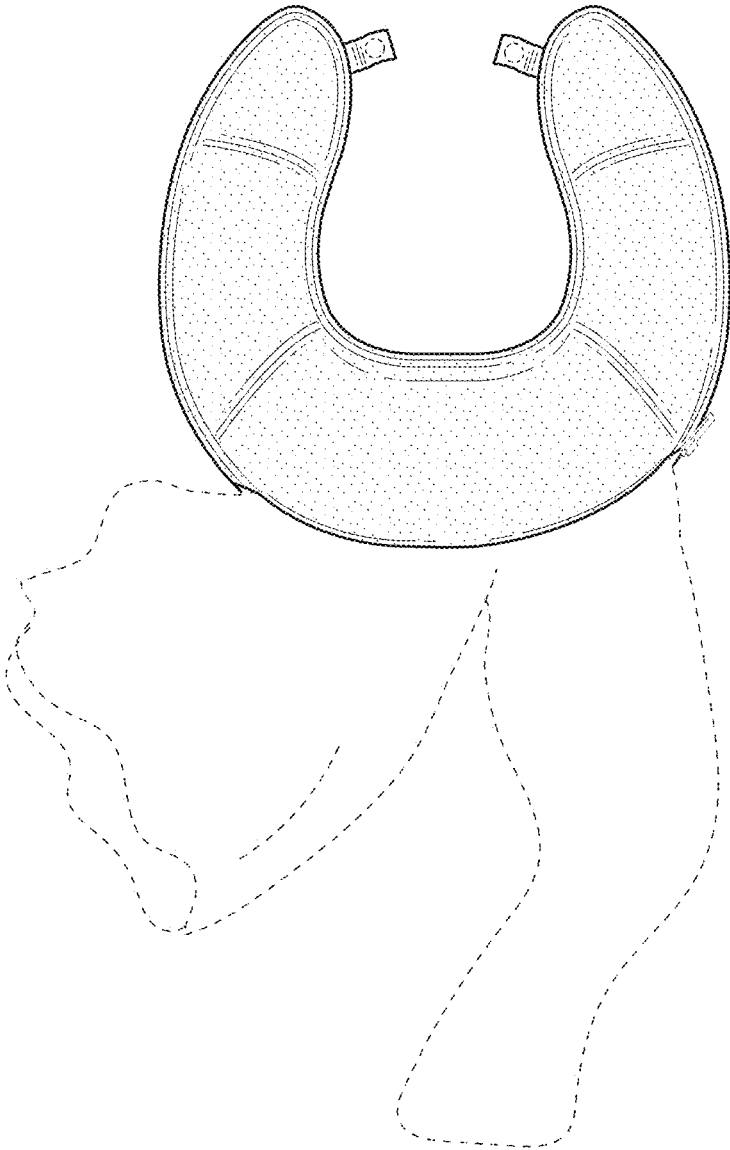

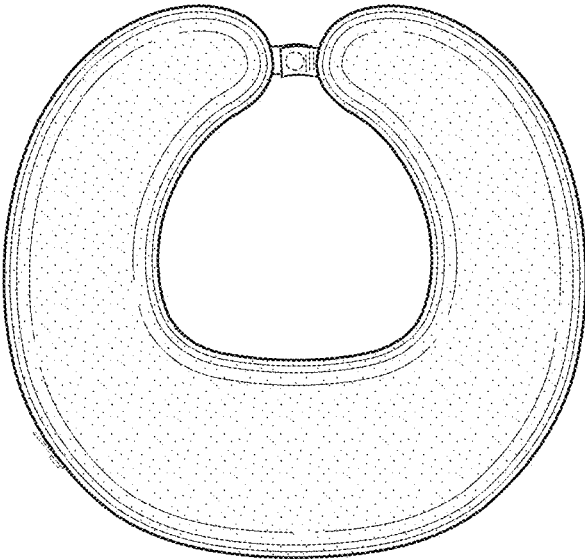

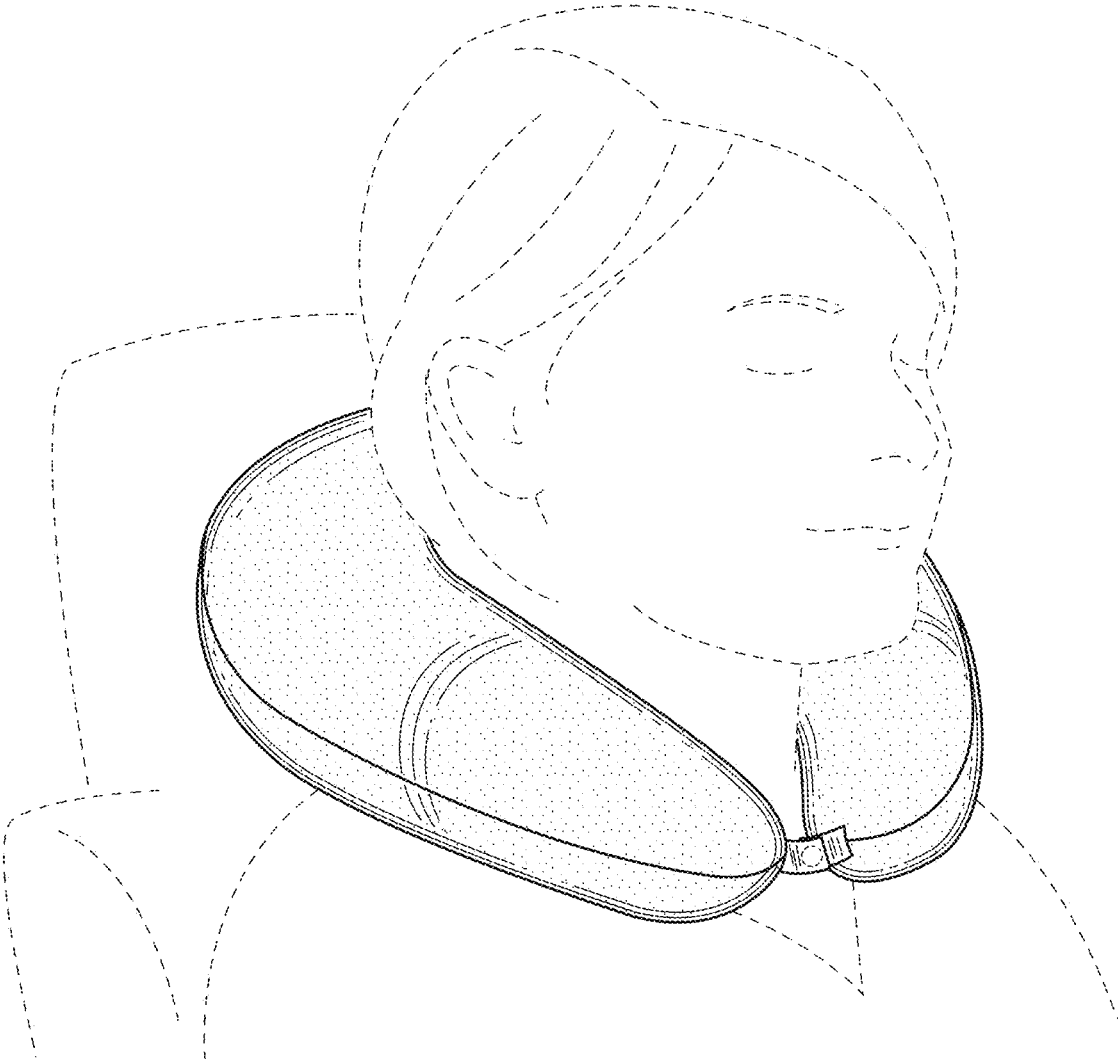

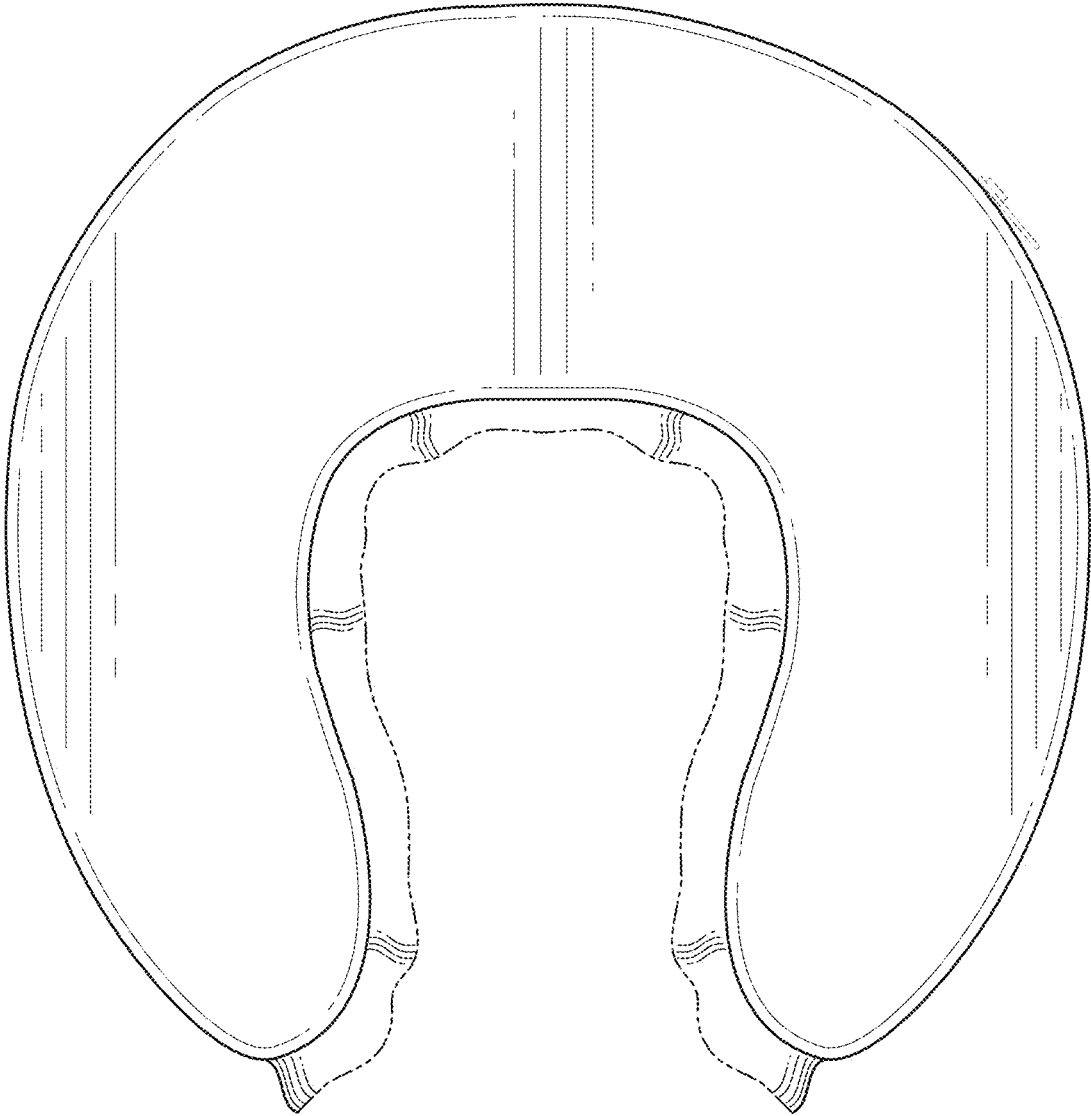

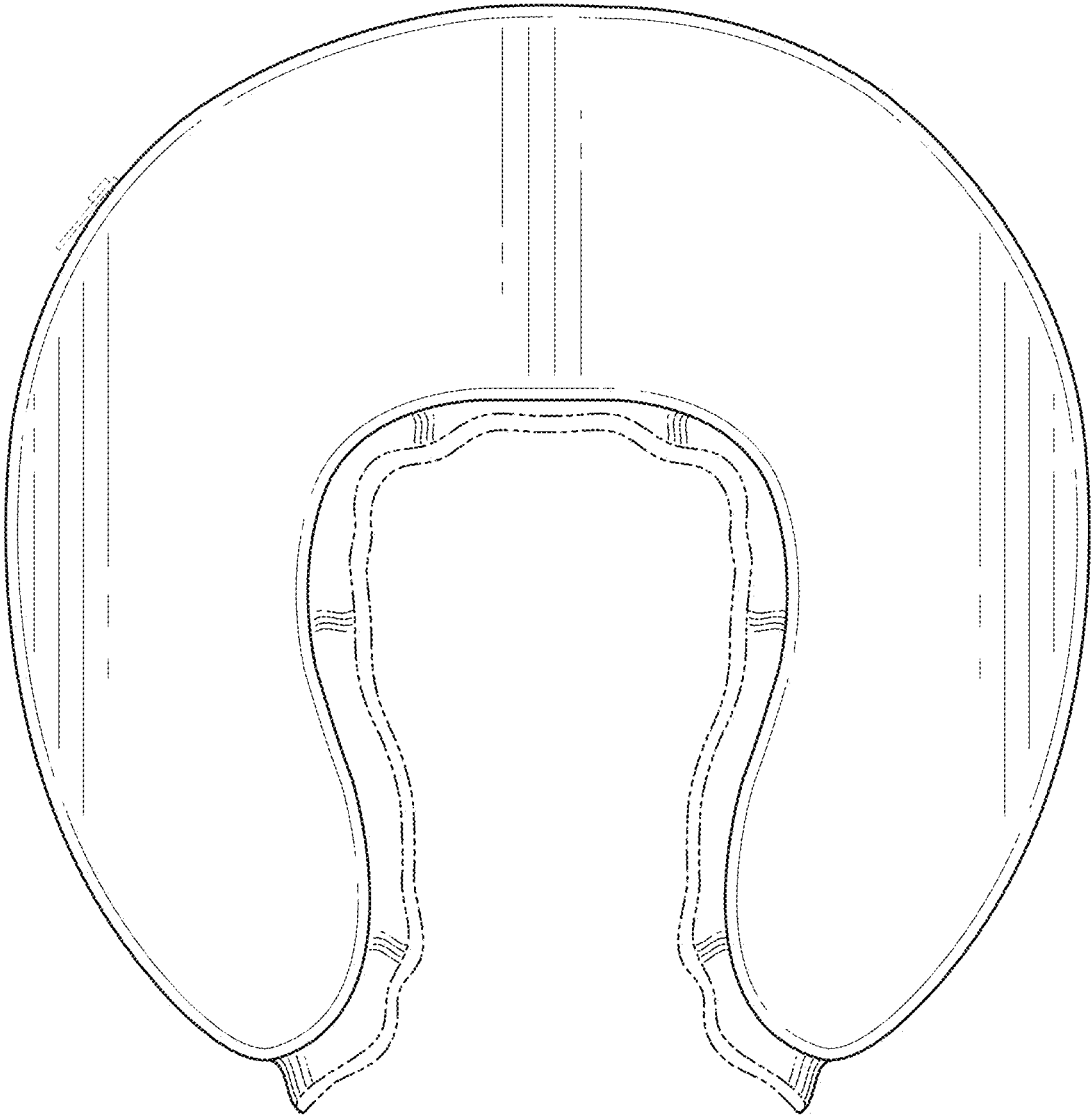

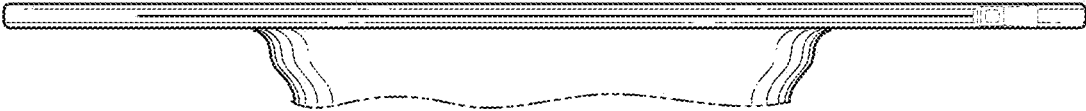

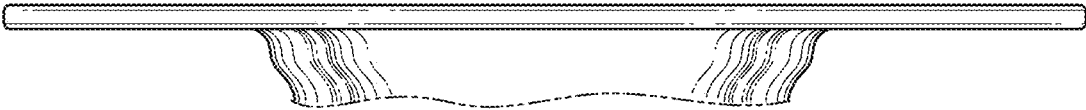

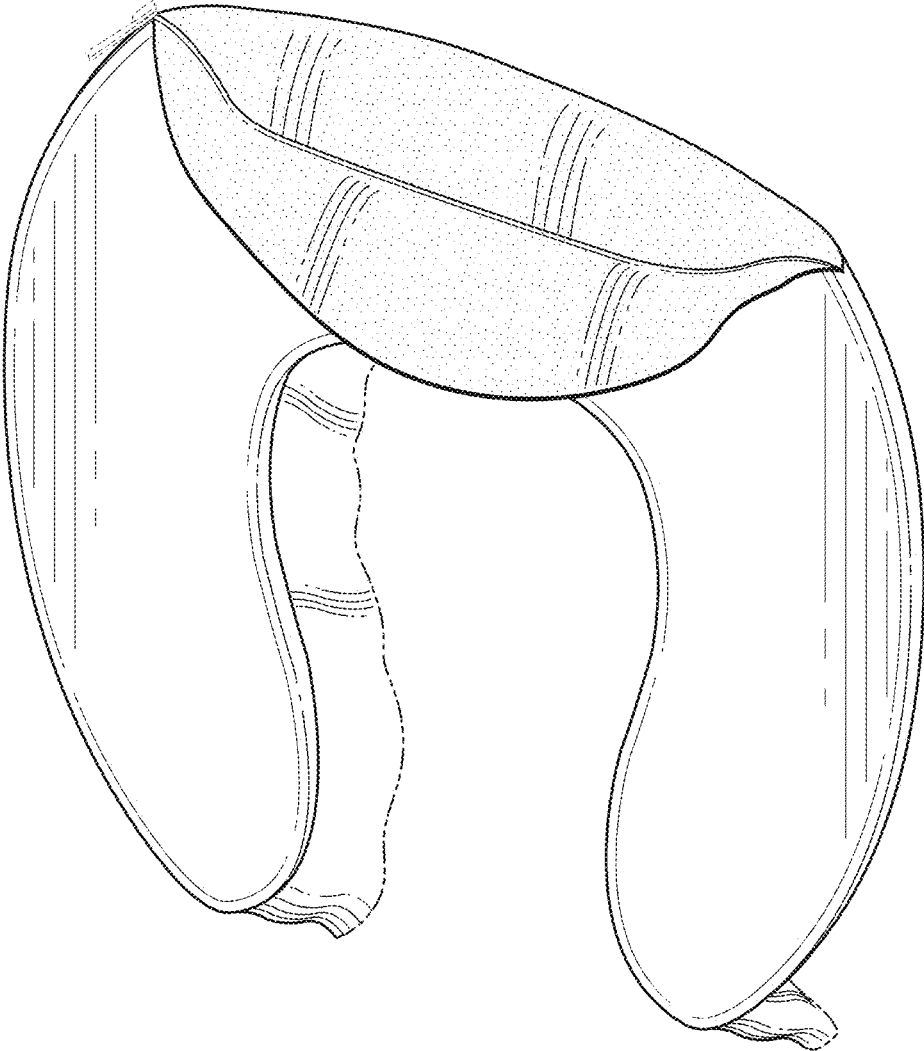
