

(57) **CLAIM**

The ornamental design for a packaging container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a packaging container, showing the new design;
 FIG. 2 is a front elevation view thereof;

 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a rear elevation view thereof;

 FIG. 9 is a top, front and right side perspective view of a packaging container, showing the new design as assembled;



























