(57) **CLAIM**

We claim the ornamental design for an inflatable tent frame, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an inflatable tent frame showing our new design;

FIG. 2 is a front elevational view thereof, the rear elevational view being identical to the front elevational view;


FIG. 3 is a right side elevational view thereof, the left side elevational view being identical to the right side elevational view;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a bottom plan view thereof.

The stippled shading shown in the drawings represents the three-dimensional contours of the design and is not intended to indicate surface decoration.










