
(57) **CLAIM**  
I claim the design for a hot bolting clamp, as shown and described.


**DESCRIPTION**

FIG. 1 is a top perspective view of a hot bolting clamp of my design;  
FIG. 2 is a bottom perspective view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a front elevational view thereof;  
FIG. 6 is a back elevational view thereof;  
FIG. 7 is a top view thereof; and,  
FIG. 8 is a bottom view thereof.  
The phantom lines show fasteners and spacers joining and separating members of the hot bolting clamp of the design but are not claimed as part of the design.

















