
(57) **CLAIM**

The ornamental design for a shade guide capsule, as shown and described.

DESCRIPTION

- FIG. 1 is a perspective view of a shade guide capsule showing our new design;
- FIG. 2 is a left side elevational view thereof;
- FIG. 3 is a right side elevational view thereof
- FIG. 4 is top plan view thereof;
- FIG. 5 is a bottom plan elevational view thereof;
- FIG. 6 is a front elevational view thereof; and,
- FIG. 7 is a rear elevational view thereof.














