FIG. 2 is a bottom perspective view thereof;

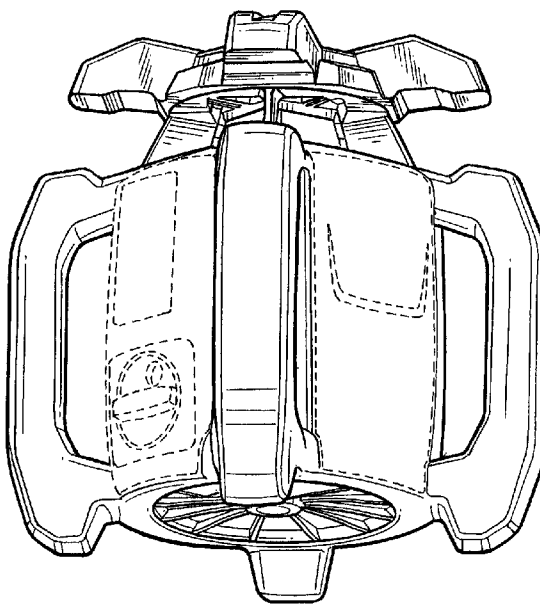
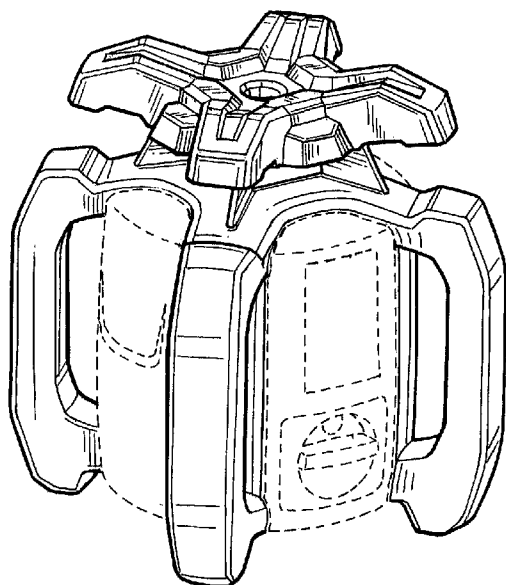
FIG. 3 is a side view thereof, the three additional side views being identical, excluding the unclaimed subject matter;

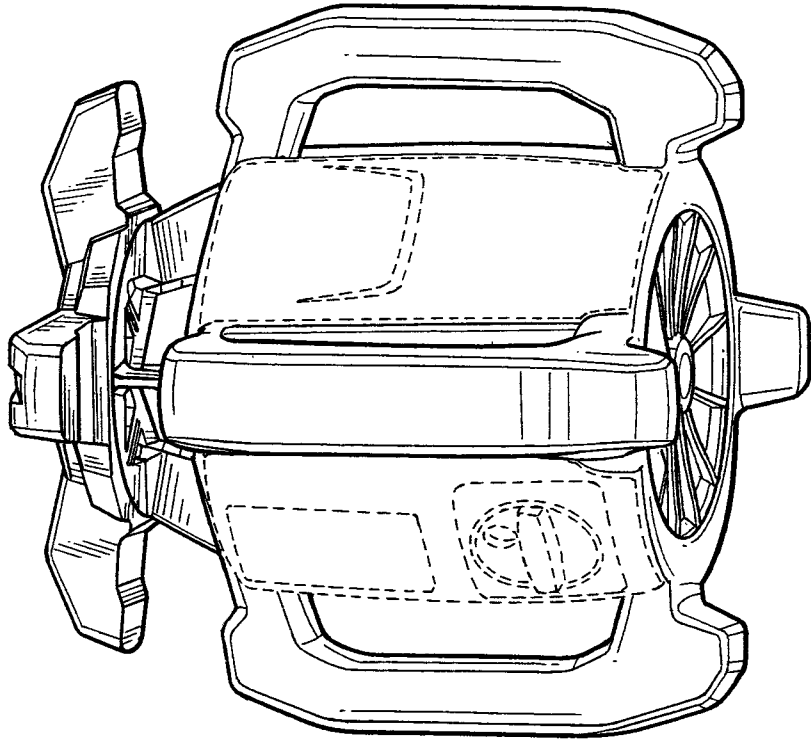

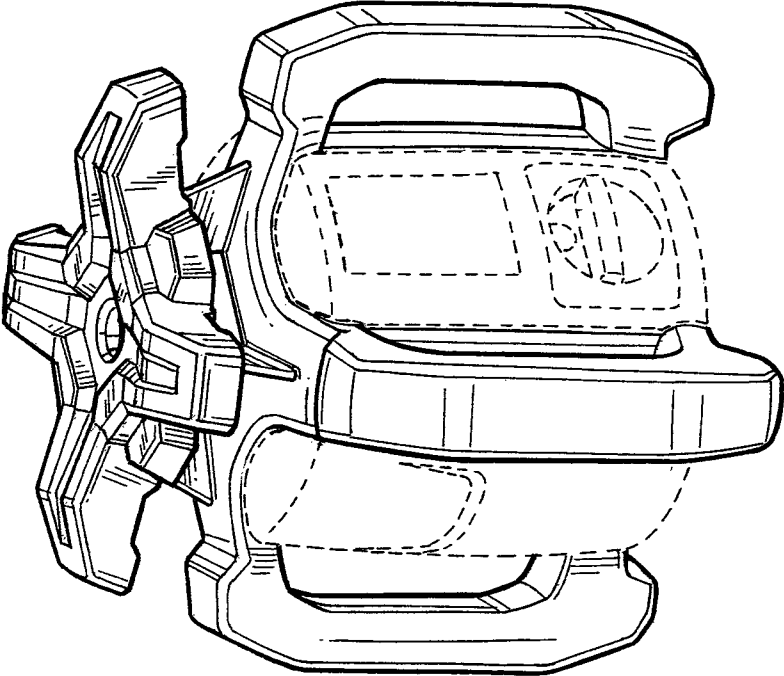

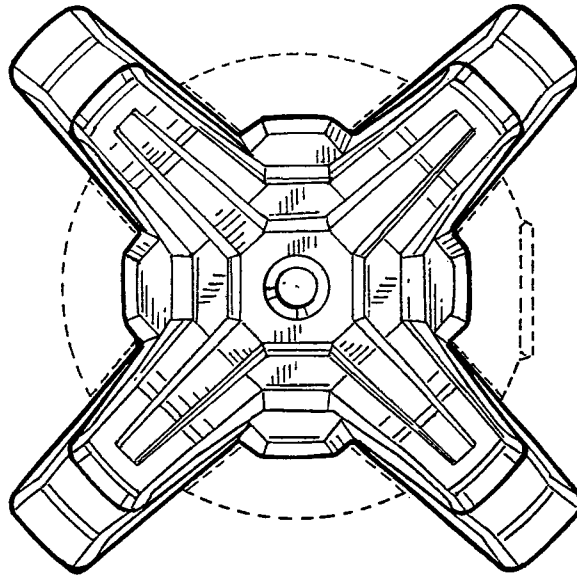

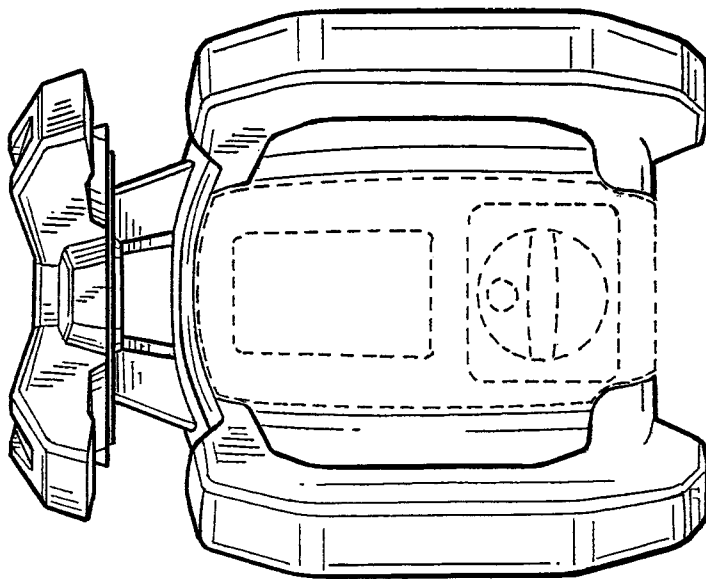

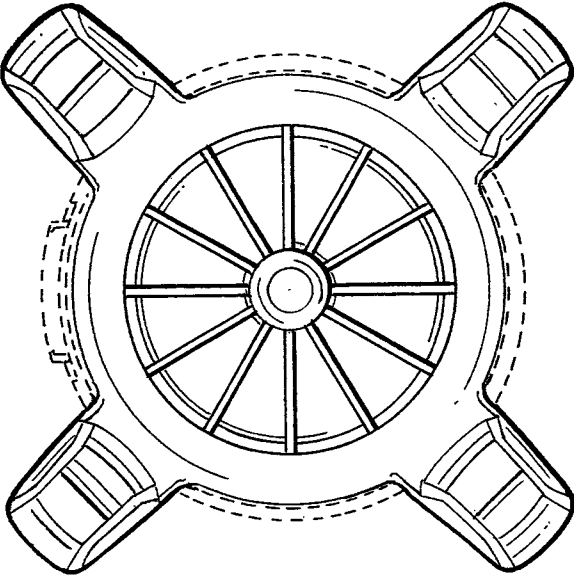
