DESCRIPTION

FIG. 1 is a perspective front view of the convection control sleeve having a teardrop cross-section with an octagonal base portion, taken from a top-left angle in accordance with my invention;

FIG. 2 is a left side view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a back view thereof;

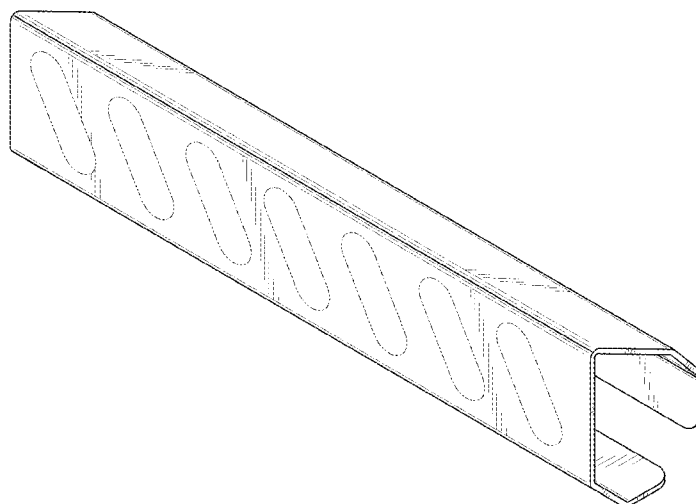
FIG. 6 is a top view thereof; and,

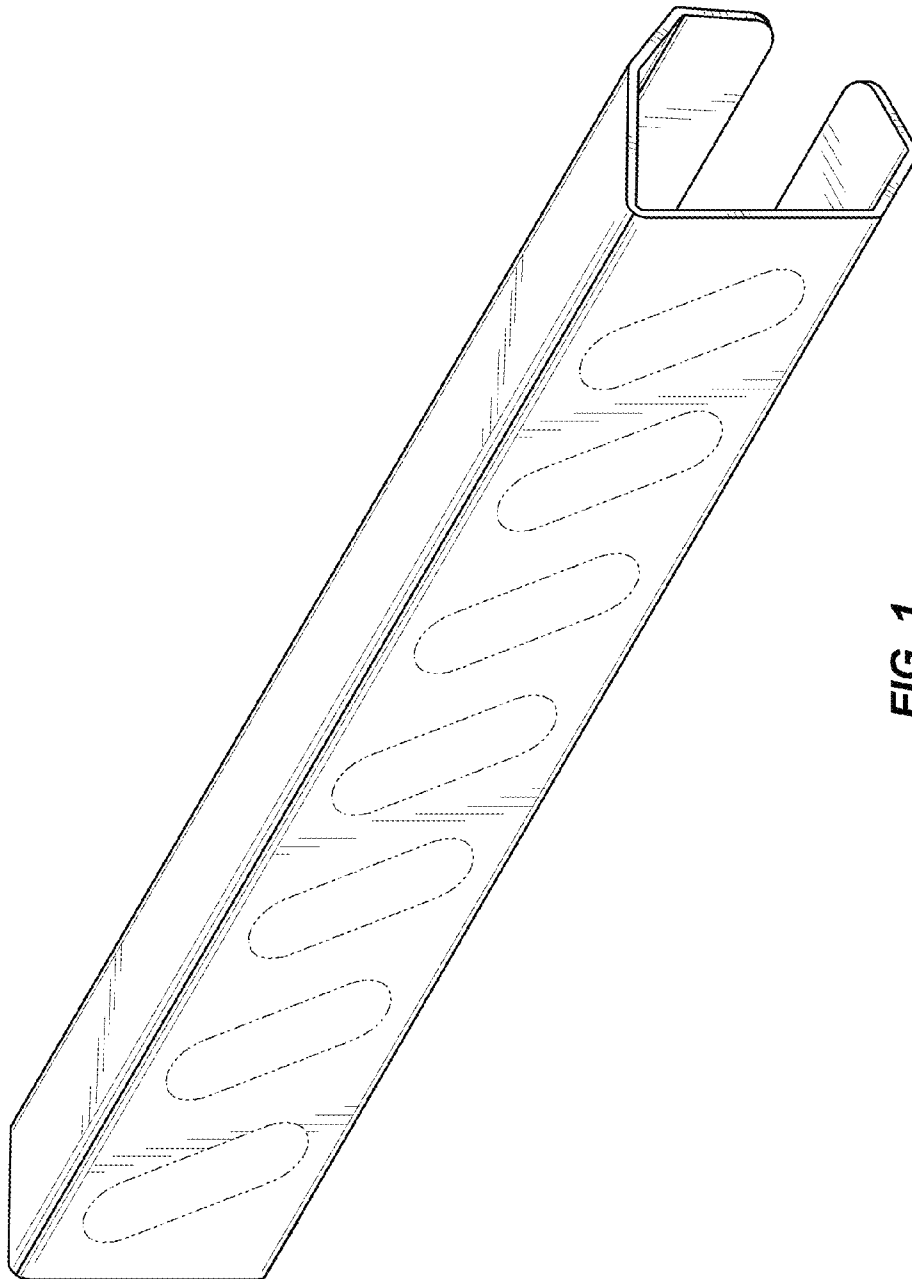

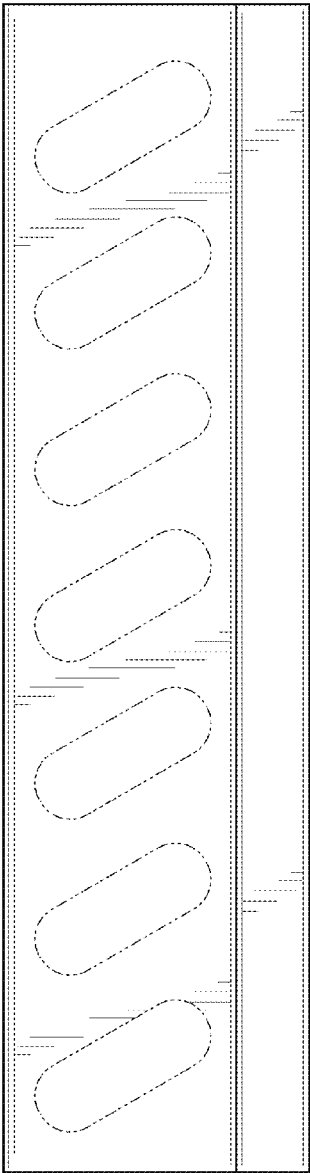

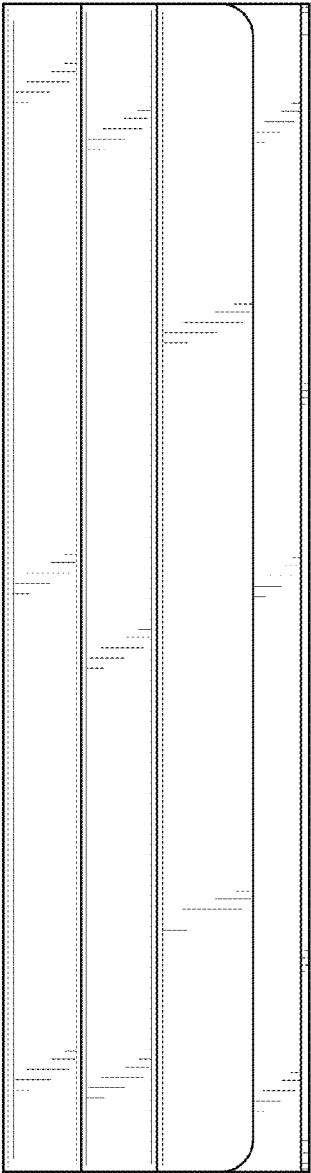

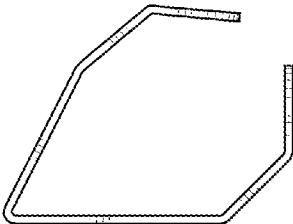

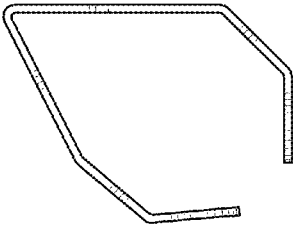

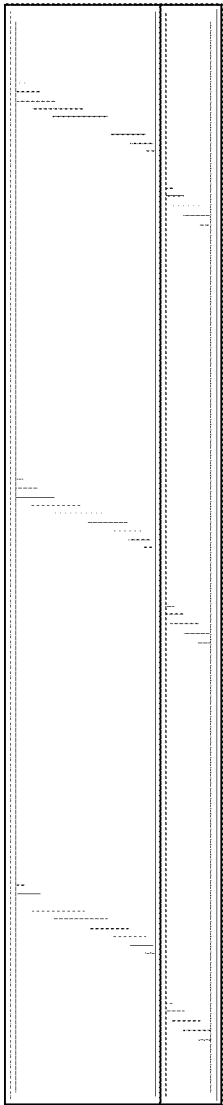

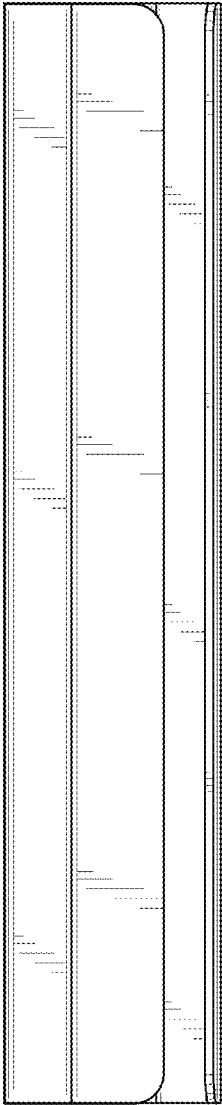
