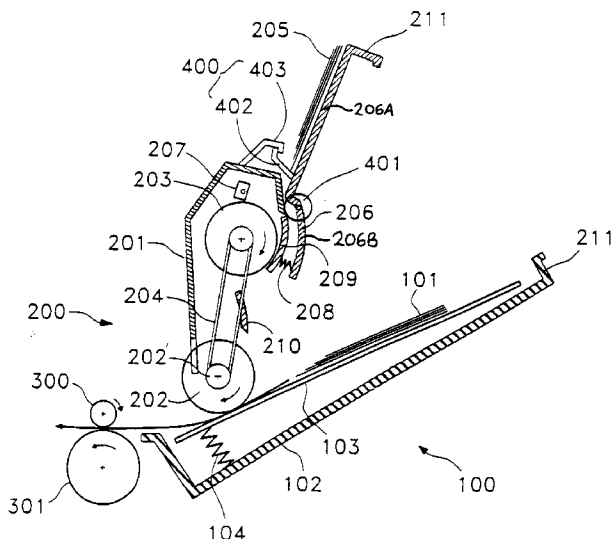

(54) **Automatic paper feeding device in a multifunctional machine**

(57) Disclosed is an automatic paper feeding device in a multifunctional machine including a recordable medium cassette (100), a document cassette (206) and a paper feeding unit (200). The document cassette is separated rotatably from the feeding unit. When performing a first function in the multifunctional machine, an auto-

matic document feeding (ADF) rubber (209) of the document cassette is separated from an automatic document feeding (ADF) roller (203) of the paper feeding unit. When performing a second function in the multifunctional machine, the ADF rubber of the document cassette is contacted to the ADF roller of the paper feeding unit.
