The ornamental design for a portion of an appliance, as shown and described.

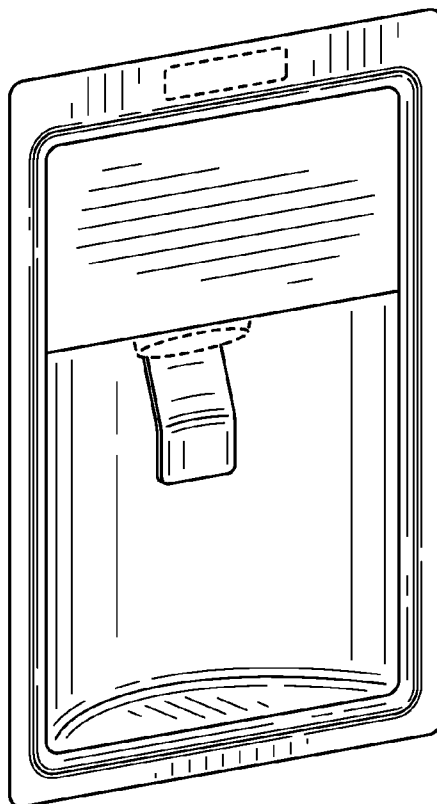
DESCRIPTION

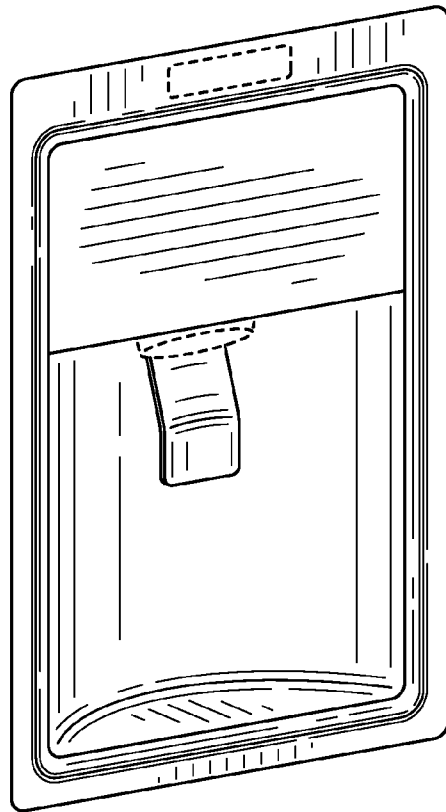

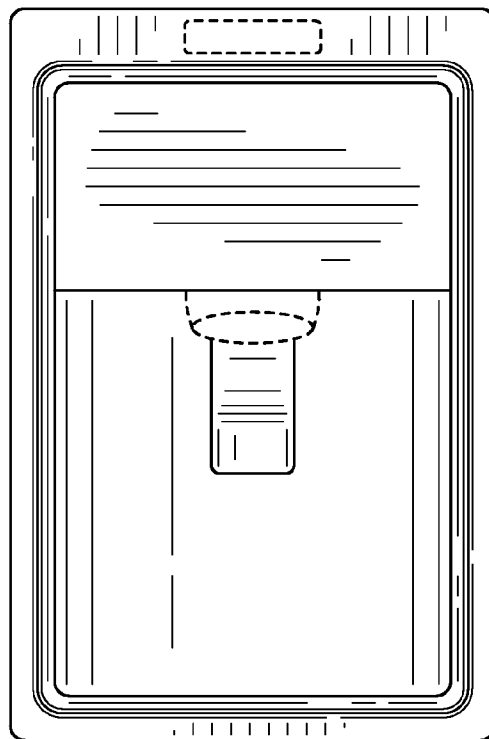
