(57) **CLAIM**

We claim the ornamental design for a faucet handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of the claimed design;

FIG. 2 is a side view of the embodiment of the claimed design shown in FIG. 1;

FIG. 3 is another side view of the embodiment of the claimed design shown in FIG. 1;

FIG. 4 is a front view of the embodiment of the claimed design shown in FIG. 1;


FIG. 5 is a rear view of the embodiment of the claimed design shown in FIG. 1;

FIG. 6 is a top view of the embodiment of the claimed design shown in FIG. 1; and,














