



The ornamental design for a plant reservoir, as shown and described.



DESCRIPTION

FIG. 1 is a right, side elevational view of the plant reservoir showing my design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a front: elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a front perspective view thereof; and,
FIG. 8 is a right side elevational view with the cork removed.
The broken lines shown in the Figures, depict portions of the plant reservoir that form no part of the claimed design.








