(57) **CLAIM**

The ornamental design for an equipment support pad, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an equipment support pad in accordance with the present invention.

FIG. 2 is a bottom perspective view of the equipment support pad in accordance with the present invention.

FIG. 3 is a top plan view of the equipment support pad in accordance with the present invention.

FIG. 4 is a bottom plan view of the equipment support pad in accordance with the present invention.

FIG. 5 is a front elevation view of the equipment support pad in accordance with the present invention.


FIG. 6 is a rear elevation view of the equipment support pad in accordance with the present invention.















