DESCRIPTION

FIG. 1 is a perspective view of a bib showing my new design in use;

FIG. 2 is a further perspective view thereof;

FIG. 3 is a front elevational view thereof; the opposite side being a mirror image thereof;



FIG. 4 is a right side elevational view thereof; the opposite side being a mirror image thereof;










