(57) **CLAIM**

The ornamental design for a baseball bat-shaped finial for a curtain rod and holdback, as shown and described.

**DESCRIPTION**

FIG. 1 comprises a perspective view of the baseball bat-shaped finial embodying our design;

FIG. 2 is a rear view thereof;

FIG. 3 is a front view of the baseball bat-shaped finial depicted in FIG. 1;


FIG. 4 is a top view of the baseball bat-shaped finial depicted in FIG. 1, the bottom view being a mirror image thereof;

FIG. 5 is a right side view of the baseball bat-shaped finial depicted in FIG. 1; and,

FIG. 6 is a left side view of the baseball bat-shaped finial depicted in FIG. 1.

The broken line showing of the hardware on the finial is included for the purpose of illustrating environment and forms no part of the claimed design.












