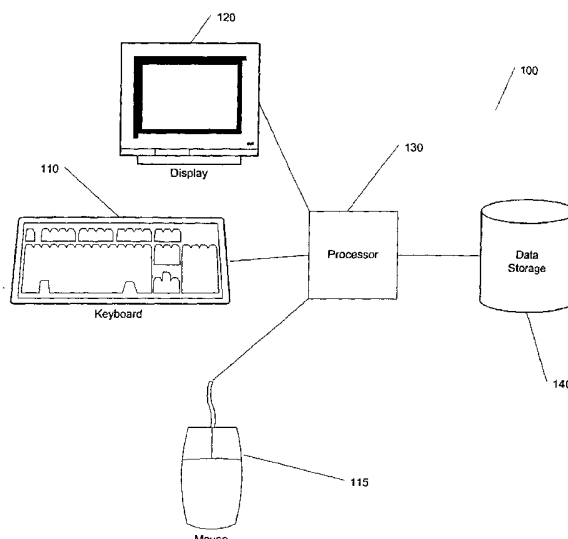

(57) Abstract: A medical information system (100) for treating of a patient by a clinician is provided. The medical information system (100) may include a processor (130). The medical information system (100) may include an input device (110, 115) readable by the processor. The medical information system (100) may include a demographic information interface configured to allow the input of patient demographic information for the patient from the input device (110, 115). The medical information system (100) may include a medical history interface configured to allow the input of medical history information for the patient from the input device (110, 115). The medical information system (100) may include an examination interface configured to allow the input of examination information for the patient from the input device (110, 115). The medical information system (100) may include diagnosis interface configured to allow the clinician to select a diagnosis using the input device (110, 115).
