
(57) **CLAIM**

I claim the ornamental design for the utility vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a left front perspective view of a utility vehicle of the present invention;  
FIG. 2 is a right rear perspective view of the utility vehicle of FIG. 1;  
FIG. 3 is a left side view of the utility vehicle of FIG. 1;  
FIG. 4 is a right side view of the utility vehicle of FIG. 1;  
FIG. 5 is a top view of the utility vehicle of FIG. 1;  
FIG. 6 is a front view of the utility vehicle of FIG. 1; and  
FIG. 7 is a rear view of the utility vehicle of FIG. 1.














