(57) **CLAIM**

What is claimed is the ornamental design for a cover for a boiler cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of the cover for a boiler cabinet. The broken lines in the center of the cover are shown to define a boundary around a control panel portion of the article which is not part of the claimed design. The area within the broken line boundary is not part of the claimed design. The broken lines below the cover are shown for environmental purposes only and form no part of the claimed design.

FIG. 2 is a front elevation view of the cover for a boiler cabinet of FIG. 1. The broken lines in the center of the cover are shown to define a boundary around a control panel portion of the article which is not part of the claimed design. The area within the broken line boundary is not part of the claimed design. The broken lines below the cover are shown for environmental purposes only and form no part of the claimed design.














